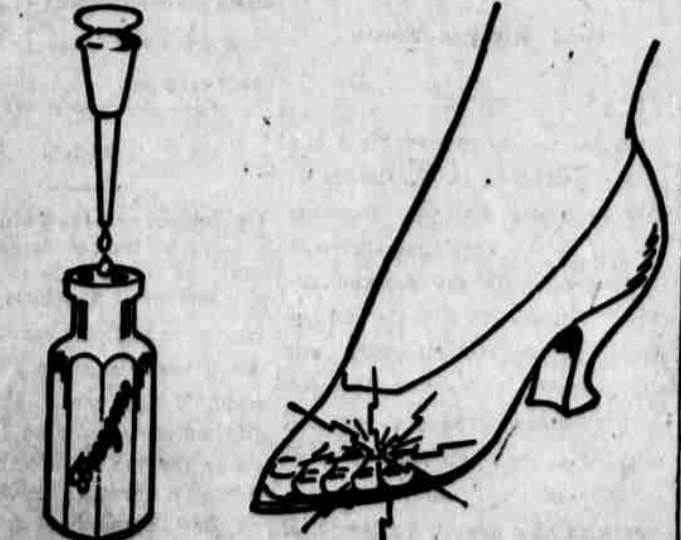
## First Survivors of U-Boats to Reach Shore
