INTEREST LEGISLATION.

Representative Merryman has again demonstrated his utter unfitness to represent Klamath County and Southeastern Oregon in the legislature. The first concrete evidence of this fact was brought to the attention of the people of this county when he practically refused to join with Senator Baldwin in support of the constitutional amendment permitting the raising of funds for the construction of permanent roads.

He was sent there to protect all of the interests of the section of this state that he is supposed to represent. Every man who cast his ballot for his election did so feeling a confidence in him that justified his act and believing that when he went to Salem he would not permit himself to become the representative of a few to the injury of the many.

On February 11, Dr. Merryman introduced a bill that provides that "it is not lawful... to herd sheep... on the land or possessory claims of other persons... or to permit them to graze within one mile of the dwelling house of the owner or owners of such possessory claims located within the County of Klamath, State of Oregon."

If that bill should become a law it would destroy the sheep industry of Klamath county. Under its provisions sheep could not be grazed near the "possessory claims" of anyone, no matter whether that person lived thereon or not. "Possessory claims" is the joker in this bill and is put there with the deliberate intent and purpose of forcing the sheepman to move.

tion of all these interests, in spite of the resolution of protest of the city council of Klamath Falls, for these people recognized the danger of such a measure and the financial loss it would be to Klamath Falls and Klamath County.

Representative Merryman knew in advance that the presence of the sheepman here meant the eventual erection of a scouring plant, warehouse and woolen mill in the city and the making of Klamath Falls one of the sheep and wool centers of the west. Yet he has singled out his home county and his home city as the object of his shaft of destruction.

The Herald is not posing as the representative of the sheepmen. They are only an incident in the scheme of development that is in store for Klamath Falls. It would take the same stand if a measure of similar import were aimed at the cattle men, the timber men, or any other one industry of this county. It is opposed to this bill for it knows what it means to the financial and material welfare of Klamath county and Klamath Falls, and it appeals even at this late day, to Dr. Merryman to cast aside the pettiness or influence that has induced him to take this step and stand before his constituents the man they believed him to be.

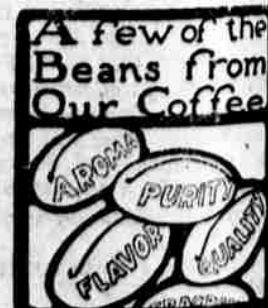
