

UNION OPERATORS IN PORTLAND STRIKE

PORTLAND, June 30.—The Union operators employed by the Pacific Telephone and Telegraph company struck today in sympathy with those on strike in California. It was said the entire 800 operators employed by the company here would join in the strike. Four hundred were out by 5 a. m. A few of the electricians joined the strike and their union officers said they would decide on what course to follow as a body at the meeting tonight.
