Mr. Brown, who is one of the ablest engineers on the coast, laid out the sys-

> tem, and started work on a tunnel from the Upper Lake, which if it had been completed by the Reclamation Service would have brought under irrigation several thousand acres that are today above the present main canal.

After the work had progressed to a considerable degree and the firm had expended upwards of \$200,000, the Reclamation Service appeared on the scene. The tocsin was sounded and the farmers were gathered from the four corners of the county and were told that if their good and grand old Uncle Samuel were permitted to come in here he would put the water on their land for not to exceed \$20 an acre, and they would have ten years in which to pay back the money without interest; that the maintenance charge would not exceed 25 cents an acre; that he would reclaim 250,000 acres of land and make the marsh land that surrounded the city bloom and blossom until it would support a great population, and-well they sold them the brick. Some of the enthusiasts were ready to hang Brown and Hawkins because they didn't take to the woods and let the Reclamation have all of their rights and interests for nothing. In the meantime Brown and Hawkins offered to build the system and sell it to the people for \$15 an acre, but they could not hear anything but the siren call of the government officials. Finally an agreement was reached whereby the Reclamation Service acquired their rights and they shook the dust of

Klamath county from off their fact. Since winding up their affairs. which was about ten years ago, they have confined their operations to California. Mr. Brown is accompanied by Mr. Hawkins, both having pitched their tent on the banks of Spring Creek, where they are going to try for the next few weeks to recover from the scorching heat that has been burning up the Sacramento Valley. Continuing his exclamation, Mr. Brown said: "I have kept more or less in touch with Klamath Falls during the years that have passed, but I had no idea that the development had been so pronounced. I am amazed at the mills and box factories that have been built here, indicative of the solid foundation upon which the city rests. You see no evidence of the boom, which is another sign that sanity and good business sense is governing development. "I am glad to get back, if even for only a few days. I always like Klamath and its people and I hope to make this the beginning of an annual visit to what I believe to be one of the best sections on the Pacific Coast."




