OREGON BREVITIES

HOOD RIVER, Dec. 24.—F. R. Abstein, pioneer rancher, whose place is on the Columbia river highway near Mitchell's Point tunnel, has been here after bobcat traps. The varmints, driven to famine point by the cold weather, are raiding ranches.

BEND, Dec. 24.—After four years as assistant minister at St. Francis Catholic church in Bend, Rev. Fath-

er Adrian Sharkey will leave Monday for Roseburg, in which city he will head the Catholic church. Rev. Urban O. Riordan of the Franciscan Capuchin order arrived in the city today from Cork, Ireland, to succeed Father Sharkey.

SALEM, Dec. 24.—Plumbers who have been on the jump here for several days repairing broken water pipes and other damage resulting from the recent storm, estimate that the loss to the people of the city will total more than \$10,000.

ONTARIO, Dec. 24.—Snake river is jammed with ice floes and is threatening wagon and railroad bridges between Ontario and Huntington. The Oregon Short Line is sending dynamite to blow the ice jams and the Malheur county court is preparing to protect the bridge east of Ontario.

MOSIER, Dec. 24.—Stanley Miller and Webb Brother of Mosier succeeded Friday in killing a large cougar, several miles south of town on Little Mosier creek.

SALEM, Dec. 24.—The bill prepared by Representative James Stewart of Wheeler county providing for an amendment to the constitution authorizing an increase in the road reconstruction indebtedness limitation from 2 to 4 per cent will go before the legislature at the special session in January, according to Mr. Stewart in Salem.

BEND, Dec. 24.—Fire which is believed to have started on the first floor, destroyed the Leader building

at Silver Lake early Saturday morning, occasioning a loss of \$4000 for the building and several thousand more for personal property and printing plant equipment. It is said that included in the loss are all the records of the Silver Lake Irrigation district, as well as personal business records.

PORTLAND, Dec. 24.—Because of the requirements of the Oregon State gasoline law which provides that gasoline sold in this State must be of 56 degrees specific gravity gauge, the Standard Oil Company today announced an increase in price of 1 1/2 cents per gallon. This increase is effective in all Western Oregon and as far east as The Dalles, these points being supplied with gasoline from California.

Eastern Oregon, which is supplied from Wyoming points, is not immediately affected, but company officials say probably will be very soon.

SALEM, Dec. 24.—Three liquor stills which the federal officers believe were used by amateur brewers of the vicinity have been seized at the plumbing establishment operated by Fraser & Platt here.

OREGON CITY, Dec. 24.—An auxiliary to the American Legion of this city is to be organized in the near future.

PORTLAND, Dec. 24.—Definite decision to carry forward plans for financing a corporation that will provide tourist hotel accommodations for the travel that is certain to come to Oregon in 1920, was taken at a meeting of the Chamber of Commerce committee that has been investigating the matter.

SALEM, Dec. 24.—Acting upon a legal opinion given by Attorney-General Brown, coupled with his own observations and examinations, Dr. L. F. Griffith, superintendent of the state hospital for the insane here, has announced that next Monday he would release George E. Chenoweth of Curry county, who has been detained at the institution since his acquittal on a charge of murder last August.

SALT LAKE, Dec. 24.—The Mutual Creamery company, will build a large condensed milk, cheese and butter factory at Eugene, Or., early next Spring and will make efforts to secure the co-operation of farmers of Oregon for the daily delivery of 20,000 pounds of milk, according to the announcement today of officials of the headquarters office of the creamery company here.

SALEM, Dec. 24.—Residents on rural routes out of Salem were served with their mail by regular carrier Friday for the first time since the storm broke here a week ago last Tuesday. For 10 days no mail has been delivered in the rural sections except such as was called for by those who braved the snow and came to town, many taking the mail for their neighbors back with them.

PORTLAND, Dec. 24.—Several aliens have been deported from Oregon recently, according to announcement of R. P. Bonham, chief of the immigration service of the Oregon district. A number were deported through Ellis island, while others went direct from here to their native countries.

SALEM, Dec. 24.—John H. Lewis of Portland has filed application with the state engineer here covering the storage of 10,000 acre-feet of water from Willow creek in Malheur county, and the appropriation of 100 second-feet of water from Willow creek for irrigation purposes.

SALEM, Dec. 24.—The industrial association of Oregon has submitted to Governor Olcott the names of the five persons to represent the employers at the conference to be held in Portland December 22, to make recommendations to the special session of the legislature with regard to increasing payments to injured workmen under the provisions of the state compensation act.

SALEM, Dec. 24.—That many Bob White quail perished as a result of the recent cold weather and heavy snowfall, is indicated in a report received here from Roy Bremner, district game warden.

PENDLETON, Dec. 24.—The west end of the city, in the Tutilla district is flooded because of high water from the thaw.

The Umatilla is rising rapidly and bridge washouts are threatened. Wild Horse creek is the highest in history, and the town of Adams, near Pendleton, has four feet of water running in the streets. Telephone and electric light wires are in danger and trains are much delayed.

GRANTS PASS, Dec. 24.—Probably no one indication of the real estate activity in Josephine county is more outstanding than that the Josephine county Abstract company has had to quadruple its office force to care for the demand, for abstracts for intending purchasers.

BAKER, Dec. 24.—Braving deep snow and the cold, 32 teachers, many from remote parts of the county, have come to Baker to be examined for certificates. Two Grant county teachers are among the number. They were unable to reach Canyon City, so they travelled 40 miles by stage, from Galena to Austin, and arrived in Baker after being 60 hours on the road.

THE DALLES, Dec. 24.—The twentieth district convention of the Knights of Pythias lodge was held here Thursday.

EUGENE, Or., Dec. 24.—Announcement is made from the office of the Cascade national forest at Eugene that a new industry is about to be developed in the Northwest, that of tapping Douglas fir trees for turpentine.

LA GRANDE, Dec. 24.—Following announcement that William F. Finley, state biologist had been dismissed, the Wing, Fin and Fleetwood club of this city announced they would like to see the abolishment of the state biology department, to have the \$10,000 which is taken out of the sportsmen's licenses each year used towards propagating birds and fish for the state. They believe in the biology department, but want the state to support it.

SALEM, Dec. 24.—At a meeting of the Salem members of the board of trustees of Willamette university here Fred A. Legg, architect, was instructed to prepare plans for rebuilding the interior of Waller hall, which was partly destroyed by fire early Wednesday.
