est. Monthly wages with board were highest in the Western States, including the Mountain and Pacific States, where the average was \$62.96, while without board it was Farming operations of 1919 pro-

duced crops that had a value at the farm that was 11.8 per cent above 1918, and animal products 9.9 per cent above, but the gain in wages of farm labor was relatively greater. Wages by the month with board increased 44 per cent, without board 15.3 per cent, and day wages in

"These figures indicate," says the department of agriculture, "that the farm laborer is still regaining the ground he lost, relatively, early in the rapid upward movement of farm products after 1915. 


