

TERCENTENARY
OF PILGRIMS
OPENS TODAY

ROTTERDAM, Aug. 30.—The Holland Pilgrim Fathers tercentenary celebrations begin today and will continue to September 2, after which others will be held in Plymouth, London and Nottingham, says the Times.

A memorial service will be held in Leyden tomorrow on the spot where John Robinson, the principal Pilgrim Fathers lived, also in the English Reformed church in Amsterdam and the Scots church in Amsterdam. The official reception of the delegates will take place Monday, August 30 in Leyden when the Ministers Van Karnebeek and De Visser will deliver speeches. The first session on that day will be presided over by the American minister in Holland, William Phillips, while Sir Ronald Graham, the British Minister in Holland, will preside over the second session.

On September 1 the delegates will assemble in Amsterdam for which occasion an impressive program is compiled. On September 2 the members will make a boat trip from Leyden to Delft along the picturesque canal, as the Pilgrim Fathers went in canal boats spending the night of August 31, 300 years ago in prayers in Delft. On arrival in that same little place which forms now part of Rotterdam a memorial service will be held in the church and some other festivities will take place in the town of Rotterdam after.

Delegates will then leave for the celebrations at Plymouth the same day.

GOOD BOUTS
AT CHILOQUIN

Bobby Allen received the decision in the main event at Chilquin Saturday night in a 10-round boxing contest with Louie Lyons, of Los Angeles. The bout was described by fans as a fierce and sensational battle, in which the boy from the cafeteria belt fought gamely against heavy odds in weight.

One Klamath Falls fan said: "Lyons put up a game fight and deserves much credit. The contest was just one fierce rally after another, but it demonstrated again that a good little man cannot beat a good big man."

Allen had the advantage in weight of 30 pounds, it was said.

In the semi-final Earl Ritchie, who is slated for the main event with Wild Bill Reed, San Francisco heavyweight, here Labor day, stopped Hil Stainbrook in the third round. Ritchie showed his usual speed, which is astonishing for a big fellow, and ability to hit.

In the opening bout Kid Hartley of Yreka knocked out Kid Larry in the fourth round. Larry substituted for Bobby Wagner, who had a sore back. He was in poor shape but went on at a moment's notice to save the crowd from disappointment and fought gamely until exhausted.

Chilquin fans were satisfied with the exhibition, was the word brought back, and asked for more bouts later.

Matchmaker Smith starts a busy week today, arranging for next Monday night's contest. Rival training camps are also looking forward to a strenuous week of finishing workouts.

WOOL ASSOCIATION
HANDLES MILLION LBS.

BERKELEY, Cal., Aug. 30.—The California Farm Bureau federation's wool pool organized to handle the marketing of the spring wool clip for farmers has consigned to date about a million pounds of wool, according to W. H. Hellemann, secretary. From the total amount shipped Yolo and Mendocino counties consigned fully one-fourth.

The pool, for the spring clip is practically closed for the state; some of the assignments are as yet in the sheds in California, but the greater portion of the shipments have been made east.

TOWN TO CLOSE
ON LABOR DAY

The committee in charge of the Labor day celebration to be held next Monday reports that its preliminary work has been completed, and an intensive week's work remains to be done.

Every business establishment in the city has signified its intention of closing on the holiday, and, as Labor day follows Sunday, all persons are reminded to do their shopping on Saturday in preparation for two holidays.

Tentative plans include a parade of all affiliated unions, commencing promptly at 10 a. m., from Main and Spring streets, adjacent to the Big Basin Lumber company plant. Invitations have been extended to city and county officials to participate. The entire afternoon, practically, will be taken up by a sports and games program, which will consist of over 20 events, and will provide opportunity for enjoyment to the large crowd expected to attend. Valuable prizes will be competed for.

Two big special events are listed and great rivalry has already manifested itself. A log-sawing contest will attract a number of woodsmen who claim to "wield a wicked saw," and the prizes offered will undoubtedly evoke keen competition. The tug-of-war, the main event of the day, will be bitterly contested. Last Labor day, the fortunes of war went against the carpenters' union, which has since greatly augmented its membership, and the carpenters, aware of this, are determined to "bring home the bacon" this year, wiping out the stigma of past defeat. But the timberworkers, who oppose the carpenters in this year's tug, have ideas of their own, and are saying nothing, and sawing wood, (no pun intended).

Several hundred dollars in cash and merchandise have been donated by the merchants and professional men of the city, and the committee in charge of arrangements is preparing a souvenir program, in which every contribution will be acknowledged. As soon as arrangements are complete, a full and detailed program will be published.

HAYS DENIES
COX CHARGES

CHICAGO, Aug. 30.—The senate investigation of Republican and Democratic presidential campaign expenditures started here today.

The Republican campaign for 1920 will be carried on at total expenditure of \$5,000,000, according to testimony given by Will Hays, chairman of the national committee, but he explained that \$1,100,000 had been expended by the organization which went out of office with the end of the Republican national convention.

Hays emphasized that the present national committee had a budget of approximately \$3,000,000 and that \$1,000,000 of the total amount expected to pass through the committee's treasury would be allocated back to the states for strictly state purposes.

Hays denied Governor Cox's allegations and said positively that no "big money interests" had underwritten the Republican campaign.

Hays told Senator Kenyon he never heard of the quota list of the cities Governor Cox set out in his Pittsburgh speech. "Somebody gave the governor a shoddy list," said Hays. "His statements in regard to the whole quota matter are false."

FIRE DESTROYS
HOME, CONTENTS

His belongings were stored in the lower part of the American hotel here when that place burned last year and he lost everything. The life insurance policy burned at that time but was replaced, as it will have to be again.

FOUR DEAD IN
BELFAST RIOTS

BELFAST, Aug. 30.—Rioting and destruction of property was renewed here early today, the Unionist quarter being the scene of serious disorders. Troops opened fire and a young woman was critically injured and a man wounded. At an early hour other disturbances had occurred and many shops were wrecked.

The troops opened fire from an armored car to clear the streets. Ship workers, unarmed, were attacked on their way to work but soldiers checked the trouble.

Today's rioting is said by the police to be the worst Belfast has seen. Up to 1 o'clock it was definitely known that four deaths had occurred as the result of the disorders.

LONDON, Aug. 30.—The hunger strike of Terrence MacSwingy, mayor of Cork, has progressed so far that even if he took food now it would do him no good, according to a statement by Dr. Briston, prison physician, to MacSwingy's wife.

SAN FRANCISCO, Cal., Aug. 30.—Co-operative agreements for forest protection have been entered into between Lake, Mendocino and Butte counties and the state forester by which the state maintains a ranger for the district and counties stand all expenses of fighting forest fires, according to a report from M. B. Pratt, deputy state forester.

91ST TO KEEP
FIRST BATTLE
ANNIVERSARY

From present indications and reports, what is to be the first and largest of reunions of America's fighting divisions in the World war, will assemble around the bay cities at the Golden Gate. Once more the "Whis-s-a-Bangs!!!" will ring and the "when Buddie and I went over the top" stories will be renewed, and "you remember Geese Hill" conversations, all to be gone over together with the "turnip drive."

A circular letter is being sent out from San Francisco to every known "Buddie's" address, by the central committee of the reunion, to the members, their friends and relatives, of the (Wild West) 91st division, to be held at Idora park, Oakland, Cal., September 26, commemorating the battle of the Argonne, when the ninety-first received its first baptism under fire. Among the invited guests, will be General John J. Pershing, Major General William E. Johnston, commander of the ninety-first overseas, as well as all former division, brigade and regimental commanders of the division.

It is expected that some 30,000 "Buddies," together with their relatives and friends will be present on this occasion; excursions from all parts of California, Oregon, Washington, Montana, Idaho, Nevada and Utah, are being arranged.

Over 1,000 men from the 368th infantry alone, will be there. Other units which will be represented, come in full force, are the 347th field artillery, the Masonic ambulance corps (364th field ambulance company) the 34th, 347th, 348th machine gun battalions, the 361st, 362nd, 364th infantry regiments, the 346th and 348th field artillery regiments, the 316th engineers, the 316th ammunition trains and the 316th military police. All these organizations will maintain headquarters in the various hotels and clubs in the city where former comrades may gather to renew old friendships.

At Idora park a great variety of entertainment will be afforded the former fighters in the form of boxing contests—under the direction of Willie Ritchie—swimming races, dancing, band concerts, an aerial circus participated in by army aviators, and a tug-of-war between representatives of the 181st and 182nd infantry brigades, moving pictures of the division in training at Camp Lewis, in action in France and Belgium, and its return to the United States will also be shown under the auspices of the United States signal corps. The Red Cross, Y. M. C. A., K. C. War Camp Community Service, Salvation Army and other war service organizations will maintain huts on the grounds to assist in the entertainment of the former doughboys.

The committees having the affair in charge, are hard at work perfecting their plans, in order to insure the success of the celebration. The reunion committee, under the direction of Sergeant Major James I. Hers, secretary, has opened a registration and information bureau in room 306, city hall, San Francisco, where all inquiries may be addressed.

BIG YIELDS FROM
MARSH GRAIN CROP

Threshing now being done by the big Holt combined harvester on the Caledonia marsh shows wonderful yields, barley going as high as 80 bushels to the acre, rye making 65 bushels and wheat, it is estimated, yielding 50 bushels.

This tract was raw land just one year ago. The grain crop is on the land recently purchased by the Klamath Mint company, and is located eight miles above Klamath Falls on Caledonia marsh and Upper Klamath lake.
