THE FIRST STATE AND SAVINGS BANK

The First State and Savings bank has not failed, and we do not believe it will fail. The fact that the doors were closed today does not mean that they will not reopen.

Back of the closing lies a long, long story. Its telling at this time is neither opportune nor necessary. But it does not involve any men connected with the First State and Savings bank in any misconduct in the management of its affairs.

"I would rather go down to failure standing side by side with Captain Siemens, than to rise to fame by contributing one iota to the hardships now confronting him."

It is this confidence in the man that is going to put the First State and Savings bank back in its old place as one of the sound financial institutions of the state.

Its closing comes through no fault of Captain Siemens nor any of the officials. It comes simply as a result of an indefinable, untraceable rumor that all was not right with the institution.

Then came the failure of the Morris Brothers bonding house. This failure changed conditions in Portland to such an extent as to require the return of Captain Siemens to that city, where he was at the time it was decided to close the doors of the bank.

Another reason for confidence is the unequivocal statement of Mr. Hooper that the bank is solvent. Its closing will mean a little inconvenience to those having money on deposit, but that is all.

What will happen? Undoubtedly the usual custom will be followed. The bank will reorganize, the reserve placed where it will meet every demand and the institution resume operations.

RESOLUTION DECLARING INTENTION TO MAKE STREET IMPROVEMENTS

The city engineer pursuant to resolution of the Common Council of the city of Klamath Falls, Oregon, having under date of December 11th, 1920, filed his plans, specifications and estimates of costs of improving Fourth street from southerly line of Klamath avenue to the southerly line of Oak avenue; Fifth street from the southerly line of Willow avenue to the southerly line of Walnut avenue; Walnut avenue from the northerly line of Fourth street to the southerly line of Seventh street and Willow avenue from the northerly line of Fifth street to the southerly line of Sixth street, together with all intersections between the termini mentioned not already improved; Such improvement to consist in bringing said portions of said street to the established grade, and hard surfacing the same with Bitulithic, pavement to the following widths:

Fourth street from Klamath to Oak the hard surfacing to be 25 feet in width; with four foot cement sidewalks on each side of the street so far as improved.

Fifth street from Klamath avenue to Walnut avenue the hard surfacing to be 40 feet in width; and from the southerly line of Walnut avenue to the northerly line of Willow avenue the hard surfacing to be 32 feet in width with cement sidewalks on each side of said Fifth street from Klamath avenue to be the northerly line of Oak avenue.

Willow avenue from Fifth street to Sixth street the hard surfacing to be 32 feet in width; no sidewalks.

Walnut avenue from Fourth street to Sixth street the hard surfacing to be 25 feet in width.

Oak avenue from Fourth street to Seventh street the hard surfacing to be 25 feet in width with cement sidewalks on each side of said street.

The sidewalk to be installed four feet in width, together with proper and adequate drainage and curbing.

It is hereby resolved, that said plans, specifications, and estimates of cost for making the improvements above described, be and the same are hereby approved. And be it further resolved, that the Common Council hereby declares its intention to improve said portions of said streets and avenues in accordance with said plans and specifications and estimates of cost in the manner and form above mentioned with Bitulithic or other hard surface pavement. The estimated cost of the proposed improvements hard surfacing with Bitulithic is \$63,000.00; The estimated cost of the proposed improvements using Oil Macadam pavement is \$46,100.00; the estimated cost of the proposed improvements, hard surfacing with Concrete is \$57,800.
