STANFIELD ON 3 COMMITTEES

WASHINGTON, March 21.—Senator Stanfield will get a place on the major committee of postoffices and post roads. He will reintroduce the \$100,000,000 road measure introduced by Chamberlain with the assistance and co-operation of Senator McNary, an d will be able to push it by reason of membership on this committee.

Governor Stanfield will also be a member of the committee on public lands, made possible by the relinquishment of this place by Senator McNary. Senator Stanfield will also have a membership on the committee of claims, where he can be in touch with the war and other claims, and will be on the civil service committee, which will handle all the soldiers' claims and pensions. The assignments received by him are considered very good and give Oregon added strength in the senate.

Senator McNary retains his chairmanship of the committee on irrigation, one of the most important committees for the West and Oregon. He goes up to fourth place on the committee on agriculture and is really higher in line than that, as the senators ahead of him have other major chairmanships.

Norris of Nebraska is made chairman of agriculture, which is good for the West, and the other Republicans are Page, Kenyon, Wadsworth, McNary, Capper, Keyes, Gooding, Ladd and Norbeck. The West is dominant in this committee.

Senator McNary also moves up on the commerce, Indian affairs and manufactures committees, as he was prevailed upon to retain his place on Indian affairs by Senator Curtis, chairman, although pressure of work made him consider dropping this committee.

GRAZING FEE PAYMENT TIME IS EXTENDED.

The Agricultural Appropriation Bill, approved March 3, 1921, carried an amendment which allows grazing permittees on the National Forest until September 1, 1921, in which to pay their grazing fees. Failure to make payment on or before September 1, 1921 shall be sufficient cause for revocation of the permit and of the grazing preference of the permittee, and trespass proceedings may be taken to collect the value of the forage consumed.

This amendment, it is understood, applies for the year 1921 only, and is made by congress to help the stockmen over a period of financial stringency.

Jim Howard Found Guilty By Federal Jury At Portland

"Old Jim" Howard was found guilty Friday at Portland of violating the laws of the United States in connection with illicit distilling in Klamath county.

For the first time in his 60 odd years, much of which has been pass-

ed in developing the art of distilling, "Old Jim" has become entangled with the law.

For years "Old Jim" Howard has been a picturesque character of southern Oregon. In the days before the state went dry, he was noted for the peculiarly fine quality of the whisky which he distilled under license from the government.

Jim's fall came through the possession of some latter-day moonshine. The federal jury in Judge Beans court acquitted Jim on two counts, but convicted him of possession of liquor.

Judge Bean will pronounce sentence early this week. It was not believed that "Old Jim" will attempt to appeal.

DECKER ADMITS SLAYING DOUBLE

WARSAW, Ind., March 21.—Virgil Decker, aged 19, Saturday confessed that he struck Leroy Lovett, his "double," with a crowbar as he slept in a cottage on the Tippecanoe river, near here, and several hours later took the unconscious body to a nearby railroad crossing where a buggy containing the body was struck by a train.

"The devil drove me to it," said Decker, after signing the confession. He denied that transferring his own clothing to Lovett's body was a part of the plan to collect insurance totalling nearly \$30,000 payable to the slayer's brother, Fred Decker, in the event of Virgil's death.

Memories of his early religion, revived by letter urging him to confess and seek forgiveness, combined with the softening influence of the motherly advice given by Mrs. C. B. Moon, the sheriff's wife, resulted in Decker's confession.

CHARGE ROADS SEEK TO BIAS PUBLIC MIND

CHICAGO, March 21.—Charges that the railroads, knowing the railroad labor board had no power to enforce its decrees, were trying to smash the labor unions through public opinion and were attempting to influence public opinion through false, paid publicity, were made before the board Saturday by Frank Walsh, the union's attorney, when he began the second day of cross questioning of railroad officials.

He asked T. Dewitt Cuyler, chairman of the association of railway executives, whether Ivy Lee, press agent, was not employed because he was an expert in breaking down unions.

"No," replied Cuyler. Walsh charged Lee published false statements regarding the salaries of union officials in mine publicity gotten out in 1914.
