RAIL LABOR BOARD'S WAGE CUT ORDER IS EXTENDED

CHICAGO, June 28.-United States railroad labor board today extended its wage reduction order, effective July 1st. to practically every large railroad in the country. No change from the 12 per cent reduction granted 105 carriers June 1st was made by today's decision. The new order affects 210 roads.




