EDDIE BURNS HAS RECORD AS "A BAD MAN"

Sheriff Low received the following clipping from Sheriff Colkins of Yreka, California, today, which gives the record of Eddie Burns, the "master mind" of the Mt. Hebron and Dorris robberies which took place in June. The thieves were traced to this city and the spectacular flight of Joe Schmidt, Eddie Burns and a man named Neehias followed, after a Chevrolet car was wrecked in the canal east of this city.

Sheriff Low and the local officers followed the trail of the three men. Burns, according to Sheriff Low was rather pitied by a certain element in this city as they presumed he was not a criminal. The clipping taken from the Yreka paper at the time of the trial of Burns tells his record: "Few people who read the account of the arrest of Eddie Burns had any idea of the manner of man the local officers had to do with."

Knowing his prisoner to have had a wife, Sheriff Colkins communicated with the prison authorities of Leavenworth, Kansas, sending fingerprints of Burns, and the report of this individual was not over voluminous and not at all reassuring.

He was known in the northwest as a desperate man and worked under the name of Louis Steurnagle and among other items the report states that he was the leader of a gang of safe crackers, store burglars and box car robbers operating in central Washington. On the night of November 16, 1920, he escaped from the county jail in Ephrata, Washington, where he was held for grand larceny, by picking his way through two heavily locked doors.

The young man was first sentenced in King county in 1915 to the Monroe reformatory for burglary for from one to 15 years. He was paroled to join the Canadian army, from which he deserted. He was later sentenced from one to 10 years to the Washington state penitentiary in 1918. He was again paroled and arrested again for cracking safes for which he was awaiting trial when he escaped. He had been charged with habitual criminalism. He is reported by the sheriff from Grant county Washington, as being a gun man and a desperate character.

This is the prisoner who attempted to dig his way out of the Okanogan county jail recently, but was unsuccessful.

U. S. WAR TRUCKS FOR ROAD WORK

More than 27,000 motor vehicles have been distributed by the Bureau of Public Roads of the United States Department of Agriculture among the various states for road-building purposes. Up to October 31 a total of 27,198 had been so distributed, including 1,800 retained by the Department of Agriculture for use on roads in the National Forests and in connection with the administration of the Federal Aid Act. These comprise virtually all the surplus motor vehicles turned over to the Department of Agriculture by the War Department to be distributed under the Wadsworth-Kahn Act among the States for road-building purposes. These vehicles, consisting mostly of motor trucks, are a part of the war materials originally intended for use in France.

Of the number of motor vehicles distributed to the States up to October 31, Oregon was allotted 314 trucks and 24 autos.
