ATIONAL Educational Week is closed, and if it has been but

a week theoretically set apart, if it has not kindled fires of practical ambition to attain the ideal which educators, editors and public speakers .bave been talking about during the week, it has been a failure. Unless it has been but the beginning of a wide campaign to wipe out illiteracy, the work can as well be set down as wasted from the standpoint of actual accomplishment. It has functioned chiefly in the

schools, where all are pursuing the pathway of literacy. Except as it may influence those whom it reaches in the schools, both students and teachers, to consecrate and reconsecrate their lives to the crusade against ignorance, it has not even touched the fringes of illiteracy.
