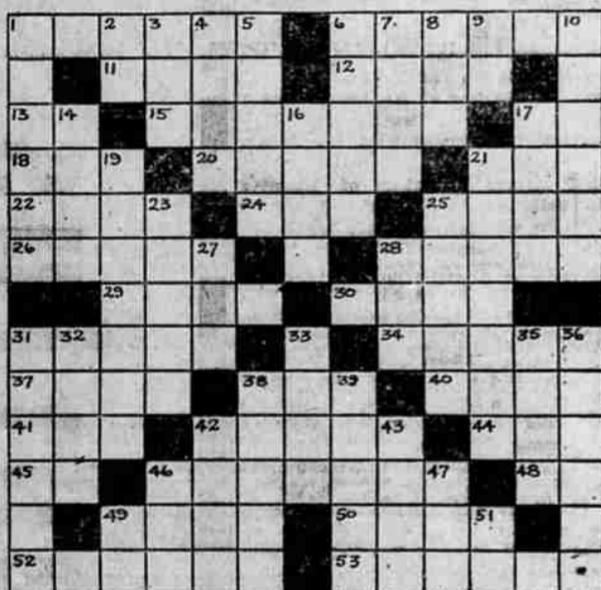

THE VIRTUE OF BEING IN DEBT

If you were going to employ a salesman and had your choice of a man heavily in debt or one equally capable but not in debt, which would you prefer?

A great corporation recently made a statistical survey of common attributes of several hundred salesmen and discovered the surprising fact that men heavily in debt seem to accomplish more than those without such financial burden. The explanation is believed to be only partly that, when a man owes a large sum of money, he works hard to get this debt removed. Still more important is the fact that a man heavily in debt is probably a smart fellow or he wouldn't have succeeded in inducing a bank or other institution to permit him to owe so much money.
