## FRENCH CABINET GETS VOTE OF CONFIDENCE

### Chamber of Deputies Endorse Painleve Ministry by Big Majority

PARIS, April 22.—Nine hours of debate featured by bitter personal attacks on Joseph Caillaux, lately returned from exile and now minister of finance, preceded the vote in the chamber of deputies last night on the policy of the new cabinet. At the conclusion of the verbal fireworks, Premier Painleve and his colleagues were voted confidence, 394 to 218.

The tactics of the opposition in attacking the inclusion of Caillaux in the ministry are believed to have assured the victory of the government, as both the radicals and the socialists were dissatisfied with M. Painleve's announced declaration of retaining the French embassy at the Vatican.

For Caillaux

M. Blum, the socialist leader, said that when he entered the chamber session he had his doubts, but when he heard the attacks directed at Caillaux these doubts were removed.

"We congratulate M. Painleve for having summoned Caillaux," M. Blum continued, "and since he is attacked for having done so, we give him our votes." So the socialists' 104 votes went solidly for the government.

To Restore Finances

M. Caillaux will appear before the chamber's financial committee Friday to review the financial situation and probably to give some indication as to the nature of his first efforts to restore the situation of the treasury, notably on the subject of repayment of the short term notes falling due this year. The government today is indicating a bill for two provisional votes on account to pay the current expense of the government for May and June as the budget for the year has not yet been passed. The financial committee is expected to report on the provisional appropriations late today so the chamber can begin debating them tomorrow.

## BEND MAN WILL RECEIVE NEW HEARING

SALEM, Ore., April 22.—Judge McMahon of the circuit court today granted a writ of review in the case of the state against Joe Polley, a Bend, Oregon contractor, who is accused with a violation of the prohibition law in connection with the seizure of a still. The case is being appealed from the justice to the circuit court.

When the case was called for hearing last Friday district attorney Carson moved that the justice of the peace sit as a committing magistrate and bind the defendant over to the grand jury without hearing. The motion was granted and Polley was freed upon furnishing bail of \$250. He has returned to eastern Oregon.

## AMERICAN LEGION FAILS TO DECIDE ON GUARD COMPANY

R. Canton, A. D. Collier, and George M. Barth. This committee will meet to consider the resolution April 25th at which time those interested will be heard.

It was claimed by some of the speakers that it was not within the scope of the authority of the American Legion to have anything whatsoever to do with this proposition.

## HILL LINES TO TOUGH MALIN SECTION

### General Agent Hoyder of Hill Lines Confers with Local Water Users

J. J. Hoyder, general agent for what is known as the Hill Lines, made a hurried visit to this city last evening for the purpose of conferring with the directors and officers of the Klamath Irrigation district about the proposed colonization project announced by Dr. Mead, commissioner of reclamation. When here Dr. Mead stated that he had under way a plan to place one hundred families upon Tule lake land and that the only thing standing in its way was transportation. He further stated that if a railroad tapped that part of Klamath county several hundred additional families would be sent here to settle on this land.

In all of the announcements that have been made in connection with the extension of the Oregon Trunk to this city, the terminus has never been placed beyond the state line. Reference to the extension of the line "to the state line" has frequently been made and when this peculiarity has been mentioned to some of the officials, the response has been that the Malin section was a very fertile one and capable of producing a great deal of tonnage in and out. Hoyder's sudden return to personally investigate Dr. Mead's plan indicates that there is a strong probability that if the Hill lines come to Klamath county they will touch the Malin section.

The great possibilities for development of the land surrounding Malin, as well as the Merrill section, amazed Secretary Work and Commissioner Mead. It likewise has been a source of wonderment to the Hill officials who have been making an intensive investigation of possible tonnage in Klamath county. The Hill lines have been known as developers. It was the sentiment of the late James J. Hill that he would sooner haul in a bushel of wheat than haul out a carload of lumber, for when a tree was cut that ended it, but the wheat kept right on producing tonnage. So a policy in Klamath county would make it one of the richest in the state.

## LAKE OF THE WOODS SHUT OFF BY SNOW

Lake of the Woods is isolated from the outside world by a heavy snow that fell last Saturday and Sunday, Forest ranger H. J. Rogers reported today. On Monday morning, there was 23 inches of new snow. During the heavy storm of Saturday and Sunday the lake raised 12 inches in 30 hours. According to last reports it is still snowing in the Lake of the Woods region.

Only with snow shoes or skis would it be feasible to attempt to get to the lake, the forest ranger said. Mr. Rogers is connected with the forest service force on the Crater National forest. He is stationed at Rocky Point.

## NAVAL CRUISE FROWNED UPON

### Secretary Wilbur Urged Not to Send Fleet to Australia Now

WASHINGTON, April 22.—Secretary Wilbur was urged today by Frederick J. Libby of the national council for prevention of war, to abandon or curtail the program for the fleet visit to Australia. A letter written by Mr. Libby said "the psychological effects of the cruise" are all on the side of misunderstanding even in Australia, but not less so in the United States and Japan. "There are unquestionably," it adds, "multitudes of citizens in the United States who prefer that we avoid military gestures and who are enthusiastically behind our president in the attempt to maintain a consistent and unwavering policy of friendship and understanding with all nations."

## WRATHY MOROS PLANNING REVOLT IN PHILIPPINES

MANILA, April 22.—Revenge for the killing of a number of their relatives more than a year ago by the Philippine constabulary during an uprising, is being planned by a band of Moros in Lanao province, constabulary headquarters here was informed today.

The Moros, it was stated in the report, have assembled in a native fortress and preparing for vengeance.

The constabulary commander for Lanao province said necessary steps had been taken to dislodge the Moros from their position by peaceable means if possible.

## BUILDING MAY BE IN CHARGE OF REV. RICE

### Klamath Falls Pastor May Accept Position of Head of Community House

According to word received today, Rev. and Mrs. Arthur L. Rice, of the Presbyterian church of Klamath Falls, may accept the charge of the community house at Crater Lake National Park, during the summer months. According to Rev. Rice there are several angles of the proposition to work out, before definitely accepting the position. Last summer, Rev. Rice acted as gate tender at the park and was highly pleased with his work in connection with the tourist trade.

Although near completion, the community house in the park, not more than 50 feet from the lodge, was not used to a great extent, until the last few weeks of the season. The building has been erected for the comfort of the tourists who use the park auto camp grounds. The hotel cares for its guests in a social manner and the need for social facilities for the transient guests was felt. The building includes a huge fireplace, victrola, wicker furniture, several smaller rooms and rest rooms. Although there has not been a sufficient fund for the purchase of a radio, several expressed belief that the community home would be furnished with one before the close of the season.

## SHEPHERD WILL GET EARLY TRIAL

CHICAGO, April 22.—Chief Justice Hopkins of the criminal court today assigned the trial of William D. Shepherd, charged with the murder of his foster son, William N. McClintock, by typhoid inoculation, to Judge Thomas Lynch for trial. Judge Lynch said he would set the case for next Monday for preliminary motions.

"Our calendar is in such shape that it will be possible to grant a reasonably early trial," said Judge Lynch.

The contract for the county timber cruise was awarded several months ago to the firm of Edgar and Cullison. The contract will bring \$15,000 to the successful bidder.

## CHILD'S DEATH IS TO BE PROBED

### Tillamook Woman Admits Giving Granddaughter a Severe Beating

TILLAMOOK, Ore., April 22.—The death of Sylvia Louise Descamps, aged 4, at the farm home of her grandmother, Mrs. M. C. Paton, 35 miles south of Tillamook, following a beating which the grandmother admitted to District Attorney Barlick she had given the child, will be investigated tomorrow by the county grand jury. Barlick announced today. The nature of charges, if any, will be determined by the findings of the grand jury, he added. Mrs. Paton is in jail here.

The girl's body was taken in charge late yesterday by Coroner Henkle after investigation by Barlick and Deputy Sheriff Lucas of reports that the child died after receiving a beating with a strap at the hands of the grandmother. Mrs. Paton, the authorities declared, said she had corrected the child for a minor fault, and that the beating followed an attempt by the child to strike back. Mrs. Paton said she did not intend to harm the child and did not realize she was striking the child hard.

Becomes Ill

The child went out to play after the whipping and later came in complaining of feeling ill. Mrs. Paton put her in a chair and later to bed. She said she sent for aid to a neighbor's home.

Sylvia was the daughter of Mrs. Cora M. Descamps of Portland, and Peter C. Descamps of Washougal, Wash. The parents were separated and the mother had sent Sylvia and three other children to the grandmother's home last year.

Mrs. Paton has been homesteading a forty-acre tract in the Meda district. She is 59 years of age.

## YOUNG MALIN GIRL INJURED BY AUTO

MALIN, April 22.—Miss Mildred Zumr of Malin is in a Klamath Falls hospital suffering from a badly fractured leg, when she was struck by a car driven by Clarence Kirkpatrick this morning. The accident, which witnesses say was unavoidable, happened just before the opening of school, when Miss Zumr stepped out of her car in front of the blacksmith shop on the highway. She was reported as resting easily this afternoon. Miss Zumr is a student in the Malin school.

## MERRILL HIGHWAY IS NOT DAMAGED

Although The Dalles-California highway south of town was inundated at a point near Lum Short's ranch, when a fault in the main irrigation canal precipitated a flood of water over the road, the road was not materially damaged, state highway engineers asserted this morning. The roadbed was not undermined and only the sides of the road were washed away to any extent. The repair work can be accomplished at a nominal cost.

## TWO KILLED IN RAILWAY WRECK

### Engineer and Fireman of Milwaukee Line Lose Lives in Crash

MILES CITY, Mont., April 22.—Both the engineer and fireman of the Columbian, crack passenger train on the Chicago, Milwaukee and St. Paul railroad, were killed this morning at 10:15 o'clock when the train hit a burned out bridge and the engine dropped ten feet into a dry run three miles west of Rahway, Montana.

As the engine plunged, the air lines burst, automatically setting the brakes on the passenger coaches behind and stopping the train, all of the coaches except the mail car remaining on the tracks. Some of the passengers were badly shaken, but none seriously injured, according to the announcement of railroad officials here.

## FORD DEFENDANT IN LIBEL ACTION FOR BIG AMOUNT

DETROIT, Michigan, April 22.—Henry Ford and the Dearborn Publishing company of which he is owner, were named defendants in a \$1,000,000 libel suit filed today in U. S. District Court by Aaron Sapiro, originator of a plan of cooperative marketing for farmers.

In the declaration filed by William O. Gallagher, attorney, Sapiro alleges that articles defamatory to his character have appeared in the Dearborn Independent. The articles, the declaration alleges, charged Sapiro with being one of "a conspiracy of Jewish bankers who seek to control the food markets of the world."

## BRUTAL MURDER OF WOMAN IS UNCOVERED

### Unidentified Body With Skull Crushed Found by Culver City Police

LOS ANGELES, April 22.—The body of an unidentified woman about 35 years of age was found early today two blocks in the rear of a couple of road houses at Culver City near here.

Surgical examination revealed that the woman had been killed with a club after being criminally assaulted. Her skull was crushed.

Earlier police reports fixed her identity as Mildred Tracey, inmate of a Culver City sanitarium, who had escaped from the institution yesterday. This identification later was proven erroneous.

The body when found was only partly clad, the greater portion of the clothing having been torn off, apparently in the struggle which the victim had waged with her attacker.

No marks of identification could be found on the clothing that remained on the body or on the articles which had been torn off and lay scattered about.

A blood stained battered club was found nearby.

## MEDFORD COUNCIL HITS AT PEDDLERS

MEDFORD, Ore., April 22.—At a meeting last night, the Medford council in an effort to discourage street carnivals and peddlers from entering the city, passed an ordinance increasing the tax on carnivals from \$50 to \$100 a day, and adopted a peddlers license ranging from \$7.50 to \$300 semi-annually, outside collectors are also required to put up a bond of \$500.

## MOE EXPECTED TO ARRIVE TO FACE CHARGES

### Former Pine Tree Manager Due Back in City Some Time Tomorrow

Frank Cassidy, general manager of the George N. Mann theater interests, arrived in Klamath Falls last night to spend several days checking up on the alleged embezzlements of B. F. Moe, former manager of the Pine Tree theater.

"I would rather not make any statements regarding the charges against Moe," Mr. Cassidy said. "Our investigations disclose that he got away with \$2150 in actual dollars and cents and that he accomplished his reputed embezzlements by substituting duplicate deposit slips of receipts taken in at the theater for the certified deposit slips issued by the bank. Our auditor did not notice that the deposit slips were not certified until we started to check up on the matter."

"The matter will be aired before the grand jury and I would rather not say anything that would be disadvantageous to Moe at this time."

It was Mr. Cassidy who accidentally detected the first shortage of \$450. At that time, he agreed to give Moe a chance to return the money. Later investigation in San Francisco disclosed further shortages.

Moe is expected in Klamath Falls tomorrow. He left for this city from Kollage, Idaho alone.
