BAD EXAMPLE

Aside from the questions involved in the trial of Senator Wheeler, the Department of Justice laid itself open to severe criticism, if not censure, for the unfair advantage attempted in "springing a surprise witness" without allowing the defense an opportunity to present rebuttal testimony. Every American citizen expects the government to be fair and square—not only in matters affecting Senators, but in matters affecting the common man. Legal procedure of this character is of justice which appeals even to school children. The Department of Justice should not lend itself to measures that President of the American Bar association denounces as "one of the blackest crimes in the legal and governmental history of the United States."

his Spokane headquarters to Klamath Falls, and each time, newspaper files reveal, he urged the citizens of this community to high endeavor. He wanted them to use all possible speed in obtaining the required right of way to Bend—without cost to him. He eulogized the community spirit of Klamath county, and said more than once that he was proud to lead a big railroad program for Central Oregon with such loyal and far-seeing people standing with him and working shoulder to shoulder with him.

His honeyed words had their effect, and the citizens of this section worked with a will to comply with every demand he made of them, relying firmly on his promise to build the projected line through to Bend.

The files reveal that after the people of Bonanza, through their railroad promotion club, had obtained all of the needed right of way for the branch line from Dairy to Bonanza, they went even a step further and offered three ideal terminal sites to Mr. Strahorn, absolutely without cost. For they saw a railroad traversing their fertile section, and with the coming of the ribbons of steel, they saw an end to controversies between factions of the Horsefly irrigation district. Old differences were forgotten as they worked together for a common cause—the Strahorn railroad.

This was the temper of this and other communities throughout this section during the fall of 1916, when people generally fully believed that the Klamath country had awakened to the dawn of a new era—with Robert E. Strahorn and his railroad promises foremost in the hearts and minds of the people.

YOUNG CONVICT IS RECAPTURED

a number of 30-30 rifle cartridges. Hall was taken at about ten o'clock last night, but the news was held up for two hours by the newspapers upon the request of Chief of Police McShane who had hopes of being able to apprehend Tanko as well.

Through the night the entire police department worked, looking for Tanko. All roads leading out of the city were guarded and rooming houses were being searched. Even the off shift of the fire department was called into service. The sheriff's force also was out. It seemed that Tanko might be captured during today.

Means Hanging
Hall's only comment after his capture, the police said, was "I know what this means, it's the noose."

This cryptic remark was taken by some as an admission that it was Tanko and Hall who on April 18, shot and killed H. J. Litzberg, a Sacramento merchant in his store while attempting to rob the establishment.

Gus G. Rilo, an aged clerk employed by Litzberg always has maintained that it was Tanko and Hall who attacked him in the robbery attempt and shot Litzberg when he came to the rescue from a rear room.

Three days after the killing of Litzberg, Patrolman Clyde Nunn, pursuing a car which had been commandeered, along with its driver, F. R. Harlow, was shot by men later identified as Tanko and Hall. He was dangerously wounded, but is recovering.

Were Desperate
When arrested, Hall was dressed in a new pair of overalls and a new shirt. A new cap was also found in his room. It bore the label of Tozal, a Japanese merchant at 1241 Fourth street.

On the way to the city prison Hall remarked to Chief McShane that it had been "hard going" and that the officers had "hounded" them to a point where they were almost desperate.

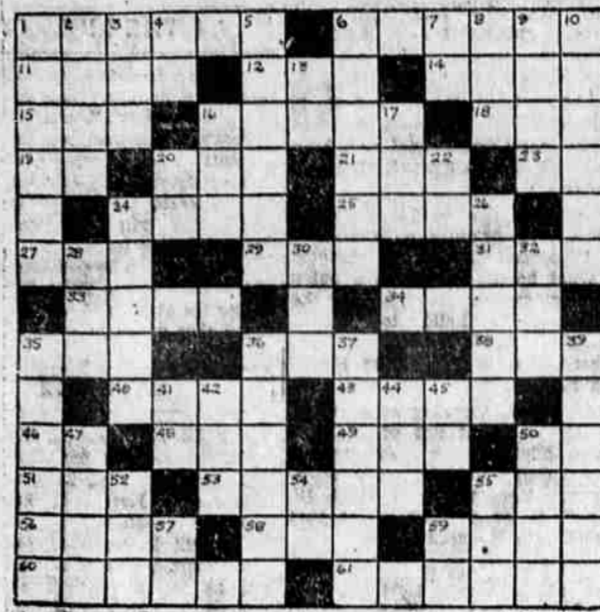
The tip to the police department was given by a man who saw a man he thought was Hall leave the Nippon theatre, Fourth street near L. Following him, the man saw the suspect disappear into the Colusa Rooming House and immediately notified Captain Desfontains.

Tanko Escapes
It is presumed by officers that Tanko was with Hall in the theatre and became suspicious as the two left, probably turning in another direction when he observed his partner was followed.

According to S. Shimada, proprietor of the rooming house where Hall was arrested, a man rented a room about six o'clock last evening and said he wanted accommodations for two. He left and returned in about ten minutes, Shimada said, registering under the name of "J. Raych" after that the rooming house man saw no more of him until he was brought downstairs by the officers, he said.

COOK RETURNS TO MEDFORD THURSDAY

Cecil A. Cook, boy scout representative of Klamath, Jackson and Josephine counties returned to his home in Medford yesterday after spending ten days in the city in the active interest of boy scout work. According to those interested in the projects, Cook has accomplished a surprising amount of work among the raw material given him to form scout troops. The appointment of scoutmasters has not yet been definitely made, however those who will serve will be men who are interested in boys and the work of boys during the spring and summer months. Among the troops to be formed in the city while Cook was in Klamath Falls were two in Fairview school and one from the boys of the Sacred Heart church. Cook will return within a fortnight to resume his duties here.

Army Officers To Enroll Youths For Summer's Camp

As guests of honor at the Reserve Officers banquet tonight in the White Pelican hotel, Colonel F. T. Arnold and Major John Bubb, both of Portland are in the city today.

Colonel Arnold who is chief of staff of the 96th division of Portland in charge of all reserve activities in Oregon and Washington will address the students of the high school today and be the speaker of the evening at tonight's banquet which is scheduled for 7:30 in the Dutch room of the hotel. Not only is Colonel Arnold actively interested in the activities of reserve corps but also in the Citizens Military Training camps in this area. It is for this purpose mainly that he and Major Bubb, who is division adjutant

have made the trip to Klamath Falls. They expect to return to their homes tomorrow.

The mission of the trip is to enroll high school boys for the Citizens Military Training camp for the season of June 19 to July 18 in Camp Lewis, Col. Arnold and Major Bubb recently made a trip to Coos county where they enrolled 43 boys in the high schools. They hope to surpass this mark in Klamath county and in Klamath Falls alone.

According to Colonel Arnold, statistics show the average increase to be five pounds for each man in the camp last season. The work includes all forms of athletic work and various phases of entertainment accorded them.

"The basic idea," said Colonel Arnold, "is the physical development, the training and leadership given to the boys while in camp, teaching them the basic fundamentals of good citizenship."

Four Bootleggers Are Found Guilty In Federal Court

PORTLAND, Mr. 15.—Four of six alleged rum runners, arrested by Federal officers at Warrenton, Ore., July 24, 1924, were convicted in federal court today on charges of possession and transportation of liquor. The jury failed to agree on a conspiracy charge. Those convicted were Oscar Lund, Dean Thomas, W. L. Davis and J. R. Gillfellen. One of the defendants, Luther Zinn, was acquitted of all charges.

The sixth, Captain E. C. Swank, failed to appear for trial, and forfeited bonds. The government announced a retrial on the conspiracy charge would be asked.

Officers charged the men were arrested while unloading 175 cases of liquor from two rum runners.

S. P. EARNINGS

SALEM, May 15.—The Southern Pacific company as a result of its business in 1924, was able to credit to profit and loss \$25,367,148.77, according to the annual report filed today with the Public Service Corporation. Total operation revenues were \$204,211,872.74, total operating expenses \$147,021,812.69 and net operating income \$38,487,712.41. Steamship operations showed a deficit of \$96,339.84.
