

HENRY BURKE AND 'FARMER' VANCE TO WRESTLE HERE AT MOOSE HALL SATURDAY

Local Man Puts Coast Middleweight Championship Belt at Stake With Idaho Champ—One of Best Cards Ever Staged Predicted

Moose lodge promoters announced this afternoon that as a special added attraction, Pete Buzukos, one of the best welterweight wrestlers in the country, has been signed to meet Jim Fleming, a middleweight, in a special added event.

More interest than ever before is being displayed in the wrestling bout at Moose hall next Saturday night when "Farmer" Vance, middleweight champion of Idaho will attempt to wrest the middleweight crown from Henry Burke, Klamath Falls grappler.

Heretofore Burke has always had to wrestle men much heavier than himself, but in Vance he is meeting a legitimate middleweight with a reputation of being one of the best in the west, and the local man will have to show his full bag of tricks if he is to win the coveted two out of three falls.

For the first time in more than a year Burke's middleweight belt, emblematic of the coast championship, will be at stake. Vance has agreed to weigh 160 pounds at 2 o'clock Saturday.

A good preliminary bout also will be offered, when makes it one of the most attractive wrestling bouts the Moose lodge has ever staged here.

Interest in wrestling revived considerably yesterday with the arrival in the city of Pete Buzukos, former welterweight wrestling champion of the United States.

So far as looks are concerned, Pete is in a class with "Bull" Montana, and he carries a pair of cauliflower ears which would make the



Bull blush with envy. He's no Ansonia, but he's a cracking good bone crusher, and he's here to challenge the winner of the Vance-Burke match. Pete says he has taken on a little weight and will come into the ring at about 155. A finish bout between him and either Burke or Vance would be a top-notch attraction, and one which the Moose promoters would do well to stage, providing they can get Burke or Vance on the dotted line.

With Saturday more or less of a holiday, and with Burke's belt at stake, Moose lodge officials are looking forward to the biggest wrestling crowd that has ever jammed its way into Moose hall. Anyway, it is a match that would draw attention any place on the coast.

COPS 'EXPOSE' HELD FAILURE

incidents which have occurred during the past few weeks, in their effort to prove inefficiency on the part of Chief Loucks and his patrolmen. One instance was cited in which a group of about 20 well known men and women were staging a "party" in a Chinese noodle joint. It was intimated that members of the party comprised some of the best families of the city.

Dignity Hurt Cooper and Brown walked in on them while the party was at its height. Cooper, the testimony showed, walked into the kitchen of the noodle house, and one of the women of the party laughingly told him to go ahead; that he would make a good dish-washer even if he was a bad policeman. It ruffled Cooper's dignity and he wanted to "pinch" the bunch of them. But Brown telephoned to Mayor Goddard and was told to quiet them down and let them go home.

Then, horrors! Argraves wanted his job back because, he testified, Chief Loucks had shown discrimination in assessing charges against cattle or stock impounded by the city. His testimony was to the effect that Loucks had charged one man more than another, and by reason of that, he (Argraves) was a good police officer and ought to be wearing the star again.

Herald "Party" Aired The much-discussed "Herald party" also was aired fully and completely.

Cooper testified that early one Sunday morning he had seen a man walk across the used car lot at Eighth and Main streets, and in following him had entered the rear of The Herald building and had seen a group of printers playing a game of cards. He had "pinched the joint", to use his expression, and carried some of the men to the police station on charges of gambling. But Mayor Goddard had arrived a short time later and ordered the men released from custody. He had seen no liquor, he testified.

Mayor Goddard testified that he had investigated this arrest, had conferred with the city attorney and found there was absolutely no evidence on which any charge could be prosecuted.

Friendly Game W. H. Perkins, news editor of The Evening Herald, testified that a group of the printers had been playing a little friendly game of cards just after the Sunday morning Sun had got off the press; that one of the reporters had gone through the used car lot in order to get a key to the front door for use the next morning, and that Cooper had followed the reporter into the building and arrested four of the seven men without asking for or receiving any explanations.

Perkins said that he had not requested that the charges be dropped. Instead, he got in touch with Mayor Goddard and demanded that the men be released because they had been unlawfully detained by Cooper. Perkins further testified that Cooper

had said that "a man named Myers" in the district attorney's office had ruled that the presence of poker chips, even in a private dwelling, was prima facie evidence of gambling, in which Myers apparently had overruled the supreme court. A \$20 check which Perkins had posted for the release of one of the men later was torn up after Chief Loucks had returned it on instructions from the city attorney.

Cooper Questioned Cooper was asked if he knew anything about Argraves or had heard him discussed relative to the work he was doing.

"I heard other officers say he was yellow, when he was on the night shift," he testified. "They said he wouldn't hold up his end of the work at night."

Patrolman Brown, as a city witness, testified he had been present at the police station just prior to the 432 Broad street raid, and that no whiskey had been taken out of the locker, and that there had been no talk of "planting" the stuff.

Powell Questioned Ex-chief of Police Powell also was present that night, and testified that there had been no talk of whiskey "planting."

"You are very friendly to Mayor Goddard, are you not?" asked Attorney Marx.

"Yes, I am," replied Powell. "You helped him a good deal during the campaign, didn't you?"

"Yes, and I am proud of it," replied the witness, as the crowd in the rear of the hall cheered lustily.

During the time he was on the stand, Argraves smirked almost continually as he faced Mayor Goddard and assumed the attitude of attempting to show that he knew all about police work, while his superiors knew nothing at all.

Argraves Questioned He was being questioned as to why he had not aided in protecting a group of school children who were parading Main street through heavy traffic.

"Well, I saw the mayor out there in the street with them, and thought if he knew so much about it, I would let him finish it," said the witness.

It was this attitude which seemed to impress the council that Argraves was not the efficient officer he should have been.

A large body of citizens, property owners in the district on which paving contracts were scheduled to be awarded last night, were present during the hearing.

Citizens Angry Dissatisfaction was expressed by some of these that the council would allow its time to be taken up by testimony of such character while the question of these awards is still hanging fire.

It was pointed out that it will now be impossible to take action on the bids until next Monday, at the very earliest. Some of the property holders expressed themselves as feeling that the matter of improving a big section of the city's streets was of more importance than the hearing of an attempt to impugn the motives or actions of city officials who had consistently shown their desire to do all that was possible for the best interests of the city.

contention that while the Clear lake dam was essential to the irrigation of the Langell valley lands, it was not so in the case of the Tule lake lands, because these lands could be and were reclaimed by the Lost river drain.

He further contended that when the homesteaders offered to stand twenty or twenty-five per cent of the construction cost of the Clear Lake dam, it was done not because they felt that they were benefited to that extent, but simply because they wished the matter settled and to that end were willing to give it in the nature of a gratuity.

It seemed rather difficult for Campbell and Goodwin to understand this line of reasoning, but it seemed very plain to the third member of the board, W. A. Dazell, the state's representative. Aside from this slight rift in the lute, the hearing proceeded with smoothness and dispatch.

One of the interesting features of the hearing was the artful dodging of Superintendent Nowell whenever asked to furnish any information as to costs or any facts as to engineering decisions made during the progress of the construction

of the project. There was a clear lack of the honesty and frankness that should exist between master and servant and the slipperiness of the bureaucrat was characterized throughout.

As a partial excuse for the charge of half the construction charge of the Gerber dam against the Tule lake lands, Chairman Campbell stated that it had to be charged somewhere; that there was no law against it; that it was not apportioned according to the benefit received, but with the single object of securing the return to the reclamation fund of the money expended; that the service had to find some place to put the charge so as to insure the return of the money to the trust fund.

This phase of the case was disputed by Carnahan, who contended that there was no law for such a procedure and that the charges should be made not according to the whim or fancy of someone, but clearly and only upon the benefit derived.

At this point Mr. Goodwin, the interior department representative, stated that it was apportioned at the discretion of the secretary of the interior and that no one "could question the discretion of the secretary, even though he were wrong."

This peculiar mental attitude was something new to the counsel for the homesteaders, and he stated that he did not think this was a correct point of view and hoped that the time never would come when such powers were delegated to any man by an American government.

The first projection of the steal of the power sites and water rights by the Service and their disposal to the California Oregon Power company for a song, came when Mr. Carnahan called attention to the fact that if the sale were to stand, he wanted a portion of the \$120,000 credited to the Tule lake lands.

This brought out the amazing information from the project manager, Mr. Nowell, that the project never was given credit for the \$120,000 but it was credited to some mythical power account.

After some more artful dodging, he offered as another reason for the non-crediting of this to the project the fact that it was for the ditches and canals acquired with the Ankeny canal were worth much more than that realized by the sale of the Kené and Ankeny canals and the Leavitt power site, and hence the money was diverted elsewhere and the account balanced by charging up the old ditches and canals to the farmers.

It is expected that the hearings will continue for more than a week.

Predatory Animals Cause Less Damage to Livestock Here

Ravages of predatory animals on sheep of Klamath and Lake counties were less this year than ever before, is the report of Stanley G. Jewett, inspector of Oregon for the Predatory Animal control division of the Biological Survey.

Accompanied by his assistant, Elmer Williams, Mr. Jewett arrived in Klamath Falls this afternoon on his way back to Portland from Lakeview.

"The predatory animal situation looks more favorable this year than ever before," he said. "There have been fewer complaints of coyotes, than ever before."

No change in the control work of Klamath will be instituted, Mr. Jewett said. Government Trapper Gubser who is at present working on ground squirrel control work, will soon be transferred to predatory animal control work.
