MORE BARBARITY OUTLAWED

The international arms conference at Geneva has put deadly disease germs on the list of prohibited weapons, after outlawing poison gas.

This is good news, even though the vote at Geneva is not final, and though ratification by all the powers represented there would not bind the unrepresented powers, and though some nation assenting to this principle in time of peace might change its mind, as nations have done before about war methods, when actually engaged in a life-and-death struggle.

Poison gas should go. Deadly bacteria should go. Supplies of either on hand, for military purposes, should be sunk in the depths of the sea, as our surplus gas was after the war, if it is not too cruel to the fishes. Various other types of war material, the latest and most diabolical engineering of science for wiping out human life by wholesale, should be discarded as far as can be done by the solemn pledges of the civilized nations.

Pious talk of "abolishing war by making warfare more horrible" has been proved tommyrot. Horrible ways of killing men, women and children did not prevent the biggest and worst wars, and will not prevent a bigger one if the professional fighters go ahead arm-in-arm with the scientists.

It will help much to obtain these pledges against the most revolting methods of salughter, and thus gain a foothold in building up a world sentiment that will keep them from military use. It will help more if a concerted effort is made to eliminate the poison gas of race hatred and the disease germs of international contempt, suspicion and fear.

It is now discovered that the Father of His Country, he who was "First in War, First in Peace and First in the Hearts of His Countrymen," was also first among real estate advertisers. The San Diego, California, real estate board has had made a lot of copies of an "ad" found in the issue of August 20, 1773, of the Maryland Journal and Baltimore Advertiser. George Washington advertised 20,000 acres for sale thus:

"As these lands are among the first which have been surveyed in the part of the country in which they lie, it is almost needless to permise that one can exceed them in luxuriance of soil, or convenience of situation, all of them lying upon the banks either of the Ohio or Kan-hawa, and abounding with fine fish and wild fowl of various kinds, as also in most excellent meadows, many of which (by the bountiful hand of nature) are, in their present state, almost fit for the scythe.

"From every part of these lands, water carriage is now had to Fort Pitt (now Pittsburgh) by an easy communication. It is thought the portage to Potowmackmay will be reduced within the compass of a few miles, to the great ease and convenience of settlers in transporting their produce to market.

"And it may not be amiss further to observe, that these must be among the most valuable lands from their contiguity to the seat of government, which more than probably will be fixed at the mouth of the Great Kan-hawa."

There you are! And fairly up-to-date. Rich soil, convenient location, suitable for the sports of hunting and fishing as well as for agriculture, convenient to markets for produce and contiguous to future thriving towns. Modern real estate advertising is scarcely more complete and roseate than this.

Miller, who was postmaster at Jacksonville for more than 20 years and Emil Britt, who was mayor of the city for as many years. Mrs. Cook and Miss Amelia Britt accompanied Mr. Miller and Mr. Britt, Mrs. Cook being editor of the Jacksonville Post, the only newspaper in the city which is the county seat.

Peter Britt, one of the oldest pioneers of the state, was the father of Emil Britt and the first photographer in the state of Oregon. STOCKMEN AGREE TO SALE PLAN

Cattlemen Here to Join California Association

Owners of more than 12,000 head of Klamath county cattle, numbering an even dozen, have already signed an agreement with the California Cattlemen's Association covering the sale of their stock until November 1 and more are expected to sign at meetings to be held today at Fort Klamath and tomorrow at Bly.

The meetings are being conducted by H. M. Rice, secretary of the association.

Local men who have so far signed include J. L. Beckley, D. E. Alexander, Chas. Drew, J. D. Grimes, J. L. High, R. Cheyne, F. P. Corpenling, F. C. Grohs, Buch Williams, O. L. Brown, J. Givan and F. L. Pope, W. C. Dalton and W. O. Brown were already members of the association.

The whole purpose of the association, according to Rice, is to bring about orderly marketing of stock and to prevent the sudden slump in prices that has prevailed under the old system, whereby ranchers sold their stock as the mood struck them or as they needed money.
