

Crater Lake Dokkie Band to Get Big Reception Here on July 18

"The Crater Lake Country," which includes Southern Oregon and northern California, is planning a unique publicity effort, which now has the backing of public officers, and the civic and other organizations of Siskiyou county, Calif., and of Douglas, Josephine, Jackson, Deschutes and Klamath counties, Oregon. This is nothing less than to send the Crater Lake Temple band, the famous musical unit of the D. O. K. K., to Providence, Rhode Island, in the month of August, 1925. The plan is to have the band accompanied by a representative who will have charge of the dates to be filled by the band in concert performances, and at the same time to distribute advertising matter of an enticing nature.

"America's Switzerland" needs only to be known to be loved. Its great cattle ranges, power plants, timber forests, fruit ranches and grain fields are the economic basis, which make it possible for real men and women to live here and have the glory of living in such a land. And when such people hear of the joys to be had in the game hunting, salmon, steel-head and trout fishing, and then know of the balm of our climate which makes it so easy to be at home in the big out-of-doors, they will not rest until they have come and

tasted of these blessings. After that—they will never be content until they belong to us. To put across this message, in a big, dignified and impressive way is the mission of the Crater Lake Temple band on this trip. Incidentally, they are making the trip count as a part of their contest in semi-annual field meet of the D. O. K. K. held this year on the Atlantic coast. In 1923 this band took second place in their first effort at the Portland meeting. The financing of the trip is made easier by the fact that a part of their expenses will be paid out of a fund raised for that purpose by the D. O. K. K. Imperial Palace (national organization.)

On July 18th there will be a big concert and a dance at Klamath Falls, the music for which will be furnished by this band, incidental to a ceremonial held here on that date. We have no doubt that the patronage given this concert and the dance following, by Klamath Falls people, will be a proper expression of the pride which Klamath county shares in the Crater Lake country.

The advertising of our resources and attractions, to the people of the eastern states, is a proper object of expenditure by our county board and our chamber of commerce. It

is so regarded in other parts of the state, and we trust will be so regarded here. Seldom can it be done to so good an advantage as it can be done in this particular enterprise. Our eastern cousins know that the west is big; they sometimes call it "wooly." But when they see it represented by a musical organization of the first rank, consisting of our own boys, resplendent in their beautiful uniforms and speaking the universal language of the world's best music, they will be more impressed by the message carried to them by our printed presentation of the facts and figures concerning our resources and opportunities for gaining the joy of living.

The men and the organizations of Klamath Falls will not soon again have such an opportunity to do the kind of advertising that counts, as is presented to them in the proposed eastern trip of the Crater Lake Temple band.

Riding Horses Now Ready at Diamond Lake

DIAMOND LAKE, Ore., July 10.—(Special to The Herald)—With the arrival of George Gilcrest and fourteen riding ponies, riding will be available at Diamond Lake for the rest of the summer. Mr. Gilcrest, who kept thirteen horses at the lake last summer, came in from Prineville with the horses and two bear dogs a few days ago and has established headquarters on the main road a few hundred yards north of the lodge.

As was the case last year, regular trips with Mr. Gilcrest as guide will be made to Mt. Baldy, on the west side of the lake, and to Mt. Thielsen on the east side of the lake. Other trips will be arranged by Mr. Gilcrest if desired by a party large enough to warrant the trip.

All the horses are in fine shape, having spent the winter near Prineville, where Mr. Gilcrest got them into condition for the rather trying three months' summer work. While not difficult to handle, the horses are all spirited and full of vigor.

The bear dogs, says Mr. Gilcrest, are go-getters and will ably assist anyone who wishes to go after bear meat. Last year after hunting season opened Mr. Gilcrest conducted several hunting trips into the less frequented parts of the Cascades.

Although the rush of the Fourth of July has subsided at the lake, a steady stream of tourists is coming into the lake.

Linfield College Not To Be Moved

PORTLAND, Ore., July 10.—Linfield college will remain in McMinnville, according to the resolution adopted by trustees of the institution late yesterday at the special meeting in White Temple. Cost of removal is too great in the opinion of the board, the sum of \$750,000 being deemed necessary for buildings and equipment, and \$500,000 additional for endowment purposes. Half that amount will suffice if the college remains where it is.

The trustees also voted to instruct the executive committee to launch a campaign to raise \$500,000 for new equipment.

Courts To Settle Fish Controversy

WASHINGTON, July 10, (AP)—The controversy between the government and the state of Oregon over the control of fishing rights on Sand Island at the mouth of the Columbia river probably would be fought in the courts. The issue has been brought to a head, it was announced today at the department of justice by the state fisheries board, issuing a lease to the Columbia River Packers Association despite a protest of the United States attorney on behalf of the government.

If the state's lease carries out its announced intention to begin at once the laying of fishing and casting nets, the action will constitute in the opinion of the department a "trespass" and the United States attorney has been instructed to commence injunction proceedings when such action is taken. The department's announcement added that leases of United States or other fishing sites on the island probably would cooperate with the government in the litigation. The fishing privileges for some time have been leased by the government but the state recently protested on the

ground that the island property, turned over to the war department years ago for military purposes, had not been used for such.
