Seek to Cancel Big Bond Issue

PORTLAND, Ore., Aug. 14.—Suit to cancel as invalid all the extra \$500,000 or more bonds reported to have been printed for the city of Oreno at the same time as the issue of \$50,000 bonds authorized for water works extension, was filed today by John S. Shute, bond dealer, in Forest Grove.

The same suit asks for a permanent restraining order against the defendant officials of Oreno, to prevent them from placing on the market any of the bonds printed in excess of the \$50,000 which was authorized, issued and finally placed in the hands of Shute to be marketed.

He asks for an order of the court declaring this issue of bonds valid. Shute has publicly offered to repurchase any of the Oreno bonds which he has sold. He declared that these bonds had been certified to him as valid by a responsible firm of Boston bond attorneys and by the officials of Oreno.

Investigators who have been looking into the Oreno bond situation have reported that they have found that about \$500,000 bonds were printed for the city. An earlier report given out by one of District Attorney Myers' investigators that the bonds printed totalled \$999,000 has not been verified.

Heavy Fire In Cascade Range

EUGENE, Ore., Aug. 14.—A forest fire covering 125 acres of logged-over land was reported near McKenzie Bridge in the Cascade National forest bounds yesterday evening. Green timber stands are on all sides of the fire. Thirty men were dispatched to combat the flames, and today the blaze was under control. Rain which fell last night for the first time in 61 days, aided the fire fighters. A 50-acre fire on Drift Creek, in the Siuslaw National forest, was checked when it reached green timber. A small fire near Belknap Springs in the Cascade forest was also checked.

BEEF SUGAR ACREAGE DECREASES EXCEPT IN RUSSIA

ROME.—Acreage devoted to beef sugar growing in European nations, producing three-quarters of the world's supply, decreased from 1,563,000 hectares in 1924 to 1,905,000 hectares in 1925, statistics gathered by the International Institute of Agriculture show.

The decrease was greatest in Spain, falling from 179,000 to 78,000, and in Italy, falling from 124,000 to 50,000, while Bulgaria which had 25,000 hectares planted in 1924 had none in 1925.

On the other hand, a large increase was reported from Russia where the acreage was augmented from 345,000 to 469,000 hectares.

NOTED WINDJAMMED ENDS CAREER AS FISHING BARGE

NEWPORT BEACH, Cal., — The final chapter in the romantic career of the three-masted schooner Muriel is written on the sands of the beach at the entrance of the Harbor here where the battered hulk of the craft once a proud figure in the Pacific coast commerce of windjammers days, lies a hopeless wreck.

Since her launching at Alameda, Cal., more than 20 years ago, the Muriel has established an enviable record among sailing ships on the seven seas, particularly in her fast passage while engaged in the copra trade in the South Sea Islands. She was once ranked with the finest and most safely sailing ships of the Pacific, and the waterfronts of the coast heard tales of romance and adventure woven about her by scores of grizzled seamen.
