"KLAMATH" OR "KLAMATH FALLS"?

Every resident of the city, new or old, should voice his or her choice over the proposal to change the name of Klamath Falls simply to Klamath. It is a matter which should be of interest to all.

There are arguments which can be advanced on both sides of the question. As Klamath Falls this city at the present time is obtaining more publicity along the coast than any other town of its size. Because of the present litter rail fight, the eyes of the country are now on this city.

If the name is shortened to "Klamath" will much of this publicity which came to Klamath Falls be lost by reason of the shorter name? Will it be confused with the town of Kalama in Washington? Will much of the charm and romance of the longer name be lost if the change to Klamath is made?

Klamath Falls was so named in the early days when there was a waterfall in Link river. But the coming of the power projects has obliterated the "falls" for all time, and the name "Klamath Falls" is a misnomer so far as actuality is concerned.

The Evening Herald believes the shorter name of Klamath to be preferable. Just as Spokane Falls was changed to Spokane, so, too, we believe, should Klamath Falls be shortened to Klamath. Spokane lost none of her early day prestige in the change. We do not believe that Klamath Falls will be the loser in any respect.

However, it is a matter for the people to decide for themselves. The Herald urges its readers to make their selection and send it to this office on the ballot printed on the front page of this paper, for the people themselves are the ones who will determine the issue.

LAKE HURST, N. J. Sept. 23. (AP)

Rigid tests of samples of the wreckage of the airship Shenandoah by the bureau of standards, Washington, was ordered today by the naval court of inquiry sitting here to determine whether there was structural weakness that might have led to the disaster that cost fourteen lives. Samples of the wreckage now here will be assembled in the order of their place in the ship for inspection by the court before the tests are made at Washington.

The court also directed the preparation of a blue print of the ship, giving the location of the various witnesses at the time they saw or heard the first indications of the breaking up of the craft, so as to ascertain whether it will be possible from the testimony to determine the location of the first serious failure of the structure.

PAN-EUROPEAN COMPETITION URGED AGAINST U. S. FILMS

BERLIN.—(AP)—Pointing out that it is useless for Europeans to compete with the United States in the motion picture film business, Dr. Roland Schacht, one of the leading German producers, advocates a joint European emulation of American film production. "Everyone for himself, but all for Europe," is the motto he recommends.

Dr. Schacht says American film producers persistently outbid European rivals and buy or erect agencies or theatres and have managed to acquire a controlling influence in many of the largest foreign companies. It is high time, he urges, for European producers of all countries to join forces in the matter of their productivity, rather than the marketing of their products.

BULGARIAN EMIGRANTS DUPED

SOFIA.—A number of arrests were made recently in which the persons were charged with issuing fraudulent certificates of emigration for Bulgarians to enter the United States.

The Bulgarian emigrants, numbering 42, were stranded in Bremen where they were cared for by the Bulgarian Legation in Berlin. The legation has sent a request to Sofia for 600,000 leva for the care of the victims.

August Big Month For Oakland Autos

Retail sales of Oakland Six cars for August—the month in which the smallest number of cars are sold at retail in the industry as a whole—were the highest for any month so far this year and the greatest for August in the history of the company. These sales were higher by 34 per cent than the best previous August.

The highest previous month's sale of Oakland cars this year was in April, when the spring demand was at its height.

Production at the factory is being stepped up to meet the demand for the new cars, with the result that production during the remaining months of this year will be at peak.

In a recent compilation made by the General Motors Corporation as to the percentage of deliveries of General Motors cars made to consumers in each month, August was the low month, with a percentage of 4.25.

Against this percentage of 4.25, Oakland sold in August 9 1/2 per cent of the anticipated year's production.

Two notable facts stand out in the sale of the new Oakland Sixes, according to W. R. Tracy, assistant director of sales, the more uniform division of deliveries between the four closed body types and the almost general uniformity of sales according to population throughout the country, showing general national-wide prosperity and national-wide popularity of the new Oakland Six.

Three Colorado horses, Major Henry Leonard's "Norfleet," Edward Pring's "Ranger," and Mark Hirsig's "Sandy," made the best time for the first day of the Colorado endurance ride which started this morning. Each finished the sixty mile grind in a few minutes less than 9 hours.

The pillow was found near the Southern Pacific tracks, in the mill district, indicating that either the man caught a train out of Medford or took the pillow and left it there merely as a blind.

The man was between 30 and 35 years old, it is said. Police have found no trace of him as yet.—Medford News.

FIRST PAINT IN 42 YEARS

In ye olden days your house, when painted, endured the coat forever; and now, as instanced by the house of Mrs. Hewett on Church street which is now being painted for the first time in 42 years by Alfred Boorse and Howard Torgler.

The house was built in 1883 and was considered a mansion at that time. It was erected by James W. Virtue, deceased, who established the first bank in Baker, at a cost of about \$12,000. It then occupied the block where St. Francis Academy stands and was purchased by the Sisters of St. Francis and used by them for several years for school purposes. It was removed to its present site to make room for the present academy building.—Morning Democrat.

A. C. JOY ELECTED

Appointment of A. C. Joy of Ashland as crop observer in Jackson county for the Soars-Roebuck Agricultural Foundation Index, is announced from Chicago by P. V. Ewing, director of research for the foundation and editor of the Index. He will form a link in the nationwide chain of county agricultural observers elected because of his first-hand knowledge of farming conditions and his ability to observe these and intelligently interpret them.

The index, to which the observer will contribute from this county, is a compilation of the monthly reports of 3650 observers in every section of the country, and this number is being added to steadily. All the observers are practical, thinking farm-minded men, each chosen because of the opportunities he has to observe the needs of agriculture in his own locality and for his ability to apply economic principles to current farm problems. As a group they represent a cross-section of the thoughts that the man in the furrow is thinking, and their joint analysis of existing agricultural conditions, as expressed in the Index, is considered a forward step in helping agriculture help itself.—Medford Tribune.

MOTHER AND SON

Charged with contributing to the delinquency of a minor, complaints have been sworn out for Roland Cruzan, 17, and his mother, Janie L. Cruzan. It is charged that the mother by persuasion committed an act that would manifestly cause delinquency of a minor girl. The alleged crime is said to have been committed July 10 last. Loretta Pursell, 15, of West Springfield, is the complainant in the case.

The case is to be tried in the county court before Judge C. P.

Barnard. The justice court has no jurisdiction and it will be a month before the circuit court convenes and to prevent delay the case is taken directly to the county court, according to announcement at the office of the district attorney.

This is the third time in more than five years as county judge that a criminal case has been tried before Judge Barnard. Under the law the defendants have right to a jury before Judge Barnard the same as in justice or circuit court.—Eugene Guard.

TO SEND DELEGATES

A delegate to the interstate commerce commission hearing in Portland on October 5, when the east-west rail plan and the Southern Pacific's Klamath Falls project will be considered, will be appointed from Coos bay at a meeting of the directors and railroad committees of the North Bend and Marshfield Chambers of Commerce in Hotel North Bend tomorrow. It was indicated today.—Marshfield News.

NEW GUARD TOWER

The work of erecting a new guard tower at the Oregon state penitentiary is now under way. The tower will be located near the front gate and will be outside of the prison walls. The institution arsenal will be housed in the tower.

Other improvements contemplated include the elimination of steps leading from the prison yard to the guard posts, installation of wire entanglements above the cells and an alarm system to be used in event of breaks or other serious disturbances within the institution walls. The improvements are being made with prison labor and materials.—Salem Statesman.

GET NEW TEACHERS

Two new teachers were added to the faculty of the Bend schools today. These teachers are Miss Ethel Jacobson, who takes the place left vacant through the resignation of Miss Jennie Erickson, and Miss Clara Scheulens in charge of one of the beginning classes at Kenwood, an overflow from the other beginning classes. Miss Jacobson, a graduate from the Cheney normal in Washington, is teaching one of the fifth grade classes at Kenwood.—Bend Bulletin.

STEWART'S WASHINGTON LETTER

WASHINGTON.—The "automobile poor"—people who have a flivver and nothing else—came in for their share of consideration before the National Conference of Catholic Charities in Washington recently.

Plenty of families—whole families—spend all their time wandering aimlessly around the country in their cars, with no other home, living on handouts of food and traveling on handouts of gasolines, Miss Louise McGuire, of the Catholic Service School said.

Some of these folk stop occasionally, Miss McGuire added, while the head of the family does a little work, but many of them are constantly on the go.

At best the father of a family of "auto tramps" doesn't get much of a job, for he won't stay by it. The vagabond instinct is too strong in him and his dependents. As soon as he's earned a few dollars they're on their way.

This new kind of gypsies is so recently developed that we hardly realize we have it with us and it is almost entirely unstudied as yet.

Probably Miss McGuire, whose attention was attracted to it through concern for the future of children growing up such utter vagrants, is the best authority relative to the breed. Without going into figures, for no statistics are available, she declares it numerous and increasing—a grave problem soon to be met.

The Treasury Department, which keeps hammering away on the idea of the fatality of federal tax reduction if state and local taxation is to continue to increase, has figures to prove how serious the situation is.

Three years ago, when federal taxes were higher than they are now and other taxes were not so high, of all taxes collected in the country the central government took 59 per cent and state and local governments 41. Last year the federal government took 28 per cent and

state and local governments 72.

This, according to treasury officials, is partly because federal taxes have been coming down but it is much more because state and local taxes have been moving up.

Of course, the state and local figures are an average—some parts of the country are worse than others, but those where there hasn't been an advance are few and far between.

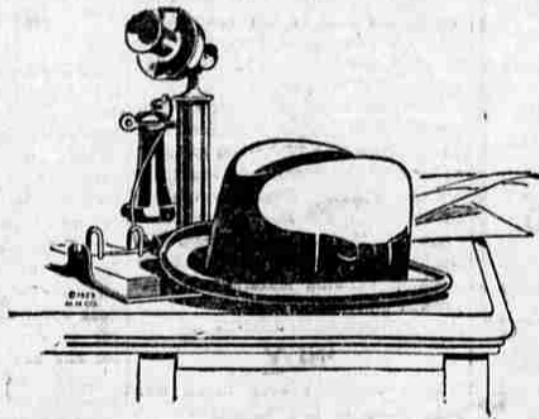
