and angry words were exchanged. Struck With Fist "I hit him with my fist when I thought he was trying to break up my home," was Howard's plea from the time of his arrest after the death of Vaughn until the jury voted him not guilty on the third ballot after a brief deliberation yesterday afternoon. District Attorney Charles E. Johnson, who prosecuted the case, held to the theory that the blow had been so terrific that it must have been inflicted with a club and two pieces of an oak club were introduced by the state as the weapon that caused the fatality. J. P. McNamara, who conducted the defense, held that friends of Vaughn's had planted the club near the scene of the trouble after a preliminary search of the scene had failed to bring to light any deadly weapon.

Sensational Trial Mrs. Austin's appearance on the stand and the story she told between sobs, was, by far, the sensation of the otherwise drab trial, even Howard's appearance on the stand failed to thrill the audience. Mrs. Austin testified that 17 years ago when her husband became insane and she was left with her babies to care for, Howard came into her life and for the years to come he treated her and the children with kindness and that it became the custom for her to be known as Mrs. Howard until she had fairly forgotten her initial identity. Common-Law Wife During those 17 years, Mrs. Austin said, she had been a faithful companion to Howard although Vaughn, in later years, had offered her repeated attentions and had on numerous occasions threatened the life of Howard. Mrs. Austin declared that her feelings are so warm toward Howard that when she secretly married a man named Austin a month before the final trouble with Vaughn, she did not have the time to tell him of her defection. "My life has been filled with trouble," sobbed Mrs. Austin, an austere and pallid woman of calm demeanor. "My father was a drunkard and I knew of nothing but trouble in his childhood; my husband became insane and I have often known hunger, and sorrow and disappointment."

No Emotion Howard was unemotional. He told in a monotone of the trouble with Vaughn and "I hit him with my fist, that's all," he concluded. Throughout the progress of the trial, he scarcely stirred himself, except when his counsel leaned toward him to ask a guiding question. The jury returned the verdict and he looked quietly at them. His mother cried. An hour later, Howard showed his first sign of emotion. He thanked a jurymen when he met him on Miner street for the verdict. Then he shrugged his shoulders and walked on.
