been guilty of "criminal negligence"—one of the accusations which led to his trial.

The court and counsel stood as the first woman to testify in the case took the stand and was sworn. She was nervous and plainly weak and weary from illness and the trying experience of recent weeks. She answered in a tremulous voice the preliminary questions put to qualify her as a witness.

Tells About Letter

Mrs. Lansdowne testified that the letter "from Captain Foley" was given her by Mrs. George W. Steele Jr., wife of Captain Steele of the navy, who is commander of the Lake Hurst air station, and of the dirigible Los Angeles.

The witness said she could not produce the letter because she had destroyed it.

Colonel Sherman Moreland, the prosecutor, objected when Mr. Reid asked the witness what was in the communication she destroyed.

The defense attorney said he asked the question because Colonel Mitchell had charged that the navy would "whitewash the Shenandoah catastrophe" and he wanted to prove that charge.

Testimony Admitted

The court, after some discussion as to the admissibility of Mrs. Lansdowne's testimony, directed her to answer the question.

"The letter said," Mrs. Lansdowne continued, "that my husband regarded the Shenandoah as a man of war and had not cared to take it on flights of a political nature—being always ready to take the Shenandoah on a military mission.

"It said also that I was willing to have the naval court, as a competent authority to take charge of the investigation."

"Was that statement true or false?"

"False."

"How was it false?"

"It was an insult to my husband's memory."

CORN CROP ESTIMATE

WASHINGTON, Nov. 12. —(AP)—This year's corn crop was placed at 3,013,390,000 bushels in a preliminary estimate issued today by the department of agriculture in its November crop report. A month ago 2,918,000,000 bushels were indicated.

Last year's crop was 2,436,513,000 bushels.
