A CASE OF REAL JUSTICE

If circuit judges throughout the state would display the same courage and good judgment as that shown during recent months by Circuit Judge Charles M. Thomas of Jackson county, we venture the prediction that moonshining would soon become a lost art in this commonwealth.

News dispatches today stated that Judge Thomas had sentenced a convicted moonshiner to five years' imprisonment in the state penitentiary. This is the maximum allowed by the laws of Oregon. Others who have dealt in illicit liquor in and around Medford are now serving prison terms at Salem because Judge Thomas is following both the spirit and the letter of the law.

The chief reason why there is a general disregard of the liquor laws both in Oregon and elsewhere is because the courts almost without exception have been far too lenient. Influential friends, small town politics, tedious delays and other baneful influences have permitted the violators of liquor laws to escape punishment too easily.

The moonshiner, the bootlegger and the hi-jacker fear jail or prison terms. Imposition of fines means but little to them. They smile—a little wryly, perhaps—but pay up and renew their illicit operations.

But jail and prison terms have a salutary effect. Five years in state's prison is a long time to serve. The average citizen will say unthinkingly that it is too much for a moonshiner. But if the judges throughout the state will follow the example set by Judge Thomas, the men who manufacture this death-dealing poison will soon turn to safer pursuits, and respect for our liquor laws will eventually reach par.

COOPERATIVE MARKETING LEGISLATION

One of the items in the president's program for legislation by the congress to meet next month is said to be the establishment of a system of co-operative marketing for farmers and adoption of "other measures of farm relief." It is the president's idea, according to the dispatches from Washington, that the cooperative marketing system shall be provided along the lines recommended by the agricultural commission of last year.

There was a good deal of objection by farmers themselves to the plan set out by the agricultural commission, on the ground that the machinery proposed would be too much hedged about with government red tape and restrictions. This is an objection of which due recognition ought to be taken when the work of drafting the proposed legislation begins. What that legislation needs to do is to set up the machinery and point the way for the farmers to follow and then leave them free to work out their own prosperity in their own way.—Eugene Guard.

KIP TESTIFIES ABOUT ROMANCE

Young Rhinelander Admits He Was in Love With Colored House Maid

WHITE PLAINS, N. Y., Nov. 19.—(AP)—Counsel for Alice Beatrice Jones, negro wife of Leonard Kip Rhinelander, wealthy member of an old Huguenot family, who is seeking annulment of their marriage today, began an attempt to prove that the youth was perfectly normal mentally and physically and was not mentally deficient as intimated by his own lawyers.

"You were a perfectly human fellow, weren't you?" asked Lee Parsons Davis of defense counsel at the resumption of cross examination this morning.

"Yes," said Rhinelander. Mr. Davis brought out that Leonard graduated at the head of his class at the ranch school in Arizona, that he was the editor of the school paper the "Yaak" and that he had been a frequent contributor of articles and editorials to the paper.

Shifting again to the color question, Mr. Davis asked Rhinelander about his first meeting with Alice and her sister, Grace, in 1921, bringing out that Leonard had no suspicions as to their color. Rhinelander admitted that even now he could not see traces of negro blood in the Jones family.

"When you first saw Alice," asked Mr. Davis, "was there any indication in your mind that there was negro blood there?"

"No," responded the witness. "Now that you know there is colored blood in the Jones family, do you see traces of it?"

"No."
There is a possibility that Philip Rhinelander, Leonard's father, who tried to break up the friendship of his son for the negro housemaid, will testify. Asked whether the elder Rhinelander would take the stand, Isaac N. Mills, counsel for the plaintiff said:
"Wait until we come to that."

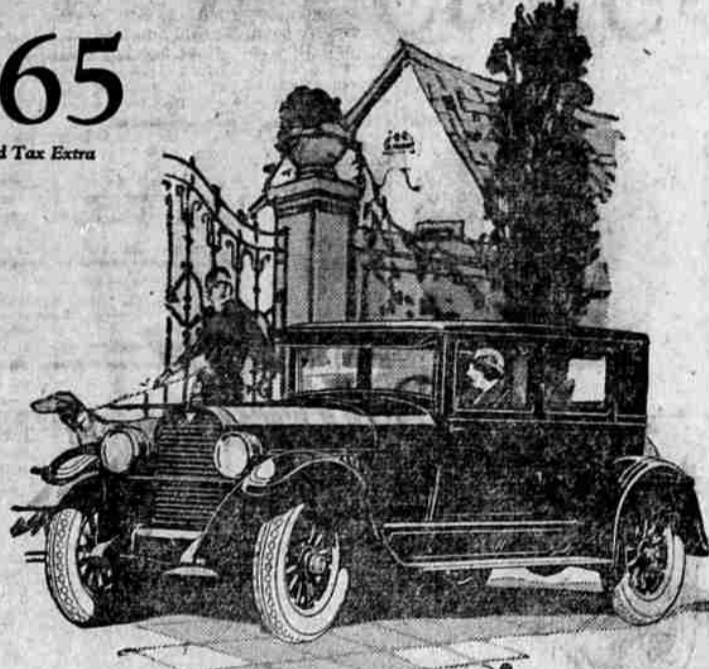
