MARRYING RICH GIRLS

A considerable number of men have it in the back of their minds that it will be advisable for them to marry rich girls. So before making any offers, they investigate the financial prospects of their proposed bride. Such an aim is justified by some, who claim that an average of the people who have wealth are able to command better education for their children and give them more advantages, so that even apart from the money they have, such girls are specially equipped for any form of activity. There are many things however that money can not buy. Many of the families that have little money are thus lacking because they thought that certain things are better and finer than money. They have devoted themselves to culture and intelligence and public service, and they have produced children of a very high type. Young men who turn down a girl from such a home merely because she has no checkbook, are likely to make a very serious mistake. If a young man forms a genuine attachment to a fine girl of wealth, he may well marry her if he can get her. Many of these girls who have had every advantage have come out unspoiled and are wholly admirable. But many of them are not practical, and some have become so accustomed to luxury that they are helpless and sometimes ill tempered without it. Such ones are a burden for a young fellow to carry. There are many who will say it is good policy for people to marry in somewhat the same social and financial circumstances that they have always been used to. The chances of conflicting tastes and desires are then reduced to a minimum. But love has bridged many chasms and where that exists all philosophies are disproved. But when marriage is determined according to mercenary motives, the results are usually disappointing.

SAVING CHRISTMAS TREES

The United States Forest Service has given its blessing so to speak, to the cutting of Christmas trees. Its chief reason for endorsing the custom is that the total number used is comparatively small. Roughly estimated, 6,000,000 evergreens constitute the yearly cut for holiday purposes. They could easily be produced on 6,000 acres of land, by nursery methods. Several times that many trees are consumed annually in the manufacture of toothpicks; and who the Forest Service seems to inquire, is campaigning against that kind of wood consumption? Also, 6,000 acres cleared of evergreens is a mere nothing compared with 14,000,000 acres annually denuded by forest fires.

All of which may be true, but does not appear to justify the ruthless destruction of evergreens every December for the holidays. If the area cut annually for this purpose were promptly replanted, Christmas trees would eventually become a crop, regularly and happily harvested without depleting the forests. Also, if care and skill were always used in gleaning the holiday trees from the woods, so that no trees were cut or injured except those that were later actually used, the forest loss would be negligible.

One can be heartily in favor of the joy-giving Christmas tree and still work earnestly to protect the evergreen supply. Have your gaily-adorned tree next month and enjoy it, but do your part next summer to prevent forest fires, and do your part to promote reforestation by planting a few living Christmas trees in your yard or on your farm.

TO PERFECT CHAPTER

Final organization of the local chapter of the Isaac Walton League of America will be perfected at a meeting during the first part of December. A letter has been received from the state game warden, E. F. Averill, stating that he will be here about December 8, and it is probable that the meeting will be held during his visit.

The charter of the Grants Pass chapter has been received and will be signed by all charter members on the night of the meeting. Those who desire to join may attend the banquet, at which it is hoped ducks and geese may be secured. The election of permanent officers will take place at this meeting.—Grants Pass Courier.

SCHOOL ARRANGED

Farmers of Josephine county are to be asked to adopt business methods in the keeping of farm accounts and in this connection a farm management school will be held at the courthouse on December 15, at 10 o'clock, at which all interested farmers are urged to be present. An effort will be made to find if there is

any particular adjustments in the organization of county farms which can be made to increase incomes.

The banks, through Sam H. Baker and R. K. Hackett, cashiers of the Grants Pass and Josephine and the First National, are cooperating and will invite a number of interested farmers to take part. It is hoped that a class of at least 15 can be secured, but it will not be limited to this number if more are interested. This farm account system is one of the major projects of the Oregon Bankers' association.—Grants Pass Courier.

PETITIONS ARE READY

Petitions for the formation of a Coos bay water district will be completed today and their circulation will begin within a few days. J. T. Brand, chairman of the committee which made up the petitions, announced this afternoon.

The petitions ask the state of Oregon for permission to form a water district that will include Marshfield, North Bend, Eastside, Englewood, Banker Hill and Millington. When enough signatures are obtained the district will be formed and a board of commissioners elected whose duty it will be to find some means of improving the present water supply and operating a company to furnish water throughout the district.

Circulation of the petitions will probably begin next Tuesday at a meeting under auspices of the Coos bay chamber of commerce.—Marshfield News.

PIONEER PASSES AWAY

A. S. Ireland, of Olalla, member of a pioneer family of Douglas county, passed away at the hospital at Marshfield this morning at 1 o'clock, following an illness of the past week.

Mr. Ireland, who had been in poor health for some time, had grown considerably worse when he was taken to the coast hospital, suffering with heart disease and stomach trouble. He was born at Olalla, where he spent practically all his life, except for a short time when he served as supervising warden in the forest service at Prineville. Upon the death of his father, who was a prominent rancher of the Olalla district, Mr. Ireland fell heir to the property and resided on the farm practically all of his life. He was 53 years of age at the time of death. Recently he had been working as deputy county assessor in his district. He was a member of the Odd Fellows lodge and a man of fine character, during his residence in the county making many fast friends.

Surviving him are a wife, and seven children, Doris Ireland, of Brockway, Irving and Keith Ireland, of Olalla, and Mrs. J. J. Lubke, of this city, Mrs. Merle Carter of Portland, Mrs. Dave Radcliff and Mrs. L. Hinkley of Marshfield. He also leaves a sister, Mrs. Roy Giles of

Bandon, and five brothers, C. Ireland and Will Ireland, of Marshfield, Henry Ireland, of Olalla, Homer Ireland of San Francisco and Asher Ireland, of Portland. The family left today for Marshfield, where the funeral will be held at 1:30 o'clock Sunday afternoon, burial to follow at the cemetery there.—Roseburg News.

WASHINGTON. — Congressman Davey of Ohio is mild of manner, but he has nerve.

Otherwise he never would have dared to announce his authorship of a bill to suspend all civil service rules for two years, that President Coolidge may separate 100,000 to 200,000 federal employes from half a billion dollars' worth of jobs.

Davey says himself that his bill, if passed, "will, for a limited period, give more power to the president (a Republican president and Davey's a Democrat) in time of peace than has been exercised by any war president."

Politicians know very well that it's risky to fire public servants, and the more any administration fires, the riskier it is. Still, the leaders would be inclined to take that risk at present, in the interest of a big saving, which would please the country even if it did create a good many sore heads.

But civil service rules stand in the way of much firing.

Suspending them doubtless has occurred to the administration folk long before now. Yet how could they take the initiative? Their motive would be accused of attempting a general clean-out, in order to get their own henchmen in.

Now Congressman Davey, a Democrat, steps into the breach.

His bill unquestionably is a genuine economy measure. The government's executive personnel ought to be cut down. If the administration is as nervous as Davey the bill will get its support (if so, it will be odd to see a Republican administration backing a Democratic congressman's bill) but it will be hard fought, too.

It's noteworthy that the first broadside against it comes from one of Davey's fellow Democrats, Congressman Black of New York.

NEW YORK — Wilhelm Giesecke, who once fought against Uncle Sam as a member of a U. boat crew, is now going to fight for him if necessary, having joined the infantry at Governor's Island.
