## WE APPRECIATE IT

The Evening Herald is very appreciative of the resolutions adopted by the Woolgrowers' Association, in which we are thanked for what little we have done in behalf of the people of the county. They were not published because it has always been the rule of this paper that nothing laudatory of the editor should be printed and since the resolutions contained references to us personally, as well as the Evening Herald and The Klamath Sun, publication was withheld. However, we are going to deviate from that rule in this instance, because the Klamath News has sought to twist the resolutions to serve its purpose in attacking A. M. Thomas, secretary of the Klamath Irrigation district. At the same time we wish to say to the Woolgrowers Association that we are glad to know that we have merited their approbation and support and to assure them that we shall ever try to hold that confidence by pursuing a course of unswerving loyalty to the interests of the people of this county. The resolutions follow:

WHEREAS, We are informed that E. J. Murray, The Evening Herald and The Klamath Sun have incurred the vindictive hostility of certain corporations, the corporation mouthpiece, The Klamath News, and a small group of their sycophants, which includes not more than one or two business houses of Klamath Falls; therefore,

BE IT RESOLVED, By the Klamath Woolgrowers' association, in regular meeting assembled, that we pledge our support to Mr. E. J. Murray, The Evening Herald and The Klamath Sun, and shall withhold our patronage from all the business houses that make war upon them, because they have stood, and stand, for the best development of the resources of the Klamath Basin and a square deal for the farmers; and

BE IT FURTHER RESOLVED, That we inform our friends, the business men of Klamath Falls, not to expect business from us as a result of advertising in the above mentioned corporation mouthpiece; and

BE IT FURTHER RESOLVED, That we take this means of extending our thanks to Mr. E. J. Murray and the Evening Herald for their unselfish and fearless devotion to the cause of the people of this county and that he hereby publicly acknowledge our obligation to Mr. Murray for the constant assistance he has freely given us without compensation or expectation and to his own financial loss.

We also wish, at this time, to express our appreciation for the resolution passed by the directors of the Klamath Irrigation district, asking that the directors of the district pass resolutions of appreciation for what we have done in behalf of the farmers of the Klamath project. These sentiments of cordial good will are so unusual and so unexpected that we fail to find words to express our feelings, but we wish to assure our friends they shall ever be treasured in our memory and be a guiding light in whatever efforts we may put forth in the future for the greater development of Klamath county.

## Scout Leaders Attend Dinner

Klamath Falls members of the Scout Leaders Round Table met at the chamber of commerce last evening for their second meeting since organization. Prior to the meeting the members enjoyed a dinner at the Marshall House.

Frank Moser, president of the organization, presided at the meeting with business matters of interest being discussed. The constitution which was written by L. E. Banker, Edward Livingstone and Arthur Grubb was unanimously adopted.

Scout Executive E. O. Nord told of the splendid meeting of the P. L. conference in Portland after which the members finished their tests 100 per cent and took up the study of the Patrol Method which was discussed in detail, as were the programs, scout games and the recreational methods of teaching scouting to boys.

Second class tests were gone into in detail and it was decided to have a corps of trained men belonging to the round table to go from troop to troop and specialize on various subjects. Howard Barnhill was selected as signalling expert, to serve with William Mueller, Howard Metcalf was selected as first aid instructor, and Dr. Paul Sharp as first aid instructor. These men will visit different troops and assist them in first and second class work involving these tests. L. E. Banker, deputy commissioner, gave a talk on drill and discipline, which invoked considerable discussion. After singing "Ivan" and giving the scout oath, the meeting was adjourned. The next meeting will be held the 15th of this month.

**STEWART'S WASHINGTON LETTER**

WASHINGTON. — How many Americans can tell who represents them in Congress? "Very few," answers A. D. Fairbairn, and he tells a story which sounds as if he knows what he's talking about.

Fairbairn is a Washingtonian who recently had occasion to take a trip through 15 of the 48 states, and in the course of this journey accident started him on an investigation into the extent of the average man's familiarity with political personalities.

"Amazing ignorance," is what he found. "In all walks of life," he reports.

The accident which started him? Well, while he was in Omaha it chanced that he needed to learn the name of the congressman from the second Nebraska district. Taking it for granted that almost any local voter could tell him, he asked one. To his surprise, the voter didn't know. He asked another. Neither did the second one know.

Curious by this time, Fairbairn kept on asking until he reached the 26th, a hotel clerk, "who," he says, "scratched his head, gave the matter about 3 minutes' thought and then found, to his keen delight, that he could name Judge W. G. Sears"—and Sears, by the way, is a congressman of more than average distinction. Not to know who he is, in Omaha, is something like not knowing who Calvin Coolidge is in Washington.

At that, the hotel clerk was unacquainted with Sears' politics.

His Omaha experience made such an impression on Fairbairn that he continued his questioning throughout the rest of his trip. It led to his discovery of the fact that "the Omaha incident was not unusual but typical."

It was the same way about senators. An FBI cabinet members, Fairbairn says he found hardly anybody who could name all of them correctly.
