Is It Home Talent?

Klamath Falls sends condolence to Portland because of her extraordinary crime record.

This city weeps with the metropolis on the Willamette because of the example she is setting to the smaller cities of the state.

It is said without contradiction that no one is safe in Portland at any time or in any district, for the night prowlers have invaded the exclusive section where private policemen are employed and business houses in the heart of the congested district are robbed at will.

Up here in Klamath our crimes may be many but they are usually small and deal largely with violation of the prohibition laws—crimes which cities like Portland have ceased to mention because they are so common. Here we still mention them and play them up, but as for major offenses the record of Klamath Falls is fine and we refuse to take a back seat for any other community where activity is on like it is here and where industry holds full sway.

Portland has ever been looked upon up and down the coast as the town where tight rein was held on everything, but it would seem those reins have loosened. The search they are making for the criminal heads will probably result in unearthing an array of local talent, who under the very hand of the supposed stern city, have developed their criminal bands to a high state of efficiency.

Klamath does not shout a lot about her purity, but taking everything in a broad way, Klamath is not a bad town by any means—probably not so bad as some of her petite neighbors who raise the sign board of extreme purification to a high and lofty position.

A Grand Old Name, But—

In ruling out the Armour Grain company from the Exchange charitableness for the old family name of Armour evidently prevented a chastisement of the recent management, which was no doubt deserved.

That the subject was dismissed with a slight rebuke by the exchange board is sufficient to convince the public that the Armour institution, when dabbling in grain, failed to keep up the good name which followed it for so many years in the commercial world.

When a firm owned largely by one family slips from the older heads who created it into possession of the younger generation too often, yes far too often, the younger ones cease to cherish and revere the name that stood for so much to the founders.

With the Armour routed from the grain exchange, with the rebuke delivered as it was, the world now knows that the custody of the Armour institution given to the younger generation has not been for the best.

further dealing with the Strahorn road, and Ralph Budd should be given sweeping orders to immediately build the Great Northern into Klamath Falls over Route D, which would mean Budd would build his own tracks from Bend to this city, giving him further rights to construct branch lines and feeders into the Sprague river country and to build such other branch lines as will develop this country and give it the rail competition which the Commission has repeatedly expressed itself as desiring for Southern Oregon.

The Southern Pacific is holding a gun to the head of the Interstate Commerce commission, making it as difficult as possible for other railroads to enter this territory, protracting the time as long as possible, and at the same time it repeatedly states it will do nothing so long as things are not determined.

It will be remembered in the original case the Southern Pacific asked to have Southern Oregon turned over to it—lock, stock and barrel. The Interstate Commerce commission refused to put such an interpretation on the Transportation Act. Now the Southern Pacific again makes the same issue with the Commission, saying it will not develop or expand so long as there is a threat of rail competition.

Will the Interstate Commerce commission stand by its original position?

Regulation Again

Evidently oil producers are like lumber manufacturers, they glut the market with their product and then suffer the pains which follow from lack of business. The latest thing to agitate is seen in the San Francisco Examiner for that newspaper is strongly advocating government regulation of both output and price of oil. It bases its argument on the fact that the oil belongs to the nation in reality. And, to carry that argument further does not everything belong to the nation in which we live. A boy raised in America belongs to Uncle Sam, and if he is the right kind of a boy he will always recognize that fact.

Referring back to the natural resources, and to follow the Examiner's theory, all products of the soil, all timber products and in fact everything used by society belongs to the nation, and should the nation see fit it could commandeer the output or regulate the output and also regulate prices of sale.

But let us warn the learned Examiner that too much governmental regulation has proven to be not only hazardous to individual effort, but it has not reacted in an economical way. We have all witnessed undertakings of the government that could have been done far more cheaply, more quickly, and a better job turned out by the individual.

Gigantic Business From Nothing

Many of us well remember when the vacant store room was rented by the "showman" and a moving picture machine placed therein. True, we saw pictures that moved. One of the old favorites was the fire department hurrying down the street. It was novel, to be sure, but few ever thought of the possibilities. The east had them first, then the middle west was invaded and finally the Pacific coast. Quickly they gained ground but with still few business men thinking that an industry of such gigantic size was growing up among us.

As an indication of its size today a deal has just been made for \$250,000,000 company which will link up coast theatres in the larger cities and put them under one management.

It is a huge business developed from practically nothing.

MRS. CHAPLIN WINS ALIMONY

Wife of Comedian
Awarded \$1500 Monthly
By Los Angeles Judge

LOS ANGELES, April 29. (A.P.)—The financial secrets of Charles Chaplin were paraded before the public today as his estranged wife, Lita Grey Chaplin, anticipated her first temporary alimony payment since filing her sensational divorce suit last January.

After Joseph M. Schenck, head of United Artists, the corporation through which Chaplin's pictures are distributed, testified at yesterday's alimony hearing that the gross income of Chaplin's last feature picture, "The Gold Rush" was \$2,225,000 to date, and that the film star had received 75 per cent of that amount, the superior court awarded her \$1500 a month alimony, retroactive from January 10 last.
