"A Bird in the Pan..."

Klamath wool growers have sold out their 1928 clip. Some well informed men are shaking their heads regretfully, holding that sheepmen should have held until later in the year. They point to tremendous losses of sheep in Australia and speculate on the anticipated rise in the wool market.

Whether these regrets are well founded we do not know—but we can understand the attitude of the Klamath sheepmen who, paying as low as 26 cents a pound last year, are offered 32 cents and as high as 33 1/4 cents right "off the bat" the next year. Wool growers now can look forward to a substantial profit; their worries over market fluctuations are behind them for another year. And, whatever may be said, there is always to consider that old adage, "a bird in the pan is worth two in the bush."

Outclassed But Not Outfought

Klamath American Legion basketball team was trounced Saturday night by the U. of O. Frosh quintet; Klamath County High school hoop stars were scuttled by the Ashland High basketballers Friday night. Two defeats, true, but defeats with silver linings. In both games the Klamath teams were within striking distance of victory almost up to the final whistle. The Legion five had the versatile University Frosh on the run in the third quarter; the young high school lads were on their toes in the Ashland game, always threatening.

Defeats? Yes, both of them; but the days when games with Klamath athletic teams were minor work-outs for invading schools, have been relegated to the past. Beaten or not, athletes of the state now realize that whatever may be their fate in a clash with a Klamath team, they will certainly know they have been in a battle when the final whistle blows.

Carlton's Magazine

For years and years a quiet unassuming man has been identified with the schools of this state. As assistant state superintendent of public instruction he filled an important place. Now he is editing the teachers' state magazine.

He is not a relative of Will Carlton, nor does he run Will Carlton's editorial entitled "Makin' an Editor Out o' Him" on his magazine's front page, but just the same Mr. Carlton is furnishing the Oregon teachers a magazine that is of great value. It is a pleasure to know that his effort is meeting with success as it should.

Strange how quickly these ducks sense the end of hunting season. Standing on Link River bridge you can hit a Hooded Merganser, a ruddy duck, a butter ball or blue bill with an apple core. The plan has had the acid test, for attempts have been encouraged by the White House to write a better plan and apparently none has been forthcoming. This congress must decide either for or against the McNary-Haugen farm relief measure.

cent from highway through the city fund. The paving will include Behn street which joins The Dallas-California highway at the city limits.

The Broad and Commercial street project will include 40-foot pavement. Pacific Terrace will be extended on the same plan as now exists, two strips of paving with a parking space in the middle. Portland street will be 16 feet wide.

"These four projects are believed to be of primary importance by the council," Mayor T. B. Waters said today. "We will waste no time in expediting the necessary legal preliminaries and hope to let the contracts early in the year in order to ensure the completion of this phase of the 1928 improvement program this year."

FROSH DEFEAT LEGIONNAIRES

In a game which was a give and take affair until the last quarter the University of Oregon freshmen team defeated the Klamath Falls Legionnaires in Legion memorial hall Saturday night, 44 to 25.

At the end of the third quarter the score of 25 to 23. Tired out from their great onslaught of the third quarter the Legionnaires were no match for their better-conditioned foes in the concluding period. The yearlings ran rampant for the last quarter and ran up their score to 44.

Olmstead and Wheeler were accused of having misappropriated \$796,415 of the bank's funds in alleged check kiting operations. Selection of a jury was expected to occupy the court this afternoon and most of tomorrow.

Price Ranges Up to 33 Cents; J. Koshland Company is Buyer

LAKEVIEW, Ore., Jan. 23.—The entire 1928 wool clip of the county has been contracted, with the purchase this week by Chas. Embach, representing J. Koshland & Company of Boston, of the Ben Daly, James Barry, Jr., and W. K. Verling clips at 33 1/2 cents. Other clips which sold at this price during the past week or more were those of P. C. Murphy, John L. O'Connor, Con C. Murphy, J. J. O'Keefe, Flynn & O'Keefe and P. J. O'Keefe, all of which were purchased by local representatives of Elsmann Brothers and J. Koshland & Company.

Several clips from the Silver Lake section, for hand delivery, including those of F. G. McBroom and Claude McCall, were also purchased during the past week at 33 cents by W. M. Marston of Boston.

Modoc Wool Cheaper.
The Modoc county wools were sold in a pool comprising about 100,000 fleeces early in December to the Alturas representative of Elsmann Brothers at 30 cents for Alturas delivery clips and 30 1/2 cents for clips delivered at Gerlach, Nevada.

Later in December a number of Lake county clips, including those of Denis Nolan, M. H. Barry, John M. Flynn, Con O'Connor, John Singleton, Wm. Sullivan, S. B. Chandler, G. W. Hardisty, Nate Wilcox, C. D. Arthur, J. M. Batchelder, Con Doody, F. M. Green, George Minton, J. D. Herford, D. T. Jones and a number of clips for Harney county delivery were sold at 32 cents to local representatives of Halliwell Jones & Donald, Elsmann Brothers, Walter Marston, E. H. Tyron and J. Koshland & company.

JUDGE CHANGES START FUND FOR TRIAL OF BRAD

LAKEVIEW, Ore., Jan. 23.—C. H. Brad, former proli "stool pigeon" who worked here and in Klamath county, was granted a change of venue to Jackson county recently by Circuit Judge O. M. Corkins. Brad is under two indictments here, one of which charges him with personating an officer and the other accuses him of aiding a felony.

Brad presented a petition alleging he could not get a fair trial by a jury of Lake county citizens and for that reason his case be transferred to some other county. He wanted it sent to Klamath county but the court refused to do it.
