A special committee will assign rooms to the visitors and no one need fear of accepting the guests offered, for they will be good people.

EDITORIALS FROM OVER THE NATION

A BUSINESS QUESTION.

Baltimore Sun: The report of the senate committee on postoffice and post roads, favoring restoration of the 1926 rates on second-class mail matter, is in conformity with the strongly urged argument that no less reduction would bring back to the government business that has been driven away by charges higher than the traffic can stand.

It is obvious that growth of second-class mail has fallen far short of what was anticipated. Potential business has expanded enormously but it has sought other avenues of transportation, a fact that seems to justify the contention that the government has imposed upon it much greater costs for handling than could fairly be allocated. Aside from the obstacles put in the way of interchange of information by the policy of the postoffice department, it is certainly worth a trial to discover whether large revenues can not be had by putting into effect rates that will attract business.

If congress fears a postal deficit, it should look to the free service it extends so generously. The mounting cost of this can not be permanently shored over upon paying users when they can find, as second-class mail has found, competitive services at lower cost.

TAXES NOT ALL PAID SATURDAY

"Just about \$100,000 shy," announced Deputy Sheriff Garrett Van Riper, in charge of the tax collection department of the sheriff's office, Saturday was the dead line in the tax collecting department after which interest is charged.

"All the big tax payers have met their obligations," continued Van Riper, "where the \$100,000 comes in is in Klamath Falls."

One per cent a month interest is charged on taxes for the first half year up to November 5; from that time forward one per cent monthly interest is charged on the entire year's taxes; on February 5, 1928, a two per cent is attached to delinquent taxes.

FIND BODY OF YOUNG TRAPPER

(Continued from page 1)

was referred to cowboys who had called at the cabin some time before, the young man told of how he was not anxious to leave when he could and then when he wanted to was unable to do so.

In part the letter read: "The morning I was all set to leave I snowed—snowed like hell and I could not make it. After the storm I tried to walk to Bly but I got off the trail and lost after walking all night, and I finally got back to the cabin with frozen feet. They were frozen so badly that I could not walk at all; in fact I had to crawl on all fours. I tried to get to the Richardson ranch by crawling on all fours but was simply unable to make it. And as you know, there is not much wood in the cabin, the only thing left for me to do is starve. I am without food now for three days and I am getting very weak. The end is not far off now. Under my pillow you will find a letter to mother. Please see that she gets it. Also mail the suitcase to the same address. In the pocket of my blazer you will find \$2, which I trust will be enough to pay the postage. I shall appreciate this, that is, as much as a dead man can appreciate anything."

Little is known of the young man other than that he came to the Bly country from Los Angeles last fall, driving an Oakland car. En route into the mountains to trap, he stopped at the Obenchain and Richardson ranches and after going back into the mountains, was out on two occasions to get supplies. He was stationed at the famous old Conrad cabin, known to cattlemen throughout the Bly country. The place has been headquarters for men driving cattle for many years.

While at times Mr. Richardson wondered what had become of the young man, little fear was held for his welfare until a letter addressed to the postmaster, T. E. Wallace, at Bly, was received from his brother, H. Goldberg, asking for information as to his whereabouts.

It was then that Richardson and Obenchain became alarmed for the young man, whom they had not seen since along about Thanksgiving time, and decided to make the trip back into the mountains.

"This was along in the middle of April and we were forced to turn back on account of the heavy snow, but awaited the first promising day and started out Sunday morning," Richardson stated. "We were forced to abandon the car, take snowshoes and hike into the timber where the cabin is situated." When we got back last night we were all nearly exhausted.

After going over the conditions with Richardson and Obenchain this morning, County Coroner Earl Whitlock decided to await word from the young man's mother as to what she wished done with his remains.

"It will be at least 10 days before it would be possible to get a team of horses into the deserted cabin to bring out the remains, and until that time I shall await the first opportunity to get in. I am told it would be useless to try to get in now," Mr. Whitlock stated today.

The young man was D. Goldberg and his remains were found in his lonely cabin yesterday by L. A. Richardson, Matt Obenchain and Frank Obenchain Jr.

Two letters written as he was slowly succumbing to starvation told of the suffering sustained by the California man. He related how he attempted to leave the cabin when the snow began to fall, how he lost the trail, how he wandered through the night in a blizzard, how his feet were frozen and how, finally, he crawled on hands and knees back to his cabin in which there was no food. One letter was written to his mother, Mrs. Ida Goldberg of southern California and the other addressed "Say Cowboy."

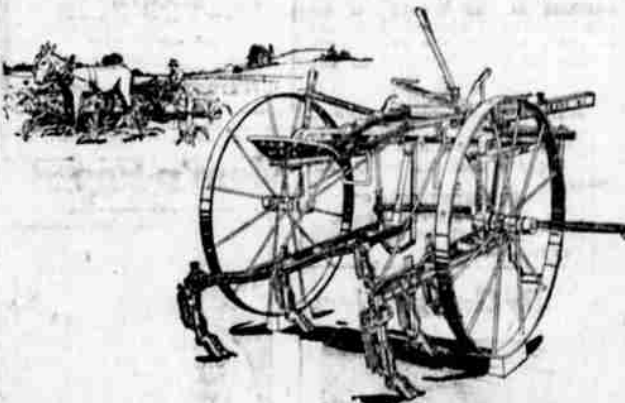
