PUZZLING PLAYS Baseball

Advancement of Runner.

When can a runner properly advance on a fly ball that is caught? Must he wait until the ball is firmly held by the fielder making the play or can he advance the moment the ball strikes the hands of the fielder? If a ball strikes the hand of one player, bounces out and is caught by another before it reaches the ground, does it make any difference in the advancement of the runner?

A baserunner has the right to advance on a fly ball that is caught the moment it strikes the hands of the fielder, provided he returns to his base and holds it until such a thing happens.

If it was necessary for the baserunner to hold his base until the ball was firmly held, players would make a practice of purposely juggling the ball and running with it at the same time, in order to lessen the runner's chance to advance.

This would place the runner at the mercy of the fielder. Thus the rule gives the runner the right to advance the moment the ball strikes the hands of the fielder making the play.

It makes no difference in the play if the ball bounces from the hands of one fielder and is recovered by the other before touching the ground.

The runner is within his rights in advancing the moment the ball strikes the hands of the first player making the play.

While at times it may seem that the runner should be made to hold his base until the actual completion of the play, such a procedure would offer him no protection and makes him an easy victim for trickery on the part of the fielder.

Doctor's Suicide Leaves Murder Mystery Unsolved

DETROIT, June 28.—When Dr. Frank R. Loomis took his own life recently by turning on the gas jets in his office, he bequeathed to the Detroit police one of the most puzzling mysteries they have ever had—a mystery that probably will remain forever unsolved.

The mystery is this: who killed Dr. Loomis' wife, Grace Burns Loomis, in the sun parlor of their home on the evening of February 22, 1927?

Dr. Loomis had been accused of the murder. He was arrested, brought to trial and acquitted a little less than a year ago.

Of course, there were those who shook their heads over that acquittal. "They couldn't actually prove anything on him, but—" That was the sort of comment one heard.

And when Dr. Loomis killed himself recently, leaving a note addressed to the police which said: "Within 24 hours an article will be published in a Detroit newspaper explaining this action on my part—until then please be patient with me." It was taken for granted that a death-bed confession would be forthcoming. But it was not.

Just before his death Dr. Loomis mailed the Detroit News a statement of the reasons for his suicide. In it he reiterated his innocence. He said that the police had "hounded" him; that gossip would not stop talking about him; that his professional practice had been ruined, and that he was tired of being pointed out as "the man they think killed his wife." So he was committing suicide.

The note, somehow sounded convincing. It didn't seem like the sort of note a murderer would write.

But it left the question—who did kill Mrs. Loomis? And the more the police study it, the farther do they get from a logical answer.

Mrs. Loomis' body was found on the floor of the sunroom of their home. She had been clubbed to death. The body was found by Dr. Loomis when he returned from a walk about 9 o'clock p. m.

All doors were locked. A sun-room window was broken; but it had been broken from the inside, pieces of the glass littering the lawn. Dr. Loomis said he had given his wife \$100 before going for a walk, and expressed the belief that some prowler had entered the house, killed her and

taken the money. Yet three valuable rings on her fingers were untouched. Furthermore, how did the murderer get in?

Dr. Loomis swore the sun-room shades were up when he left the house. Yet when Mrs. Loomis' body was found they were drawn. A telephone, upset, lay on the floor beside her. Dr. Loomis said he tried to call police when he found the body, but found the telephone out of order. And here the records of the telephone exchange bear his story out. For about 20 minutes that night the Loomis phone was reported out of commission.

The weapon that killed Mrs. Loomis was never found. The doctor told a coherent story which could not be broken down by cross-examination. The jury apparently found him worthy of belief. His friends insisted from the first that he was innocent.

And that is the way the case stands today. If Dr. Loomis killed her, would he not have admitted it in his last speech before going to his Maker? If a prowler did it, how did he get in the house?

Who killed Mrs. Grace Loomis? The Detroit police do not believe the question ever will be answered.

WIMBLEDON, England, June 29. (U. P.)—Three United States Tennis stars—George Lott, W. F. Coen, Jr., and Sidney Wood—were swept out of the men's singles today, leaving only Wm. T. Tilden and John Hennessey to carry on the campaign in the All-England Tennis Championships.

As if to warn the United States of the tremendous task it faces in attempting to wrest the Davis Cup from France, seven Frenchmen gained places in the last 17 of the men's singles.

Only Hennessey, who beat G. R. Sherwell of England, 6-4, 7-5, 6-2, and Tilden, who beat Baron de Kehring of Hungary, 6-2, 6-3, 6-1, remain to stem the conquering Gauls.

Rene La Coste, French ace, wore Lott down with his precise-

ion and beat the Chicago star, 6-1, 9-7, 6-8, 6-2. Pierre Landry Frenchman, eliminated Wood, 4-6, 6-1, 6-1, 8-6. H. W. Austin, Englishman, outscored Coen to win, 6-1, 9-7, 6-8, 6-2.

The gloom which cast its shadow over the United States in the men's singles extended to the women's singles when Miss Daphne Akhurst of Australia eliminated Miss Helen Jacobs, California girl, 6-8, 6-1.

The United States has three representatives left in the women's singles. Miss Helen Wills, Miss Penelope Anderson, and Miss Elizabeth Ryan. Miss Wills entered the last 16 by crushing Miss V. Gally of France, 6-0, 6-0.

Miss Wills and Hunter won their first round match in the mixed doubles from J. Kozeluh and Miss M. Slaney, 6-1, 6-2.
