

COUNCIL WILL SEEK PETITION ON U. S. CANAL

Reclamation Service Cold to Plea of Klamath Falls

Rebuffed by the United States Reclamation service in an attempt to secure much needed improvement of the United States irrigation canal within the city limits, the city administration is laying plans to carry the fight forward another step. It was revealed today by Mayor T. B. Watters.

Seepage from the canal has undermined paving and led to

the early breaking down of the new streets. The canal is recognized as a health menace, as a danger to automobile traffic and as a constant menace to children playing nearby.

The matter was taken up with United States Senator McNary, who immediately submitted the matter to the reclamation service. Reclamation engineers said that the seepage was a natural condition and that the canal had not contributed to the nuisance.

"That's where the matter stands today," said Mayor Watters. "Ours is the next move. The council will obtain petitions from residents who are in a position to know the facts, and with other testimony, will submit them to Senator McNary, so he may push the matter for us."

"The reclamation service wants to be shown. We propose to do it."

County Council, Boy Scouts of America. It will open July 23rd and run for a period of two or three weeks. Scout Executive H. Blevens will be in charge of the camp and J. W. Scoggins, Scoutmaster at Merrill, will be Assistant Director. Merle Swanson, Assistant Scoutmaster of a troop in Pasadena, Calif., will be Moral Officer. Names of other officers will be announced later.

The summer camp offers to every parent an opportunity to give their boy the best possible vacation at the lowest possible cost. The fee is \$7.00 for one week or \$13.00 for two weeks, which amount covers only the cost of the food. The cook, transportation and other incidentals are paid for out of the Council fund. The scouts are just as safe in the camp as at home. The smallest boy in camp wades out as far as he can into the lake.

An enclosure is then made by chaining logs together and all boys who cannot swim upon entering camp are compelled to stay in this enclosure until they are competent swimmers. The "Buddy System" is also used with all the boys in camp. Each boy has a buddy and neither one can go into the water or come out of it until his buddy does too, which keeps a close check on the boys. Competent swimmers are in charge of the boys during all swimming periods and the officers accompany the boys on all boat trips. No boy left camp last year without being able to swim at least fifty yards. Fishing is another sport greatly enjoyed, also hikes, especially the overnight hike to Mount Pitt. A program of great educational val-

ue is a part of every well organized scout camp. Scout tests are passed under competent instructors. There are camp fire programs with stunts, games, etc., every night.

Parents may visit their boys at the camp on Wednesdays and Sundays.
