The "Closed Season" Sport

Ducks, pheasant and quail, supposedly secure in closed season, are being killed by the hundreds from the roadside. The following scene has become a common one to farmers:

An automobile idling up the road, one man driving and his companion sitting alert next to him with a loaded shotgun across his knee; suddenly the car stops, the man with the gun leaps out of the car, opens fire on a flock of game birds, often peppering the flanks of livestock in the field; quickly scaling the farmer's fence, the law violator sprints out into the field, seizes his quarry, runs back to his car and, in a trice, is speeding away.

Recently young pheasants, just released from the state game farm, were planted on a Klamath farm. They were just like so many half-grown chickens, hardly able to fly. One day a "closed season sport" slipped up to the edge of a field, shot into a flock of the young birds, scooped the dead birds up and made his get-away.

This newspaper believes that such persons should be apprehended and vigorously prosecuted. Unfortunately, this state or county has not the means to hire men to patrol the county roads for this purpose, and therefore it is up to the farmer to get the number of the car and telephone it to the home of District Game Warden M. J. Barnes. He will do the rest.

The Isolation Hospital

Tonight, once again, the city-county isolation hospital question comes before the city council and the county court, this time to consider the last bids for the needful public project.

Since this project was conceived, there has been interminable delay. At first plans were not suitable; then the specifications called for a building too expensive; and finally, the council believes the heating plant too costly for the size of the building.

Perhaps this delay has, in part at least, been justified, but we do hope that something definite will be done tonight so that a very real public service can be accomplished. We do not believe in heckling public officials, but we do insist upon a reasonable celerity in dispatching public business.

It might be well to remind the city council and county court that this isolation hospital project has been "simmering" for over a year; that the spring and summer have passed and ground not yet broken for the new building; and that public criticism will be outspoken if this county enters another winter without proper facilities to take care of citizens suffering from contagious disease and unable to remain in a private residence.

Seven Weeks Late

The Kennedy sewer plans for the first unit of the \$300,000 sewer project finally arrived at the city council table—just seven weeks late.

Had they arrived on specified time, the first unit of the project, which includes laying a trunk line sewer from Mills Addition to Link river bridge, would have been one month under way today. Instead, it is more than likely that ground will not be broken on the municipal project until next spring.

So the delay of seven weeks means, in effect, a delay of seven months.

The city ratified the sewer bonds last February because it sincerely believed that existing sewage conditions constituted a grave menace which should be immediately corrected. Official assurance was given that the project would be well under way this year and completed early in 1929.

Is it any wonder that observant tax payers are voicing criticism of Mr. C. C. Kennedy's delay, and also of the administration to whom Mr. Kennedy is responsible?

will be acceptable to both sides in the dispute.

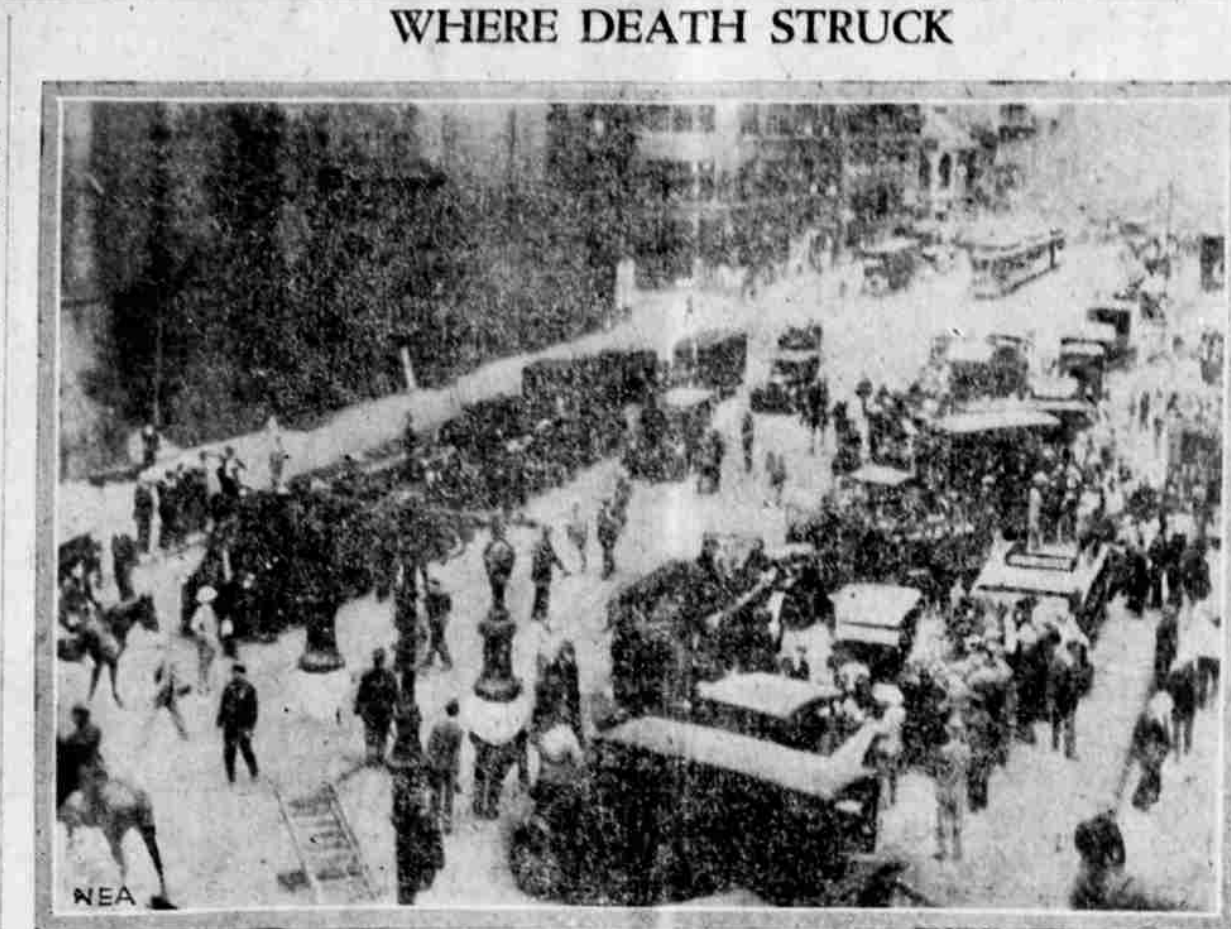
The plan would affect 70,000 employees on 80 railroads involving 98 percent of the mileage west of Chicago.

The original demands of the labor organizations involved a pay increase ranging from 10 percent for yardmen to 18 percent for conductors and other

trainmen. The railways offered a pay increase amounting to approximately 7 1/2 percent on condition that certain working rules be dropped. The increase was acceptable but the employees refused to give up the rules which they maintained were more important than the pay question.

The board of mediation has had the matter under discussion with the parties in the dispute since July 22.

ed night and day on all roads leading into the district. Camp fires may be burned only within certain districts specified by the rangers. No smoking will be allowed in the woods.

It was pointed out that the lumber company and the forest service were willing to open timber to hunters providing the hunters would cooperate in preventing fire. If, despite the regulations, fires break out directly resulting from carelessness of hunters, the entire district will be promptly closed.

indicates that he might have had suicide in mind. For example he told Horace Dunlap to notify his daughter if anything happened to him. He also had paid a debt with a check and told the man to cash it soon because he might die.

"Third, he made his will three weeks before his death, and accompanying the will was a sealed letter to his daughter, which can only be opened by her. That letter may clear up the whole thing.

"Fourth, there was absolutely no evidence of foul play in his home. Nothing was misplaced or out of order. In fact, we found a small sum of money in his pockets, exploding the robbery theory.

"Fifth, on the end of the pistol, we found some hairs which were quite apparently his, indicating that he pressed the weapon close to his head."

On the other hand, it was pointed out, it was strange that Bensinger had not left a message.

It was stressed that movements about his farm during the past few days had not indicated he planned to take his own life. He had hired a man to help him harvest his crop and had recently employed a man known as "Charley" around the ranch.

It was also pointed out that the point at which the bullet entered the head indicated an unnatural although not impossible posture for taking his own life.

The fact that none of his neighbors were particularly intimate with the aged farmer, made it difficult for authorities to secure definite information about his movements just prior to his death. His closest neighbor resided one-half mile away. However, Henry Meyer, a neighbor, was peering through a spy glass at various points in the valley

Buried In Debris

Two other clerks were said to have been buried in the debris. The proprietor of the tailor shop was missing and was reported to have been buried in the ruins of his shop.

Four bank clerks were unaccounted for but it was thought possible that they were in the crowds about the scene. A physician climbed through dangerous overhanging walls to treat a woman bank clerk who was pinned under twisted steel and brick.
