A Warning

KLAMATH has been witness to the withdrawal of 7500 acres of marsh land on Tule lake from the public hunting ground; and it has recently seen the closure of a substantial area to hunting in the upper Klamath basin.

With these facts in mind and with the additional fact that the land holders are tightening up on "no hunting" restrictions on their property, it seems to us that sportsmen of Klamath should soon awake to the fact that if the present trend continues, more land will be withdrawn in the future seriously curtailing hunting in the Klamath basin.

Unless sportsmen organize, investigate, petition and demand hearings on vital game questions; unless they revive the weak Klamath sportsmen's association and mould that body into a strong and aggressive group capable of attracting the attention of the powers who withdraw these public hunting grounds, they might just as well write "finis" on their future hunting aspirations.

There is one way to reach an objective—organization. How much organization has there been to date? Thirty-five or forty sportsmen turned out at the initial sportsmen's association meeting to discuss the game reserve question. A committee was appointed which took time in the middle of the week to investigate the situation on Tule lake.

A second special session was called to receive the committee's report. What happened? Thirteen sportsmen turned out and, by the enormous vote of 8 to 5, repudiated the committee's report and substituted one of their own.

Puny votes of 8 to 5 can not impress any government bureau—particularly when that bureau is inclined to set aside reserves without consulting the people affected.

There is a sportsmen's association in Klamath. Use it. If its policies or its officers do not appeal to you, set up an organization of your own.

But, at all costs, if you wish to secure a modification of this government game reserve, if you want any voice at all in what shall be done with your hunting land, organize.

Mr. Balsiger Withdraws

WITH the last-minute withdrawal of Elmer Balsiger from the city council race, Klamath Falls has lost one of the most vigorous, aggressive, far sighted and constructive thinking public servants that ever served the city.

For four years, this writer has attended city council meetings and has traced minutely, the progress of Klamath Falls as reflected through administrative acts of the city government. He has seen that a strong and firm hand, a balance wheel and one of the principal motivating forces of the city government originated in Mr. Balsiger's chair.

Mr. Balsiger is an original thinker and a man who has the courage of his convictions. Time after time he has taken direct issue with the rest of the council on matters involving vital questions of city government; time after time he has presented unanswerable arguments in favor of his stand and swayed the majority in his favor. Occasionally the rest of the council "stood pat" against Mr. Balsiger, but that fact never caused him to vacillate one inch.

Mr. Balsiger is essentially progressive-minded. Throughout his four year tenure, he was constantly urging action. Where others might side-step some issue, Mr. Balsiger would step in and face the matter fairly and squarely, however embarrassing to him or the administration.

It is with deep regret, and with no reflection on his successor, Clifton Hammond, that the Herald witnesses the retirement from public office of Mr. Balsiger. He has done more than his share in community betterment, but his abilities in this direction have been so outstanding that if it were in our power, we would have him continue in public office for years to come.
