## Will Uncle Sam Act?

HOW MUCH LONGER will the federal government countenance the reign of gangsters in Chicago? We say the federal government because it is apparent that authorities of the metropolis are unable to handle the situation.

When gangsters slay material state witnesses in criminal actions, when they threaten the life of a presiding judge, when hardly a day passes but some established business house or the home of some official is bombed, when the "racketeer" business has reached a point where it imperils legitimate business enterprises, when the police department is honeycombed with graft and corruption, when reprisal murders are a daily occurrence, when jurymen are afraid to follow their honest convictions because of threats—then, we say, the time has come for the United States government, to declare martial law in this crime-torn city and scotch the murderers who today do as they please in the second largest city in the United States.

Just as long as it serves the purpose for which it was created, regular process of law should be followed in curbing crime. Under ordinary circumstances we hold no brief for men who take the law into their own hands and attempt to render the justice that should be society's task. But when process of law fails year after year in checking the reign of the criminal in Chicago, when gangsters openly defy the law and even carry their lethal weapons into courts of law, the time has come for emergency measures to be taken.

If the federal government does not take action, we could not condemn Chicago citizens if they took the law into their own hands and dealt summarily with these scourges of society who kill at will any person who crosses their paths.

In western pioneer days, when law had not been established in population centers, a vigilance committee administered justice and checked crime waves. Why then, if Chicago authorities can not cope with the situation, and if the federal government does not intervene, should not the citizens of Chicago have the right to protect themselves?

## FORGER CLAIMS HE HAD FOOLED L. A. EVANGELIST
