The president affixed his signature before a gathering of proponents of the Swing-Johnson bill, who were brought to the executive office by Senator Johnson and Representative Swing, California republicans, who for years had led the fight for enactment of the bill. The measure provides that the government shall supply the \$165,000,000 estimated as necessary to construct a dam and accompanying works in Black Canyon. The money is to be repaid under an amortization plan from proceeds of the sale of power. The signature of the president was the last official act required in providing federal authority for the construction, but either Utah or Arizona of the seven Colorado river basin states must ratify the Colorado river compact for distribution of water before the act can become effective.
