

IN THE REALM OF SPORT

Year 1929 Will See Increase Of Intersectional Competition In Nearly All Lines of Sport

NEW YORK, Jan. 1. (AP)—No prospective feature of the sports campaign for 1929 is any more significant than events aimed at breaking down the old sectional barriers or removing a number of time-honored traditions.

Where 1928 has been a season of remarkable activity, 1929 will find most of the American athletic activity concentrated at home with fresh opportunities to develop intersectional interest on a wider scale than ever before. One of the most ancient of all the ancient traditions will be removed when the national amateur golf championship is staged for the first time on the Pacific coast at Del Monte. And to make it the biggest campaign ever held on far western links the Professional Golfers association tournament also has been booked for Santa Barbara as the fore-runner of a round of open competition for the country's leading pros.

Bears Play Pennsylvania.
Following the path blazed by Stanford, California's football team will journey east to meet Pennsylvania while the Army will send its eleven to the far west for the first time to play the Cardinals in a return engagement at Palo Alto.

To add to the gridiron gaiety, Yale will break away from another old tradition and go south to play the University of Georgia. The Elis are booked to play at Chicago in 1931 and may eventually wind up some season on the Pacific coast.

Tex Rickard, after having tested the drawing powers of boxing centers in the far west, middle west and east during his colorful career, will promote his first big fight in the south February 27 with Sharkey and Stripling clashing at Miami Beach.

About the only main events that the east still has stranglehold on are the national tennis championships and the Poughkeepsie regatta. But the big fight of the year, with Dempsey in a comeback role, is slated for the Yankee Stadium, where half of the world's series also may occur again, providing the Yankees have a good share of their wealth and strength.

Questions Asked.
A few of the main questions at issue as the new year gets underway are:

1. Whether or not Jack Dempsey will attempt a comeback.
2. Whether Big Bill Tilden will be restored to good standing in amateur tennis ranks, and, if so, try another comeback.

3. Whether Paavo Nurmi will remain the greatest of all amateur foot-racers or yield to the tireless call of the professional promoter.

4. Whether the Army and Navy will effect a reconciliation and pave the way for a resumption of their gridiron classic by 1930 since there is small prospect of any get-together in 1929.

"Aye,"
If a guess has to be hazarded it is vote for "aye" on all of the above counts, if for no other reason than that it would stimulate competitive interest.

Rickard predicts that new champions will be crowned in most, if not all of the professional ring classes in 1929 but no such sweeping forecast can be made in other ranks.

Such bearers of the laurel wreaths as Bobby Jones, Walter Hagen and Glenna Collett in golf, Helen Wills and Henri Cochet in tennis, the Yankees in baseball, Rogers Hornsby in batting, Babe Ruth in home-run hitting, France in Davis Cup

competition and the California crew in rowing will be difficult to dislodge. Most of them have acquired the championship habit and all have enough stuff left to shake off any rivals in the coming year, if not for several years.

No International Games.
There will be comparatively little international rivalry for 1929. Tennis and golf will offer the main opportunities for conflict where polo, tennis, golf, boxing and all the Olympic sports furnished a continual round of international activity in 1928.

Walter Hagen will lead another big pro golf invasion to England where he will seek to win the British open for the fourth time. France will defend the Davis Cup again and is not likely to have much trouble doing so unless Italy or the United States make some astonishing forward strides.

INDUCTION OF VETS OFFICERS WILL BE HELD

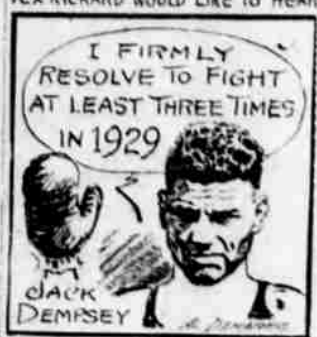
Installation of the officers of the Spanish-American War Veterans will be held in the court house Thursday, January 3. H. W. Bathany will be installing officer.

NEGRO SLAYER DIES AT STAKE

puny him when he was taken back to the farm.

Miss Keller with Shepherd's brother, and unnamed, had gone to a cabin on her plantation where the slayer was in hiding. "Miss, I'm sorry I done it," he told her.

With several men, she started with him in an automobile for the prison, but finding their way blocked by a mob, the party made a dash for the jail at Cleveland.

Within a mile and a half of their objective about 50 men in cars overtook the prisoner, asked Miss Keller to get in another car in which they would send her home, and seized the negro.

She pleaded with her to "please don't let them take me," but she was powerless to intercede. "It was pitiful," she said. "I have a heart and I don't believe in mobs. I thought he should have been punished, but that the law should have been allowed to take its course."

From the time the men seized him at 12:30 o'clock yesterday afternoon until he was killed shortly after 7 last night, the negro was driven from place to place while the crowd grew to enormous proportions.

Duvall, about sixty years old and the father of eight children, was found murdered on the floor of his dining room. His throat had been slashed with a butcher knife and he had been beaten on the head with an ice pick and hammer. Ruth Duvall, pretty high school girl, was missing.

She made her way the following day to one of the camps and told of being held captive by Shepherd, a trusty who lived in a cabin in the rear of the Duvall home. Shepherd was serving a 20 year sentence for manslaughter for killing another negro.

gangsters, bootleggers and vice. Salts, another baron who made good in the beer trade, was in jail serving a sentence of 60 days for gun-toting, a charge on which he was convicted several months ago. Big Joe said he found his game of hide and seek with the law a dangerous undertaking and feared he would be caught either between the fire of enemies or by the police.

The federal government has taken a hand in Joe's case and a charge of conspiracy to violate the prohibition law is impending. Salts breathed a sigh of relief when he entered jail and said that when he was free again he would "give up the racket for good."

"Stubby" McGovern and William "Gunner" McPadden, who long have been connected by authorities in the beer business and gang feuds, suffered the extreme fate of those who stood in the top ranks of the leaders. Both were shot to death today in a resumption of the beer war in a south side cafe.

McGovern, a former lieutenant of Capone, and McPadden, business agent for a labor union, were killed at a table where they sat with some friends. George Maloney, operator of a soft drink parlor, was arrested after the shooting. The first policeman to arrive at the scene said he disarmed Maloney and found his warm revolver empty.

Two other powerful figures, linked by police with the liquor and racketeer rings, were missing from the ranks. "Big Tim" Murphy, former Illinois legislator, who was said to have attempted to "muscle in" the cleaning and dyeing "racket" was shot and killed in front of his home. The slayers were never captured.

The most sensational killing of the year took the life of Tony Lombardo, connected with the alcohol runners, who was shot down on Madison street in the center of the city's loop district.

Open gun duels and machine-gun ambush took a heavy toll on gangland in 1928 and with the more powerful leaders either dead or driven to cover by the law, only their followers, the less prominent, were left to strive for control.

Torrid Desert Searched For Train Wrecker

SAN BERNARDINO, Cal., Jan. 1. (UP)—Little used roads in the Mojave Desert, 100 miles northeast of San Bernardino were being searched last night by a posse hunting Harry Palmer, suspected of wrecking a crack Santa Fe passenger train and kidnapping an 11-year-old Los Angeles boy.

Reports received here from the party indicated that automobile tracks believed to be those of a machine driven by Palmer, had been found in the region.

The posse has been out for two days, halting late at night and continuing at daybreak. Search for the man and the boy was started when they were reported to have been seen in Barstow after the wreck at Hesperia last Thursday.

A filling station attendant and a waitress who saw them declared the boy was dirty and seemed in fear of his companion. The kidnapping was believed to be in revenge against the boy's father, who discharged Palmer from his employ.

Railroad investigators said that footprints of a man and a boy found near a tool house in the vicinity of the wreck were identified as those of a man and a boy. Two sets of tracks also were found leading from the scene of the wreck to where an automobile had been parked.

TAX REDUCTION WILL NOT GET FAR—CHAPMAN

PORTLAND, Ore., Jan. 1. (UP)—"There is hardly any more chance for a real, constructive tax reduction program to get through the Oregon legislature at the coming session than for the proverbial snowball in hades."

Thus declared C. C. Chapman, member of the state tax investigating committee in an address here today.

Chapman declared the recommendations made by the committee were contrary to the views of many of the members of the legislature, and that while this group and that one favors tax reduction, none want the reductions to affect the particular institution of state activities to which it is devoted.

"And so it goes with every tax cut recommendation," said Chapman.

"The result will be a common feeling at Salem that in all probability it will kill off any constructive program."

Chapman said he looked with some hope on the proposals of California, Oregon and Washington, coming at the same time, for institution of an excise tax on corporations.

are such millionaires as Pierre S. Dupont, the Delaware capitalist; General W. W. F. LOOK DENIED HABEAS CORPUS WRIT BY COURT

Writ of habeas corpus submitted in the case of the State vs. Frank Look, charged with contributing to the delinquency of a minor girl was denied yesterday by Circuit Judge A. L. Leavitt.

Attorney for the defense, James Bacon, submitted the writ, alleging that Look was illegally held. A representative of the district attorney's office argued the writ showing that a new charge had been filed against Look who was arrested in October and that his detention was legal. Judge Leavitt sustained the district attorney's office and denied the writ.

The anti-prohibition association, however, refuses to concede the November election as a victory for prohibition and announced the fight was just starting.

Meanwhile, prohibition enforcement will be operating on a \$13,500,000 budget during the next fiscal year when Commissioner Doran said at least \$200,000,000 would be needed to adequately enforce the law by a nation-wide federal police system.
