City Accepts Cash Offer

VOTERS of Klamath Falls went to the polls yesterday and approved the \$150,000 bid of the O. C. & E. railroad for the city's \$300,000 O. C. & E. income bonds. It was a sensible decision founded on sound business principles.

The electorate expressed itself in no uncertain terms against the city engaging in any transaction smacking of real estate enterprise; it expressed itself in favor of reducing the city's debt when the chance presented and did not respond to the alternative proposal of \$50,000 in cash and the Seventh street property.

The result all goes to show that when issues, however involved, are given sufficient publicity so that their meaning is thoroughly disseminated, the electorate will not often go wrong. We often hear sarcastic comments from so-called intellectuals, concerning the appalling ignorance of the average voter but we have noticed that when facts are presented and issues thoroughly aired, the people vote right. It is only when an election is clouded with personalities and prejudices, when the true facts are withheld, that the voters are misled.

This newspaper extends its congratulations to the city electorate for its wise decision. It is thoroughly in accord with people's feeling that the first thing to consider at this time is reduction of the public debt.

A Chance For Trouble

THE movement of Russian troops over the Chinese border may turn out to be just one more incident in the long chain of disorder which besets the Celestial empire—or, conceivably, it can be the starting point for more trouble than you would care to think about.

Probably it will be the former. The world powers, undoubtedly, will use every effort to localize the rumput.

But it could very easily mean a large sized war. Suppose, for instance, that the Japanese felt that this Russian invasion was menacing their interests, and should send their own army up to meet it? And suppose that this should create a situation in which some such power as England should feel called on to take a hand? And with all this going on, it is quite easy to see how the United States could get involved, what with our "open door policy" and our interests in China and the Orient generally.

Probably it won't happen that way—but it's worth watching. A whole lot of trouble could very easily begin in just that way.

A Field For The Baker

THE commercial bakery now bakes most of the bread eaten in the United States; in the majority of homes the housewife does not bake a loaf of bread from one year's end to another.

But cake-baking is still the housewife's job, according to a survey made by the Department of Agriculture, which announces that the vast majority of the cakes the country eats are baked in the home.

This, the department suggests, opens a huge field to the commercial cake baker; but it warns that the bakery must be able to convince the housewife that his cake is as good as the ones she bakes herself. This was relatively easy to do in the case of bread, but with cake it may well be a different story. Every housewife takes pride in her cake, the baking of which is a much less arduous task than the baking of bread.

Apparently the baking of cake will remain a household institution for some time yet—which, perhaps, is as it should be. Here is one field where it is hard to find a "just as good" substitute for the home-made article.

Lover to Talk Love
From "The Brownings," by David Loth: By modern standards Robert Browning and Elizabeth Barrett starved their love cruelly. A handicap was beyond all Robert's daring. A kiss was something mentioned in poetry but never attempted in real life. However, they derived a certain pleasure from the realization that their love could thrive on a diet of mere words. And of words they were prodigal indeed. Over the exchange of a lock of hair they lavished enough of ingenuinity and lyrical expression to have made a trunkful of the kind of Robert wrote. His letter, suggesting that she turn him with a wash of black curl was a masterpiece of dignified pleading worthy of a request for a couple of dukedoms and a principality. He felt greatly daring, as well he might. An admirer of Be's poetry had only three weeks before made a similar, though not so eloquently phrased plea.

"I am too great a prude for such a thing," he had answered. Squelching the Senate's "Baby" Kansas City Times: Retribution, he read, is in store for the L. O. Henry J. Allen. The senate, we are given to understand, is going to teach this "baby" a

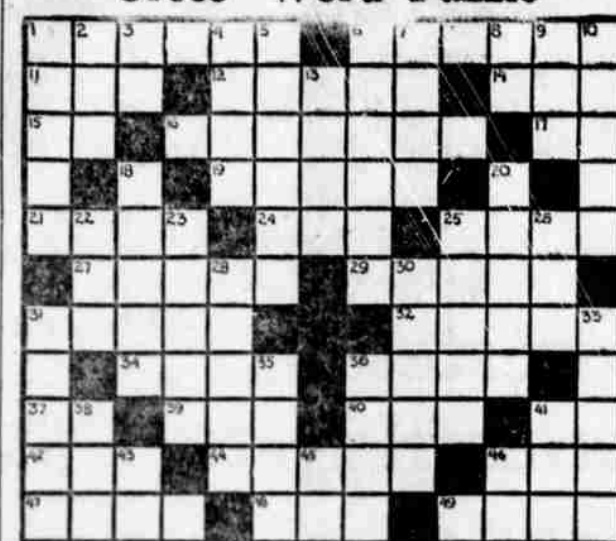

DAILY LETTER ON AFFAIRS AT U. S. CAPITAL

If You Want to Know What a Senatorial Debate Can Be Like, Here's a Sample for You. Straight from the Congressional Record—and all Concerned Were Cold Sober.

WASHINGTON, June 29.

Here's a perfect gem from the Congressional Record. It's not a fair sample of senate debate, but it shows what happens sometimes. Senator Caraway of Arkansas had several times interrupted "orria of Nebraska as the latter argued in favor of putting census takers under civil service instead of letting the jobs become political plums."

Mr. Norris: Yes.
Mr. Caraway: Is it the senator's idea that no one, simply because he is a member of congress, can be honest and can be trusted?

Mr. Norris: No. I have not said anything of the kind, and I have not said anything from which any reasonable man can draw such a conclusion as that.

Mr. Caraway: Well, what does the senator mean when he says—

Mr. Norris: That is the argument which has been made from the beginning of the civil service.

Mr. Caraway: O' it is not.

Mr. Norris: The argument which the senator from Arkansas is making now is the one which has always been made against the civil service.

Mr. Caraway: Well, I know that happens not to be true; it is not an argument against civil service. I am just asking the senator a question.

Mr. Norris: That question is an argument against civil service.

Mr. Caraway: It is no argument against civil service.

Mr. Norris: Then the senator ought not to make it.

Mr. Caraway: I am not making it. I am only asking a question.

Mr. Norris: If the senator is not making an argument against civil service then do not ask it.

Mr. Caraway: Let me ask the senator—

Mr. Norris: Cannot the senator wait until I answer one question before he propounds another?

Mr. Caraway: I do not think I will live long enough for that.

Mr. Norris: Perhaps the senator will not. He need not wait that long.

Mr. Caraway: I do not have to wait.

Mr. Norris: It does not make any difference to me. If the senator does not want to wait, that is his business.

Mr. Caraway: The senator thinks he owes the senate.

Mr. Norris: No, I do not think I own the senate. That is another statement the senator is absolutely unjustified in making.

Have I not a right here to oppose a provision in the bill because I think it is wrong?

Mr. Caraway: May I ask the senator a question?

Mr. Norris: Yes.

Mr. Caraway: What is there about it that the senator should become so angry, when I was merely trying to ask him a question.

Mr. Norris: The senator from Arkansas—

Mr. Caraway: Now—

Mr. Norris: Will the senator allow me to answer that question?

Mr. Caraway: I suppose I will stop for the rest of the afternoon.

Mr. Norris: Perhaps the senator will. It might be well as he would sit here and wait and

listen a little while. It might be well for him. He might get some information perhaps that would be valuable for him.

Mr. Caraway: I have listened for a good while and have not obtained any information as yet.

Mr. Norris: The trouble is the senator does not listen.

Mr. Caraway: Oh, yes I do.

Mr. Norris: He gets into debate when there is no call for it.

Mr. Caraway: I have been listening for eight years.

Mr. Norris: Now let us get to the senator's question. He has interrupted me so many times since the question was asked that I have forgotten what it was.

Mr. Caraway: I know the senator had, and I tried to set him right.

Mr. Norris: Why does the senator say I got so angry about it?

Mr. Caraway: Because.

Mr. Norris: Now, I remember what the question was. Let the senator keep still while I answer it. Let me answer it. The senator has asked it of me.

Mr. Caraway: I know, but I do not expect any candid answer.

Mr. Norris: If the senator will keep still I will answer it; I am going to answer it. The truth is that the senator is entirely wrong when he assumes I am angry.

Mr. Caraway: The senator does not make that kind of a face when he is in a good humor, does he? (Laughter.)

Mr. Norris: The senator has looked at so many bad faces that he does not know a good one when he sees it. (Laughter.)

Mr. Caraway: That is where that.

Mr. Norris: Mr. President, if there is one thing I cannot do after my long association here, it is to get angry at the senator from Arkansas.

Mr. Caraway: Then do not look at me in that tone of voice.

Mr. Norris: I have, however, seen him go wrong occasionally.

Mr. Caraway: Yes, when following the senator from Nebraska.

Mr. Norris: And I cannot follow him when he goes wrong.

Mr. Caraway: That is where I differ from the senator. I follow him when he goes wrong. I could not follow him otherwise.

Mr. Norris: The senator would do better if he would follow me when I am right.

Mr. Caraway: I have never found the senator to be that way.

The Presiding Officer (Mr. Dale in the chair): The senator from Nebraska has the floor. Senators desiring to interrupt must address the chair.

Mr. Heflin: Mr. President, does the senator yield to me?
