are the store, office, hotel, mill, filling station, water tower, lodging house and numerous auxiliary buildings. The theatre building is yet to be built. All the completed structures are equipped with water, lights, power and sewage plants are installed and operated by the company. The tramways built on concrete bases leading to the mill are completed, as well as the mill pond built with concrete retaining walls and dam.

The mill equipment of 60,000 feet capacity is on the ground and under installation. The installation will be completed August 1, when a small cut will be made for the use of the company in completing the building of the town.

MARKERS ARE PLACED SUNDAY

D. A. R. Marks Historical Spots of Klamath County.

Led by Captain O. C. Applegate, several members of Eulalona chapter, Daughters of the American Revolution placed temporary markers on historical spots in the Fort Klamath country on Sunday.

At old Fort Klamath a marker was placed where the American troops were stationed from 1864 to 1889.

A second marker was placed at Council Grove where the celebrated treaty was made between the American Government, the Klamath-Modoc and Snake-Palut Indians in October 14, 1866. More than 1500 Indians were stationed there.

On this spot, where the Harrison summer home now stands, an Indian village was burned by Kitt Carson. Through this treaty the Klamath Indian reservation was established.

The third marker was placed on the Battle Grounds on Williamson river where General Fremont fought the Klamath Indians in 1864.

A party will place markers

on July 10 in the Sprague river country.

Mrs. Rachel Applegate Solomon, Mrs. Robert E. Wattenburg, Mrs. Wilbur Jones and her son, Wilbur Jr., accompanied Captain Applegate on the latest trip.

Permanent markers will be placed as soon as funds are available by Eulalona chapter.
