The fact that the Reds were still in the running for second half honors could be credited largely to a lucky break in the final schedule. While the Hollywood club was slated to meet the strong Portland club, the Reds were matched against the lowly Seattle tribe whose sole claim to distinction has been that of holding down the after section of the league all season.

Meanwhile, the San Francisco Seals were slated to finish the season against the Sacramento Senators in the latter's home town, and the Angels were to tackle the Oaks in the hot across the bay.

S. P. SHORTENS SCHEDULES ON MANY TRAINS

Northwest and East to Get Better Service

New and faster schedules on three northbound San Francisco-Portland trains will be inaugurated Sunday, October 6, by the Southern Pacific company, according to announcement yesterday of James A. Ormandy, assistant passenger traffic manager.

Train No. 8, the Klamath special, will leave San Francisco at 8 p. m. instead of 7 p. m., shortening the running time 50 minutes.

Train No. 12, the Shasta, will leave San Francisco at 8:20 p. m. instead of 8 p. m., arriving at Portland at 10:45 p. m. instead of 10:40 p. m., shortening the time 15 minutes.

Train No. 14, the Oregonian, will leave San Francisco at 10:20 p. m. instead of 9:40 p. m., arriving at Portland at 7:30 a. m., shortening the time 40 minutes.

Train No. 16, the West Coast, will leave Sacramento at 10 a. m. instead of 10:45 a. m., arriving in Portland at 8 a. m., as at present, shortening the schedule 15 minutes.

There will be no change in southbound schedules, nor in the schedule of the Cascade limited, the company's crack train.
