Dependable Service

THE part railroads are playing in merchandising today is aptly explained by Edward N. Hurley, former chairman of the Federal Trade Commission, who says:

"Dependable and quick service to the retail stores, by fast express service on the part of railroads, prevents overstocking of goods and resultant loss on seasonal products. The merchant is selling from his shelves, depending solely upon the quick delivery of his requirements from the manufacturer. This is responsible for much cash-in-hand that formerly was invested in inventories that caused the manufacturers to be heavy borrowers at the banks. Today it requires 25 per cent less working capital than it did six years ago to manufacture and sell our wares in America, that reduction being due to our fast and efficient railroad service."

This fact is brought home to merchants of Klamath Falls who no longer have to invest heavily in certain lines of merchandise in order to take advantage of a discount. By the prompt handling of freight from Portland to this city, the Southern Pacific has made it possible for the merchants to obtain freight shipments on express schedule, thus eliminating the necessity of carrying stocks that are a long time selling, if ever. Corbett's Candidacy

ANNOUNCING that Henry Ladd Corbett of Portland will be a candidate for the Republican nomination for governor will be hailed with satisfaction by members of his party, for differing from many of the candidates, he is of gubernatorial stature and judging by his past record, would make an excellent governor. A member of one of the most distinguished pioneer families, Mr. Corbett, a son of United States Senator Henry W. Corbett, has served several terms as State Senator and made a satisfactory President of the Senate. He is widely known because of his investment and development enterprises in many sections of the state. His popularity in the metropolis is attested by the record votes he has polled for the Senate. He has sound business judgment, is familiar with the needs of the state, is young and energetic, has poise and common sense.

The principal objection raised against Mr. Corbett will probably be the demagogic one of his wealth, which Bert Haney raised at the Jackson banquet when he declared that "it was time to cast overboard the first families and have a few first class funerals." But why wealth, intelligently utilized, should be a bar to political preferment, has never been satisfactorily demonstrated. If it had been, we would not have had Washington, Roosevelt, or Hoover as presidents.

"PUBLIC OWNERSHIP"

Louisville Courier-Journal: An article in the Wall Street Journal, describing how dividend checks for Pennsylvania railroad stockholders, because of the great number of them, must be fed to an automatic machine which runs of sixty a minute, impresses the reader with the fact that modern corporate control has changed somewhat since twenty years ago, when "big business" was something to be feared and dreaded.

In the early years of this century unscrupulous business methods, competition that ruined, and the relentless pressure by large corporations upon the independent led to making "trust busting" the popular political sport. Of course, none ever was "busted." Even where they were split up, each segment sometimes outgrew the original parent corporation in wealth and power.

Today, instead of fighting giant corporations, the government actually is encouraging consolidations and the formation of what would have been regarded even a decade ago as "super-trusts." The attitude of a large part of the public has changed because that public has become the owner of these huge corporations. Instead of a few individuals, as was the case in the days when "trusts" were an issue in politics.

The United States Steel corporation, General Motors, the Pennsylvania railroad and the American Telephone & Telegraph company, to name a few of the largest, have hundreds of thousands of stockholders—not only in every state of the Union, but in practically every country of the world. European and South American gold has been coming

here in large quantity for investment, but of course the bulk of the stock in each of these corporations is held in this country. Politicians understand today that they should refrain from overtaxing or otherwise persecuting these corporations which deal in transportation, steel, copper, petroleum, meat and motor cars because they will thereby be not only jeopardizing the employment of millions, but adversely affecting the prosperity of millions of others.

MAYOR WATTERS has opened a question that is vital to Klamath Falls. He has suggested in his annual report to the common council that consideration be given to a new charter that will provide for a managerial form of city government. We believe he is right. The old form of city government is obsolete and inefficient. Every city in the country that has gone to the managerial form is pleased with it, which is the best possible proof of its success.

Under a city manager all detail work will be done by the manager. He looks after every feature of the city's needs and requirements. He is the same to the city that an efficient manager is to an industrial plant.

The soundness of the managerial form of government is so apparent that little argument should be needed to convince every voter of its benefit to Klamath Falls.

McCulley Child Coasts Into Car, Slightly Injured

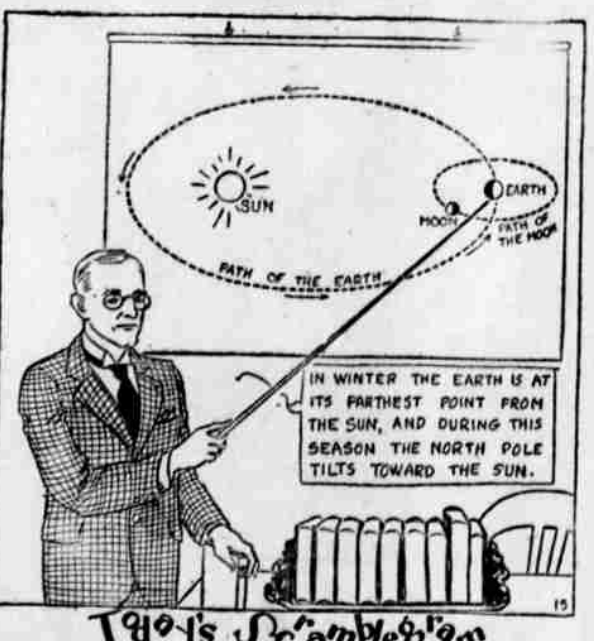

DAILY LETTER ON AFFAIRS AT U. S. CAPITAL

The Shadow of Al Smith Across Several Pending Senatorial Campaigns—Power Trust Reported Involved in Alabama Fight to Unseat Senator Heflin.

WASHINGTON, Jan. 15.—The Al Smith issue will figure to a greater or lesser degree in several of this year's senatorial elections. In two or three cases it may be just important enough to decide the result.

Some of our most famous senators, standing for re-election this year, are tangled up in it, including George W. Norris of Nebraska, Carter Glass of Virginia, Furnifold McLendell Simmons of North Carolina and Tom Heflin of Alabama.

Norris, technically a Republican, supported Smith in the 1928 campaign. Heflin and Simmons deserted Smith. And Glass stood boldly by the party ticket while his state voted for Hoover.

Power Interests Involved

The Democratic central committee in Alabama has read Heflin out of the party and Heflin, deprived of renomination, will run independently against John H. Bankhead, the probable regular nominee, in November.

The Smith issue undoubtedly will be important in this Alabama fight, but there seems reason to believe that there is more to the Heflin situation than meets the eye. While it appears on the surface that the Democratic committee was merely punishing Heflin for his anti-Smith position, one hears it said that its action is a part of a well-organized effort of Alabama corporations and reactionary forces to regain control of Alabama politics and public office. Heflin is regarded as comparatively progressive and his colleague, Hugo L. Black, even more so. The story is that power companies and other corporations are out to "get" both Heflin and Black.

The chairman of the state committee and the man who moved that Heflin be barred from the ticket are said to be attorneys for the Southern Railroad and the man who seconded the motion an attorney for the Alabama Power Company. The supposed aims of the movement are principally Muscle Shoals and a reduction of corporation taxes.

Heflin's enemies undoubtedly will play the Smith issue against him for all it is worth, but it seems doubtful whether many of Tom's people will turn against him simply because he turned against Smith. He is likely to make an anti-corporation campaign, as Black did against Bankhead in 1926.

Out in Nebraska the state Anti-Saloon League and the public utilities are reported to be burrowing industriously under Norris. Norris came so far from carrying his state for Smith, as he tried, that they probably will be able to give him a hot fight in the primaries. One hears here that national Anti-Saloon League officials advised the Nebraska superintendent to lay off Norris, but that the superintendent went right ahead. Norris has always voted dry and the League people here, much as they disapproved his jump to Smith, are not bitter against him.

Rumors that Ex-Governor Samuel R. McKelvie, now on the Federal Farm Board, would be backed against Norris in the primaries by standpat Republican and organized drys are not as strong as they were. Washington, intensely interested in the political fate of Norris, has been hearing more lately about the possible candidacy of State Treasurer Stebbins.

National dry leaders do not relish the prospect of seeing their Nebraska organization taking a licking from Norris. They realize that it is likely to prove impossible to beat him and that an unsuccessful attempt would not do their cause any good. They had one taste of defeat when Bishop James Cannon of the League tried to take political control of Virginia in the last gubernatorial election.

Glass' Chances Bright

The result of that election seems to brighten the prospects of Senator Glass to succeed himself. It hasn't appeared yet whether Glass will have any strong opposition for renomination, but common belief here is that he will be returned to the Senate and especially that Bishop Cannon and his followers won't be able to stop him.

Simmons, the oldest member of the Senate, faces a determined primary fight in which his defection from Smith—more marked than Heflin's—probably will be the chief issue. The candidate who will carry the flag for the anti-Simmons forces has not been chosen and it is too early to get a line on the senator's chances of renomination, but it ought to be a good scrap.

As we go to press the record shows that Charles E. Hughes is the 84th great man to be the first to say "faith, hope and charity."
