## Representative of Hoo Club Signs Up At Ft. Klamath

FORT KLAMATH, Ore., Feb. 13. (Special)—Mantred Jacobsen, noted ski racer and winner of the first two 42-mile Crater Lake ski races, arrived at Fort Klamath early today, coming direct from Truckee where he was victorious in the ski race there, February 8th, taking first place in the major event sponsored by the Truckee Ski club.

Nothing much is known about Amatte's power of endurance or ability to keep up the pace for 42 miles, but he has been seen along the course doing some real fast work and makes the round trip to the lake seemingly without much effort and never appears tired after the long trip.

Just what time any of the racers are making over the course now is not known. They are making almost daily trips to the lake but spend a lot of their time playing on the hills and exploring country new to them in the vicinity of the lodge and around Anna Springs. None of them have as yet made an official run in attempt to win the award of two weeks board and lodging offered by the club to the first ten making the 42 miles in less than 7 hours, 30 minutes.
