election in November when Pierce could be used as a revenge candidate by disappointed republicans.

Groundwork for the Pierce-for Governor boom was laid a few days ago, West said, when thirteen democrats were invited to a luncheon at a hotel here. A motion, West said, was put to the meeting which read: "It is the sense of this meeting that Pierce will run for governor," and the motion was carried, although W. A. Delsell, who was secretary to Pierce when he was governor, is said to have doubted the wisdom of starting the boom behind closed doors.

**Acted on Hunch**

This luncheon meeting, West said, was held a short time after democratic leaders met in unity and attempted to agree on whether Edward F. Bailey, Eugene; George R. Wilbur, Hood River, or others should be given support. West said he thought the meeting was in accord throughout, but said he "had a hunch" and dropped in on the luncheon meeting just when the motion to draft Pierce was being made.

With that democratic politics in Oregon has remained stationary.

**McNary Fight Collapses**

PORTLAND, Ore., March 21. (AP)—The Associated Press was informed today that a sudden and complete collapse of the movement of reviving lumbermen to bring out a candidate against United States senator Charles L. McNary, republican, Oregon, followed yesterday's one vote margin passage of the soft woods tariff measure in the United States senate.

Although the tariff does not become a law until the House and President Hoover approves it, leading lumbermen in the movement said that the \$1.59 per thousand board feet tariff apparently appealed the majority of Oregon lumbermen.

"With this tariff in hand," they said, "the revolting lumbermen do not care to undertake to seek a candidate to run against Senator McNary."

The lumbermen were pledged to wage a sharp fight against the senator in the primaries.

## Million Dollar Rain Drenches West Slope Of Parched Cascades

(By The Associated Press)

A "million dollar" rain drenched Portland and practically all of the western slope of the Cascade mountains today which was welcomed by orchardists, general farmers and forestry officials.

Rain fell intermittently in Portland and vicinity throughout the night and this morning turned into a steady downpour which made streets miniature rivers and laid a warm watery blanket over orchards, farm lands and forests which already had shown signs of becoming arid.

Forestry officials announced recently that unless a phenomenal amount of rainfall was experienced in Oregon within the next two or three months, forest fire conditions would be worse this year than the disastrous year of 1929.

They said today that if the rainfall was general throughout the National forests in the state and other stands of heavy timber, it probably would be insufficient to quench out several fires already reported burning and would serve as a damper to future dangers.

## Partial Eclipse Of Old Sol Due Here April 28th

PORTLAND, Ore., March 21. (AP)—For more than three hours on April 28, Oregon will lie in the weird twilight of a partial eclipse of the sun. It will take a half century before another opportunity to view this kind of an eclipse is offered, R. G. Aitken, associate director of Lick observatory, announced today.

The first effects of the moon's passage between the earth and the sun will be noted at 9:52 a. m., and the sun will not clear until 12:35 p. m., with maximum darkness at 11:12 a. m. Eighty six hundredths of old Sol's face will be covered.

Along a narrow path in California the eclipse will be total, due to the tortuous course of the moon which is pulled by numerous heavenly bodies.

The eclipse will be visible as far south as Guatemala and as far north as Alaska.

The tariff passed the senate after a heated lengthy fight in which Senator Charles L. McNary, republican, Ore., and all other northwest congressmen split a coalition of democrats and republican independents and rode through to a victory with the one vote to the good.

**Predicts Benefit**

John Tennant, president of the West Coast Lumber Manufacturers association and vice president of the Long-Bell Lumber company at Longview, expressed his belief that the tariff law would bring much benefit to this section.

He said that American lumbermen could not compete on a more favorable basis with British Columbia and Russia, where lower wage scales and lower water transportation have prevailed.
