

HEAT CLAIMS MANY LIVES

Pennsylvania and West Virginia See Mercury At New Levels

drowned in the Ohio river at New Cumberland, W. Va., in futile efforts to save a son and brother, a girl, stepping into a hole in the bed of the Monongahela river at Brownsville, Pa., became the tenth drowning victim in that section this season. A woman collapsed in Uniontown, Pa., and died before relatives could aid her.

Wave Spreading
CHICAGO, July 19. (AP)—A withering heat fastened itself upon America today.

From Great Lakes to gulf and from ocean to ocean, the continent cooked. Three figure temperature readings were common. Ninety degrees or better were recorded in virtually every section.

On the basis of official government figures, the average maximum temperature for the United States yesterday was 89.5.

Out of 94 government weather bureaus reporting to the Chicago forecast, 54 had temperatures of 80 degrees or better. Only nine of the entire number reported maximums under 80.

Crops Face Drought
The nation's granaries, baked by the persistent sun, faced drought. Livestock in many places saw green pastures turn russet and die. The danger of corn being dried in the field was felt in Iowa.

Beaches, especially those near large cities, swarmed with people. In Chicago, where an estimated quarter of a million took to the water to shake off the heat, Lake Michigan had a temperature of 68 degrees.

Kansas Sizzling
Phillipsburg, Kan., had 113 degrees, and Emporia 109.

Weather prophets are doubtful concerning immediate relief for most of the country. Possibility of thundershowers was spoken in the central and northwest, but forecasters pretended to see no certain success to the heat.

The need of rain was felt in a score of states. The United States weather bureau at Washington said the dry spell was particularly severe in Tennessee, Alabama, Mississippi, Louisiana and Arkansas, and to a slightly less degree in the middle and southwest.

Water Shortage Faced
Such heat as the nation experienced yesterday—and faces again today—has proved a serious tax upon pumping stations. Already in parts of Maryland warning has been given that unless there is rain soon, there must be a 50 per cent curtailment of water consumption.

The coolest section of the nation yesterday was in Michigan's upper peninsula, where a maximum of 62. The Pacific Coast too, had temperatures in the comfortable seventies with a 68 at San Francisco.

Yesterday's heat casualties included the death of a man in Springfield, Ill., from sun stroke, the death of a Chicago fireman who collapsed at drill, and a drowning and two prostrations in New York City, where a temperature of 84 was accompanied by high humidity.

The position on the ladder of George Merryman, one of the most promising of our high school boys, has entitled him to play with the team in this tournament, and more high school players should be able to work up high enough soon. The 1st and 2nd ranking players in Portland are high school boys and Jimmy Morrison who won the Southern Oregon cup here two weeks ago also won the central Oregon championship which was held at Bend a week ago. He is in high school at Medford.

Three Events in Plan.
The plan of the inter-city tennis meets like this one with Bend includes three events. First each player plays a singles match with one of the opposing team. All matches consist of the best two out of three sets. The second event is the men's doubles, and the third is the mixed doubles. There are no finals of any kind. Each match counts one point won or lost in the tournament score. When Bend played here a month ago the tournament score was Klamath 8, Bend 7, showing that a total of 15 matches were played. These tournaments, generally start at 10 o'clock and finish about 3 o'clock.

The tennis club plans call for a match and a return match with Grants Pass in August, dates to be announced later. The club also wishes to announce a gala dance to be held about the middle of August at the Willard hotel.

Woman Suffering From Poisoning Taken to Hospital

for executive clemency were denied by Governor W. H. Adams. A stay of execution for sixty days also was denied. Officers asking the stay were attempting to learn from the two condemned men details of other criminal activities in which the Flagles were thought to have been involved.

The men embraced the Catholic faith and were baptized by Father Regis Barrett, prison chaplain. They went to their deaths calmly and quietly.

Prison officials asked the men if there was any preference in the order in which they died. "I'll go," Abshier said simply. The trap was sprung for him at 9:40 and he was pronounced dead at 9:53. The trap was sprung for Royston at 10:37 and he was pronounced dead at 10:52.

Prisoners Say Goodbye
Before going to the executive chamber, Abshier was taken to Royston's cell. They said goodbye and shook hands.

Royston made a will leaving his few possessions to his wife who is in California with their baby daughter.

Royston's body will be sent to Richmond, Calif., for burial. He had previously requested he be buried in the prison cemetery to "save expense." A war service organization was asked to supply funds to give Abshier a burial.

In the Lamar holdup, A. N. Parrish, president of the bank, and his son, John, were slain by the quartet. Two tellers were kidnapped and later the body of one, E. A. Kessinger, was found.

Royston had been wounded in an exchange of shots in the bank before Parrish and his son were shot down, and Dr. W. W. Winelinger of Dighton, Kans., was called to treat his wounds. The doctor's body was found some time later.

and that large sums of money were mentioned, as well as a "50-50 split," the warden said he had gone to Clark's house to discuss with him a purely administrative matter—that of solving the case from the Columbia school.

Complained About Salary
While they were there, Clifford testified, Clark complained about the salary he was making and mentioned the sum he considered necessary to support his family. Clifford said he recalled that \$2000 was the amount mentioned.

Clifford vigorously denied taking as much as a dollar outside his salary, since he has been in office. "If anyone working for me ever said anything to my presence about my taking as much as a dollar outside of my salary I would write out his resignation at once," the warden declared.

Deficit Wiped Out
In discussing the administration of his office since he has been warden, Clifford declared that under his direction "the game department has pulled out of a deficit of approximately \$50,000" at the time he took office, and now has \$44,781.50 over and above all outstanding claims, as well as approximately \$50,000 additional due the department from 650 license selling agents throughout the state.

"I have never instructed any warden not to arrest game violators," Clifford declared, "nor have I ever resorted to intimidation or 'framing' of wardens as was charged."

Women, Children Not Arrested
"I have instructed wardens that no minor children or women were to be arrested except in very flagrant cases, but I have instructed wardens to require such offenders to purchase licenses."

"The department has suffered much criticism on account of this attitude toward taking in women and children."

Commercial fishing violations on the Rogue river do not come under his jurisdiction, Clifford said, but under the jurisdiction of the state fish commission. He said he felt charges of lax enforcement on the Rogue were out of place in this hearing.

A night session was held and lasted until nearly midnight.

Hearing Adjourned
The state game commission today adjourned its hearing of charges of inefficiency and laxity in the administration of Harold Clifford, state game warden, and E. H. Clark, chief deputy. These charges were made by several sportsmen's clubs.

The commission ordered attorneys for both sides to prepare briefs of testimony which the commission will study. Commissioners indicated they will do some investigating of their own before the next meeting.

The hearing was adjourned until call of the chairman. It is expected the next meeting will be called within a month.

Each Day of Fair Is Dedicated to Special Purpose

Each of the three days of the annual Klamath county fair, to be held at the fair grounds this year, September 18, 19 and 20, has been dedicated to a purpose.

The fair will open Thursday morning, September 18, and will be known as Klamath Falls Day. On this day it is expected that all residents of Klamath Falls, including business houses and stores, will participate in the observance of the fair which is an exposition of Klamath county's products and accomplishments of the past year, and the result of years of study and research.

Children's Day Changed.
The second day, September 19, will be dedicated to children of the entire county. Instead of Saturday, the 20th, as previously announced. At this time teachers and bus drivers will be on the payroll of the county and each teacher will bring in her group to attend the fair. The "mutt show" and other diversified entertainment plans will be carried out.

The third and last day, September 20th, will be known as Klamath county day, and the entire county will take part at the fair. Races, of course, will continue for the three days and the exhibits will be on display during the entire time.

Judges First Day.
Judging will start about 10 o'clock on the morning of the first day and in that manner ribbons and other awards may be made and displayed during the remainder of the fair. Judges have not yet been announced. Mrs. Barker stated this morning, however, it is thought that the majority of judges would be members of the school of agriculture, Oregon State college, at Corvallis.
