

SIX DIE WHEN PRIVATE YACHT STRIKES ROCKS

Heavy Seas Cause Slip To Wash Beyond Aid Of Live Savers

POWLEY, Cornwall, England, Aug. 21. (AP)—Six persons, including one woman, lost their lives today when the yacht Islander of the Royal Yacht Squadron was swept ashore on the rocks of Lantvit bay, near here, during a heavy gale. There were no known survivors.

Heavy seas subsequently caused the yacht to change her position, making her more inaccessible to the life savers.

Two coast guardsmen bravely descended the face of the overhanging cliff and reported they distinctly heard the screaming of a woman, apparently imprisoned in the cabin.

The first actual sight of human life aboard the yacht was obtained when the coast guards, who were still trying to reach the deck and attempt to swim for the shore.

The savage seas were too much for him, however, throwing him back repeatedly. Eventually the swimmer gave up the struggle, sank, and was seen no more.

The yacht then became a total wreck. Today searchers from here were searching the sea in the vicinity for any signs of survivors.

There were at least six persons, and possibly more, aboard the Islander when she broke up.

The governor was non-committal. "I do not know where this agitation had its inception and until I have had time to give it proper study I have nothing to say further than that I am giving it detailed and profound consideration," said Governor Norblad.

Luper Not Surprised
Rhea Luper, state engineer and secretary of the state reclamation commission, expressed no surprise when informed that a request had been made for such a session, although he said that he was not aware that such a move was under way.

The movement, he said, likely had its inspiration in the recent filing of private power companies on the largest of the power sites remaining in the state feasible for private development, referring to the applications of the California-Oregon Power company on the North Umpqua and Klamath rivers, and those of the Northwest Power company on the waters of the Santiam river and Marion Lake, which latter rights are also sought by the city of Salem for municipal power and water supply purposes.

These three applications, if approved, would place in private hands practically all of the feasible power sites in the state, Luper said. They have already been approved by the federal department and are pending before the state reclamation commission.

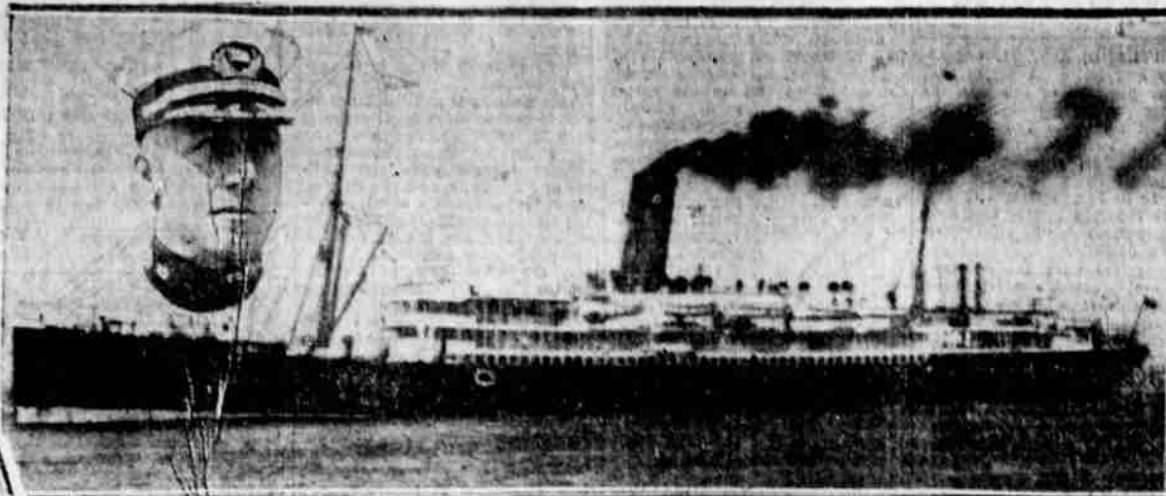

Edward Jordan, who claims to be the only man ever given a full pardon under a death sentence in the history of the United States in Klamath Falls today, telling of his horrible experiences in the death cell while waiting to hang, and giving out advice on why capital punishment and third degree methods should be abolished.

Mr. Jordan spent 86 days in the death row at the Oregon penitentiary, and during that time he states that his experiences were the most terrible that could be imagined, and that he died a million deaths while waiting to hang.

In Jail Break
Jordan was convicted with five others of the slaying of Sheriff Taylor of Umatilla county in a jail break at Pendleton in the summer of 1922. Jordan was in jail at the time, and was accused of agitating the jail break, although he did not do the actual shooting. All of the prisoners involved were apprehended and brought to trial. Hathey and Hart were hanged, while the other three are serving life sentences at the Oregon penitentiary in Salem. Jordan was sentenced to hang, but was granted a full pardon by Governor Ben Olcott when a last minute confession cleared his name.

Jordan has served three times in the United States army, from which he was honorably discharged. He is now touring the country in an effort to prevent crime, and is particularly anxious to instill into the people's minds condemnation of the practice of incarcerating young and inexperienced youths with the old and hardened criminals.
