LUPER DOES NOT FIGHT THE AUDIT

State Engineer Resigns When Records Show He Owes State

PROMISES TO RETURN INTEREST MONEY

Klamath's Grant Site Hearing Waits on Machinery of State it Appears

SALEM, Ore., Oct. 1. (AP)—The resignation of Rhea Luper as state engineer was the culmination into yesterday of an investigation into the financial condition of the engineering department that has been in progress for several weeks by the reclamation commission.

The resignation was effective immediately and C. E. Stricklin, deputy engineer, will be in charge of the department until a new engineer is appointed. The appointment will be made by Governor Norblad. By a peculiarity of the law the governor alone has authority to appoint an engineer, but a majority of the commission is required to remove him. In accepting the Luper resignation the commission voted unanimously. Luper, though a republican, was appointed to the office by Governor Pierce, democrat, seven years ago. He had

SMITH EXPLAINS OREGON SYSTEM OF BALLOTING

Portland Attorney Speaks At Forum Luncheon This Noon

L. B. Smith, Portland attorney, who is secretary and counsel of the Greater Oregon association of Oregon, addressed the Klamath County chamber of commerce at noon today on measures that will be on the ballot at the November election.

Smith, who has not visited Klamath for several years, expressed himself as astonished at the rapid development that has taken place in agriculture, commercial activity and industrial expansion.

"With the fine railroad and highway extensions you are getting down here, the Klamath country is unquestionably in preparation for a great future," he said.

The speaker commented on the general apathy of Oregon citizens in all sections of the state in relation to the heavy responsibilities placed on voters by the working of the Oregon system, by which every citizen has to be a legislator. He declared it has become the general rule to vote "No" on complicated propositions, and that the difficulties involved are the means of keeping thousands of voters away from the polls, who might otherwise express their opinions through the ballot.

"Competition with opening of the duck shooting season and the world series is pretty strong as I have to distribute," said Smith.

His organization has been in operation for about five years, and

Pleasant Weather Grooms Players Who Contest For the Pennant

PHYSICALLY FIT IS WELCOME DECISION

SHIBE PARK, Philadelphia, Oct. 1. (AP)—Robert Moses, southpaw ace of the Philadelphia Athletics, was selected by Connie Mack to pitch for the world's champion Athletics today, against the St. Louis Cardinals. In the opening game of the world series.

His opponent was Burleigh Grimes, spitball veteran of the Cardinals.

PHILADELPHIA, Oct. 1. (AP)—With the weatherman's forecast—fair and continued cool—indicating a temperature of about 62 degrees, baseball fans prepared to wear topcoats to the opening game of the world series here today.

A brilliant autumn sun this morning helped warm the enthusiastic crowd that waited throughout the night for bleacher seats. The temperature at 7 a. m. was 55, and there was a crisp chill in the wind that swept around the ball park.

Frankie Frisch will play in today's game, it was announced at the headquarters of the St. Louis Cardinals.

Lumbago Is Gone

Dr. Robert F. Hyland, club physician, said the star second baseman was "OK."

"He is feeling fine," said the doctor. Frisch has been suffering from a touch of lumbago.

The annual guessing contest between Connie Mack and the fans featured the pre-game activities. Everyone was trying to name the Athletics' starting pitcher against the Cardinals, and only wise old Connie knew. Manager Mack had the last guess and promised to keep his counsel until game time as he did last year when he came back to the thick of world's series fights after a long absence.

Manager Charles E. (Gabby) Street of the Cardinals has no

AIR MAIL TO LOS ANGELES

WASHINGTON, Oct. 1. (AP)—A contract for carrying the mails by air from New York to Los Angeles was awarded today to the Western Air Express, Inc., of Los Angeles, and the Transcontinental Air Transport, Inc., of Delaware.

The postoffice department announced Postmaster General Brown accepted a joint bid by these two companies because it was the only qualified one under the terms of the McNary-Waters act, and in conformity with specifications in the advertisement.

The United Aviation company of Pittsburgh submitted a lower bid, but the postoffice department said it did not conform to specifications.

Service is to begin within 30 days. For the present it will be maintained by daylight flying only. The schedule over the route has not been arranged.

OLD HOOVER IS HEARD NO MORE

NEW YORK, Oct. 1. (AP)—Jack Donahue, musical comedy star, died at his home in Central Park West this morning.

Death was ascribed to complications. He arrived in New York last Thursday from Cincinnati, where he was forced to quit his show, "Sons of Guns," because of illness.

At the time he made light of his illness, and refused to permit anyone to accompany him on the trip to New York. At that time he was not suffering from high blood pressure.

Jack Donahue had been called, with George M. Cohan, the last of the old-time hoofers of the stage, for although he was still on the agile side of forty, he belonged to a generation of dancers only a few of whom have retained popularity in this tap-dancing day.

He never took a dancing lesson, he often related, but learned to dance merely by practicing and listening with his own ear for the rhythm of his steps.

His wife, with whom he played in vaudeville, is known on the stage as Alice Stewart. There are three small daughters, 9, 7 and 4 years old.

STOCKS UP AND GLOOM DISPELLED

Bears Lose on Continued Selling Which Caused Depression

ADVANCE SHOWN IN MANY GOOD ISSUES

End of Market's Gloomy Period Thought To Have Been Reached

NEW YORK, Oct. 1. (AP)—The stock market displayed a sharp reversal of recent form today, rallying briskly under the impetus of short covering which frequently became urgent. Gains of \$3 to \$5 were common in the rails, utilities and industrials.

U. S. Steel and American Telephone advanced \$4 and American Can \$6. Westinghouse Electric, Sears Roebuck, Allied Chemical, Johns-Manville and Dupont made similar gains. Shares rising \$3 or more included North American, Pennsylvania, Consolidated Gas, General Electric, American & Foreign Power, Stone & Webster, New York Central, Standard Oil of New Jersey, Atchison and Canadian Pacific.

J. I. Case up more than \$10, Michigan Steel up \$9, Houston Oil Diamond Match, Eastman Kodak and Auburn Auto up \$5 to \$6, were among the leaders for which the bidding by the retreating short interests became a scramble today.

REYNOLDS SEES BRIGHTER DAYS

CHICAGO, Oct. 1. (AP)—Geo. H. Reynolds, chairman of the executive committee of the Continental Illinois bank and trust company, and dean of Chicago bankers, celebrated the end of his fiftieth year in banking today with optimistic comment on the nation's financial status.

"Depressions don't kill people," he said. "We will recover, and we are recovering from this one faster than we appreciate. There is no fundamental trouble with either the country or the American people."

"I predict within a few months we will discover we are doing a volume of business comparable to any other period of prosperity. A volume of business that will startle the nation."

Robbers Beat Up Widow Almost in Portland Limits

PORTLAND, Ore., Oct. 1. (AP)—Four robbers terrorized the farm home of Mrs. W. Murray, widow, near Gresham today, beating and blinding Mrs. Murray, her two daughters, and Fisher Jennings, farm hand, before they ransacked the house of \$12 and escaped.

Jennings suffered a broken rib, a terrible beating, and lost his teeth when one robber kicked him several times in the face. Mrs. Murray and her daughters, 15 and 8 years old, were beaten and tied with torn sheets.

Police were told the four robbers entered the home after midnight and demanded Mrs. Murray cash three checks totaling \$151.25. Meeting with refusal, Mrs. Murray said the robbers attacked the four occupants of the house.

First of World's Series Games Was Great Exhibition

Fast Ball Played by Both Teams From the Beginning—Large Attendance Greets First Game of World Series.

SHIBE PARK, Philadelphia, Oct. 1. (AP)—Setting a world's series record, the world's champion Athletics took today's game for five hits, all for extra bases, and converted them all into runs to beat the St. Louis Cardinals, 5 to 2, in the opening game of the championship battle today, before a crowd of 32,295 fans, including President Hoover.

Although the National leaguers slammed Robert Moses, southpaw ace of the A's for a total of five safe hits, they were able to score in only one inning while the world's champions made every hit off Grimes count. Home runs by Al Simmons and Mickey Cochrane, triples by George Haas and Jimmy Foxx plus a rousing double by Jimmy Dykes combined to start the Athletics off triumphantly in their first fight to retain the world's baseball championship.

SHIBE PARK, Philadelphia, Oct. 1. (AP)—With a chill in the air more appropriate for football than baseball, the fans gathered from far and wide today to watch the Athletics begin the defense of the world's championship against the St. Louis Cardinals, rampant pennant winners of the National League.

The sun broke through a flock of low flying black clouds by noon time but the advance guard of the unexpected jam of 23,000 fans, including the president of the United States, was bunched in overcoats and furs.

It looked like the chilliest world series battle since Washington beat the Pittsburgh Pirates in near freezing weather at the national capital in 1925.

Any doubt concerning a capacity attendance appeared dissipated by the early morning rush for the dollar seats in the left field bleachers. Three thousand of them were put on sale shortly after 8 a. m. and in little more than an hour the entire section was sold out, for hours before game time.

People on Roofs.
Even the temporary stands erected on the roof top of houses facing the park on 20th street were nearly filled by cash customers to the number of nearly 1300.

The world's championship pennant of the A's flew from the center field flag pole but the

only other ceremonial marks of the occasion were the decorations above and below the box to be occupied by President Hoover and his party of distinguished government officials.

The presidential party was due at north Philadelphia around 1 p. m. and expected to be in the park in plenty of time for the chief executive to throw out the first ball.

Athletics First Out.
The Athletics were first out on the field for practice and the great pitching mystery as to Connie Mack's choice of the finger to oppose Burleigh Grimes of the Cardinals seemed solved when Robert Moses (Left) Grove took part in the batting drill.

Grove was bunched in a heavy leather jacket, and retired to the bench after taking a few swings at the plate.

However, George Barnshaw also took part in the batting drill to maintain some uncertainty as to Mack's choice.

Under the direction of Captain Eddie Collins, the world's champions engaged in a brisk work-out while the crowds continued to pour through the turnstiles and the sun shed a little warmth on an otherwise very chilly affair.

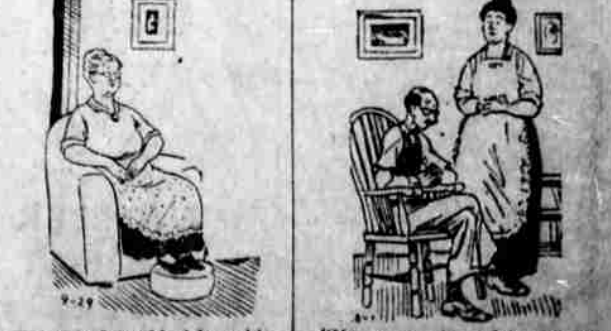
Nick Altrock and Al Schacht, the Washington comedians, put on a preliminary act or two for the amusement of the bleacher customers.
