Roads Under Foot Of Snow; Marketing Of Wheat Delayed

MONTANA FARMERS WILL SUFFER LOSS

Wyoming Is Hit; Warm Weather Predicted In Washington

WINNEPEG, Man., Oct. 16, (A.P.)—One of the wildest fall blizzards in years, sweeping across the prairies, threatens the already delayed movement of Northern Saskatchewan wheat toward railway, delivering to the head of the lakos. Hundreds of thousands of bushels of wheat must remain in the bins until the effects of yesterday's first blow of the winter disappear. Roads were under a foot of snow, and it was considered highly improbable that farmers could make deliveries for days.

DENVER, Oct. 16, (A.P.)—Snow ranging in depth from a trace to seven inches was general in the northern Rocky Mountain region today.

Storms yesterday and last night, extending from Montana into the northern part of Colorado, left a white blanket and descending temperatures. A trace of snow fell in Denver near midnight.

Seven inches of snow was reported in the vicinity of Bozeman, Mont., temperatures ranging from 12 above at Judith, Mont., to 18 above at Helena, a heavy ice coating. Farmers face the loss of considerable unharvested crops. Wheat in the Judith basin country could not be threshed because of the sudden weather change.

Wyoming, particularly in the southern part, had a heavy fall of snow, the storm nearing proportions of a blizzard at Laramie. The forecast for today was cold and snow, with generally fair weather to follow.

SEATTLE, Oct. 16, (A.P.)—The sudden cold snap, which yesterday held Washington in its grip, seemed broken today, and warmer temperatures, probably accompanied by rain, were forecast by the government weather bureau. The storm broke with winter intensity over the Cascades yesterday, hampering automobile traffic through the passes, particularly Snoqualmie pass, principal gateway between eastern and western Washington.

sels assigned to Changsha will be isolated until the rise in the river next spring, as the stream is not navigable during the low water period. The persistence of another communist threat against Changsha caused the British and Japanese to take this step.

American authorities, it was understood, decided to station a gunboat at Hochow, at the head of Tungting lake, not wishing to risk sending a vessel to Changsha during the low water period.

Advises from various Yangtze ports indicated the national government was moving rapidly ahead with projected large-scale anti-bandit, anti-communist campaign. Several thousand troops already had reached river points from Hunan province, and were on their way to Kiangsi province, where the red menace is considered the worst.

Klukians reports said many foreigners and Chinese had fled there from Nanchang, capital of Kiangsi, and were awaiting developments. A large army of rods was reported to have encircled Nanchang recently.

WOODRING SPEEDS ON WITH TREATY OMAHA, Neb., Oct. 16, (A.P.)—Continuing eastward alone after leaving his flying companion in a Wyoming snow storm, Lieutenant I. E. (C.Q.) Woodring left here for Chicago at 9:05 a.m. (C.S.T.) today, bearing with him the signature of the emperor of Japan on that country's ratified copy of the London naval treaty.

Arriving here at 8:30 a.m., after traveling the air path from North Platte, Neb., in one hour and thirty minutes, Lieutenant Woodring took off again as soon as his plane had been refueled. Unfavorable weather conditions did not deter him. He expected to reach New York tonight.

have been reported so far that the birds are coming in faster. Several hunters have reported that the northern flight are coming south and several of them have already found their way to the Tule Lake hunting grounds. "That is probably due to the heavy storms in Montana and the north country," Mr. Lawson stated.

Tule Lake Popular These are halcyon days for the Klamath sportsmen since the variety of game has been so enlarged. The hunters can be more choicely than before since they have their pick of deer, pheasants, ducks, geese, quail, silver gray squirrels and game fishing. The deer season, which opened September 15, closes Monday, October 20, and there are only a few days left.

The Tule Lake country probably affords the greatest variety of game. Several hunting camps have been established there among them the Havilina camp, which was started several years ago and later moved. The Lawson camp is also attracting many sportsmen.

Get Good Bags Over the week end a number of out of state men and Californians found the shooting at the lake fair. Among them were William Thum, Pasadena, Le Roy Shields, who is a prominent composer of music and director of John Boles, movie star, and Colbert Baldwin, grandson of the renowned "Lucky" Baldwin.

The open season for Chinese pheasants, quail, grouse or native pheasants, opened at sunrise the morning of October 15 to last until November 1, and as usual scores of local hunters were out in the valley fields. The bag limit for all except quail is four such birds in any one day, or eight during any consecutive eight days; provided that not more than one female Chinese pheasant may be killed in any seven consecutive days.

The bag limit on mountain, plume and California quail is 10 of any such birds in a period of seven consecutive days.

The duck and geese season, which opened in September, will continue to January 1. Bag limit for ducks, not to exceed 15 in any one day, and not to exceed 20 in any seven consecutive days; for geese, eight in any one day and not to exceed 30 in any seven consecutive days.

LOCAL MAN IS A VICTIM OF DESPONDENCY

After a complete investigation by the police department and the coroner's office of the death of Dan Guyon, whose body was found last night by children playing near the Devil's Teakettle, east of the city, a conclusion that the death was suicidal was reached. Robbery could not have been the motive for anyone's killing Guyon, they decided, since he had almost \$300 in currency in his pockets.

A further investigation of the matter will not be needed since police are satisfied that no autopsy or inquest will be necessary. Officers Folsom and Totter conducted the investigation. Two young boys, both about ten years old, found the body lying in the tules near the Teakettle Tuesday night, but failed to report it. Last night the body was still there and they told their parents, who called the police. Guyon's body was lying on its back, his hands were folded on his chest. In his right hand was a .38 calibre revolver, the trigger of which was firmly clasped by the index finger of the dead man's right hand.

A check made by officers revealed that Guyon lived at the Hot Springs hotel, although the clerk there, Earl Smith, said that he had not seen Guyon, who was known there as Dan Guy, since Tuesday, October 7. He said that Guyon had been drinking heavily and had recently fainted while shaving. Roomers at the hotel stated that the man was morose and despondent a great deal of the time.

Guyon formerly worked in the mills in Lewiston, Idaho and Spokane, but recently had been employed as a blacksmith at the Kesterson mill here. He was about 36 years of age. The man's relatives have been notified by Henry Joyaux, deputy coroner.
