

VOTERS HEAR CANDIDATES AT MEETING

CANDIDATES TELL OF VARIOUS PLATFORMS

Waggoner, Hamaker And
Ferguson Appear
For Mayor

Candidates who are running for public office, city and county, were introduced and presented their platforms before a large crowd of voters at a public meeting held at the Legion hall, last evening. The gathering was held under the auspices of the Klamath chapter of the League of Women Voters, a newly formed political organization in the city. Candidates for councilmen, mayor, assessor, district attorney, constable, city treasurer and police judge, were introduced by Mrs. Nelson Reed, president.

It was the last public appearance of many of the candidates, and they made an effort to bring their platform before the people. Preceding the candidates talk A. M. Collier, state commissioner, gave an introductory talk, explaining the changing attitude of the public toward women voters.

Candidates for the office of councilmen in the five city wards had first place on the program, with Dr. E. D. Lamb, first ward candidate, as first speaker. Dr. Lamb, who at present holds the office of city health officer, advocated coverage of the government canal through the city, a suitable bridge for Link river, definite sanitary code for the city, enforcement of the dairy ordinance and careful observation of all health orders.

Councilmen Speak
A. B. Moore, also running for the office of councilman in the first ward, introduced himself as owner and operator of the Baldwin hotel and stated he is for economy in keeping with the conservative ideas, and was especially in favor of obtaining an armory and adequate fire equipment.

None of the councilmen candidates in the second ward, who are Ed W. Vannick, O. L. Carter, Lawrence Hucenich and J. E. Hocking, were present. Frank E. Cantrell, candidate in the third ward, was also absent.

Interest Praised
Complimenting the ladies in the highest terms for showing an interest in political affairs, James H. Driscoll, candidate for councilman from the third ward, made a brief but impressive talk on civic affairs. He told the ladies he would value very highly their support and that he would serve the city to the very best of his ability.

H. P. Mose, carpenter, candidate for the council in ward four, stated that he has been a former councilman and expressed himself as absolutely in favor of public ownership of public utilities, and said he would exert every effort to gain coverage of the canal, public parks within the city, and regular food and health inspection.

J. D. Bagley, fourth ward candidate, expressed himself as for the taxpayer, and brought up a subject which is now timely when he said he would absolutely insist that streets when torn up in laying of pipe lines be put back in perfect condition.

J. C. O'Neil, another fourth ward candidate, was of the belief that training to be a lawyer would aid in fulfilling the duties of a councilman.

The third candidate in the fourth ward to speak, was Louis K. Porter who stated he would make no promises, but would simply serve the people to the best of his ability.

Roy F. Durbin, also a candidate in the fourth ward, was not present.

J. E. Van Camp, the only candidate in the fifth ward, who is up for re-election, was introduced and asked the women of the league to support the new dairy ordinance adopted by the city.

Treasurers Talk
Mrs. Ruth Olds Bathiany, a candidate for the office of city treasurer, stated that she would attempt at all times, if elected, to give the people efficiency and courtesy. She stated that she believed she was capable of handling the office, which handles close to \$3,000,000 in funds each year. "I have two good reasons for wanting the position, and they are my two children," Mrs. Bathiany commented.

Mrs. Nelle Elliott Motachenbacher when introduced as a candidate for city treasurer stated that one of the main qualifications for the office is a good knowledge of accounting, and stated that her experience in this line had included a business administration course in Klamath high school, six months' course at Rehnke Walker business college, business administration course at the University of Oregon, four years in the office of her father, Attorney E. L. Elliott, and two years in the office of Mendon Ebrman.

Mrs. Irma Dixon, who was city treasurer in Klamath Falls for two years and is now a candidate in the field again, mentioned a business education in the University of Iowa and Edmonston, Canada, and said that she has at least 10 years' business experience. She was also employed for two years in the county tax collector's office.

For Police Judge
"I have lived and worked among all sorts of people and have done all sorts of work, and I have a wide understanding of economics and sociology," was a portion of the short talk given by Howard K. Larsen, candidate for police judge. He expressed himself as especially interested in juvenile delinquency and was of the opinion that the coming winter would

find the police court overburdened with many problems to cope with which would require an understanding of people.

Roy N. Fouch, the other candidate in the race for police judge, outlined some of the functions of the city government, stating that the police judge's office consists of judicial work and accounting. He pointed out that during his present term of office as assistant to the police judge he has made many improvements in the accounting department and plans to continue the improvements if elected. An important point which he stressed is that a court should bring about a reform in the individual and make an example to the public.

Talk for Mayor
J. Bill Ferguson, candidate in the mayoralty race, gave as his platform "a working mayor for a workingman's city." He stated that there is something radically wrong when men and women who have created present conditions by bringing capital into the city and aiding in development cannot now get their share of employment.

In his platform, Earl Hamaker, candidate for mayor, advocated encouragement of all industries, safe and sane interpretation of laws, adequate school grounds, conservative and economic use of taxpayers' money, placing of city police in uniform, keeping the fire department in line with the city's growth, selection of inspectors for their qualifications, police patrol of residential districts and employment of local labor. He closed his talk with the statement that he has made no promises to any individual, firm or corporation.

Stresses New Phase
Hitting upon a phase not yet mentioned by other candidates, Walter R. Waggoner, the third candidate for mayor to speak, discussed business administration in relation to city government and development of a city. He emphasized the fact that carrying out the policies mentioned by other candidates such as new bridges, covering the canal, safe railroad crossings, accurately placed playgrounds, are all a matter of business and attainment of these would make people coming here not only feel, but know, that they had entered a real city.

He believed that a business administration based on sound principals would solve the police problem within 60 days. He stressed the statement that a mayor is merely the head of municipal governing power and must go into office with a spirit of cooperation and a spirit of fair play and honesty. Waggoner was of the opinion that the increased valuation of the city would take care of improvements, and he pointed out that the bonded indebtedness of the city, now a little over \$600,000, is only a little over one-third of what the city is entitled to under state law.

Fred H. Cofer and W. D. Butler, the others in mayoralty race, were not present.

For District Attorney
H. D. Bolvin, who is the Democratic candidate for the district attorney's office, and who is a Klamath county boy, gave his qualifications for the office as graduate in the law schools of University of California and Santa Clara and two years service as deputy district attorney. He stated that he could only promise a fair, honest and cooperative administration.

T. R. Gillenwaters, Republican candidate for district attorney, stated, "you all know me, and you're either for me or against me." He went on to say that the county has at present men in office such as Sheriff Lloyd Low and Judge W. M. Duncan whom he praised and with whom he works in harmony, and who are admired and that he hoped to be among those who are fulfilling the duties of their offices actively and capably by being elected to the office which he is seeking.

For Assessor
Roy Nelson, rancher of the Keno district, gave as one of his principal qualifications for the office of county assessor, which he is seeking on the Republican ticket, his knowledge of valuation of property which he has learned while serving on the board of directors of the Klamath County Farmers Loan association. Nelson answered the question of "who would be deputy assessor if he should be elected" by announcing that he would maintain the present deputy, Glen Terrill, if he would accept the position.

When introduced, Bill Lee, who is the Democratic candidate for county assessor, stated, "the people of the county know whether or not I have done my work for this is my tenth year of service in the assessor's office."

Talks for Armory
Gary B. Cozad, candidate for constable, declined to speak when he learned that his opponent, H. H. Graham, was not present, but was urged to say a few words at least, said that he has been affiliated with the sheriff's office for the past six or eight years and that he left it up to the voters to decide whether or not he has filled the office capably.

Leslie Reeder of Battery D, 249th Coast Artillery, talked for several minutes on the armory bill which will be on the city and county ballots. His talk was stirring and he pointed out that one of the greatest advantages of the armory is its importance as a training place for boys and young men, creating them into self-reliant, upstanding citizens, and urged the women of the county to support the movement.

Driscoll Interviewed
Following the meeting James H. Driscoll was asked for a serious expression relative to the councilmatic election. He outlined the needs of the city and stated that while we have the fastest growing and the best city in the Northwest, voters must bear in mind that the owing city is the one that needs careful and sane administration of its municipal affairs. He called attention to the industrial pay rolls that have been added to the community of late, and insisted that the next administration must show the city's ap-
