

OFFICERS HALT PRISON BREAK AT SING SING

OSSENING, N. Y., Nov. 3. (A. P.)—Sing Sing prison authorities sought to learn today how pistols were smuggled to four inmates whose attempt to shoot their way out resulted in the death of one of them and the wounding of another prisoner and a guard.

An autopsy indicated that Harry Gordon, 23, the inmate who lost his life in the attempted break Saturday night, committed suicide after he had wounded a guard and had been shot twice by the guard.

As a precaution against another attempt to escape, 100 guards yesterday searched the quarters of the 2300 inmates and other parts of the prison. They found a coil of rope with a hook attached similar to that used by the four in their attempted break, a few table knives and an imitation pistol fashioned from wood.

Edward Ryan, William La Pierre and Herbert Davis, the survivors, were held in solitary confinement pending determination of what charges will be made against them for their part in the attempt to escape. The wooden pistol was found in Ryan's cell.

The attempt to escape was made after the four re-entered their cell block from the prison chapel about 7 p. m. They thrust four guards and five trustees into a store room, locked them and made their way to the yard where they attempted to throw a large hook attached to a rope over the 30-foot wall.

Gordon was sent to Sing Sing in March, 1922, to serve ten years for robbery. Ryan is under a thirty-five year sentence, begun in November, 1927; Davis is serving five to ten years for robbery and La Pierre is serving twenty to twenty-five years for robbery. Ryan's original sentence was twelve and one-half years, but was increased after the escape in 1923 and was recaptured in New York several months later.

YOUNG MOTHER SHOT TO DEATH HUSBAND HELD

SAN FRANCISCO, Nov. 3. (A. P.)—With the prohibition question appearing to represent more of a cross current than a direct issue in the Pacific coast voting to take place tomorrow, it stood slightly in the foreground of the gubernatorial race in California, with Milton K. Young, democratic nominee, seeking office as a dry. Mayor James J. Rolph, Jr., republican, was an odds-on favorite to win, but supporters of Young, nevertheless forecast his victory by 200,000 votes. Rolph generally is regarded as a liberal so far as the liquor question goes.

Congressional races in only two of California's eleven districts were expected to offer excitement. Two republicans and two democrats sought to succeed the late Rep. Charles F. Curry by the write-in method.

Rep. Joe Crall, Los Angeles, was opposed by John Dockweiler, democrat.

Proposed daylight saving held considerable attention. Bond propositions include \$25,000,000 for the Golden Gate bridge project; a \$20,000,000 Veterans' Home and Farm Loan act, and a proposed \$10,000,000 issue to improve San Francisco's harbor.

legislation by the veto power. The governor believes the state is morally obligated to back the approximately \$1,000,000 paid in under the act by about 20,000 taxpayers, and mentions that it now develops that money received by the state under this act can be paid back only by the act of the legislature. In answer to the reminder that the supreme court did not actually order a refund of the money the governor explained that none of the plaintiffs asked for a refund, or the reason that none of them had paid a tax under the act.

Norblad recalled that the tax commission stated on three occasions that the money would be refunded if the act were held unconstitutional, and that he urged the people to pay promptly, regardless of the suits, so that they might avoid penalty and interest if the act were upheld.

For the reason that "property is already overburdened with taxation," the governor said he was emphatically opposed to making up the loss by property tax. He cited estimates that Oregon people held about \$600,000,000 in intangibles that are not now taxed, though subject to taxation.

Re-enactment of the intangibles act with retroactive clause, the governor is convinced, would not be legal unless enacted during the same year that the invalid act had been passed by the court. "This means," he said, "that the new act must be passed before January 1."

Another reason given for haste was that tax measures cannot that if the intangibles act were carried the emergency clause, and deferred until the regular 1931 session it could not become effective until 90 days after passage.

The fact that Cofer did not respond to invitations until late in the campaign and when he did respond he did not state his position on the city affairs except in a short, general way, has cost Mr. Cofer a good many votes, according to general belief. Butler is in the same shape. He failed to attend meetings of the civic bodies and the ladies' clubs, evidently thinking he could slip into the office without being seen or heard.

That the time has arrived when men have to stand up and speak their pieces if they would run for office, is shown in the case of Mr. Cofer, who had a following only a few days ago, and now apparently much of that following has been changed in many localities to votes for Waggoner, Hamaker and J. Bill, respectively.

With the weather man promising clear skies throughout Klamath county tomorrow, predictions are being made that at least sixty percent of the voters will cast a ballot before close of the polls at eight o'clock tomorrow night.

Instead of six for the pretentious coach, one of the Hungarian animals imported for the occasion in a capricious moment having broken part of the harness, and necessitated eliminating of him and his mate from the trappings.

A thousand of his subjects prostrated themselves before the Emperor as he entered his carriage. As the carriage was driven off, the sovereigns bowing to right and left, many of their subjects crowded behind the vehicle and prostrating themselves kissed the dusty streets which it had just passed.

Arrival at the Royal Palace marked the beginning of the week-long celebrations which the Emperor ordained in honor of the event. The hundreds of thousands of the country's 10,000,000 population gathered there began immediately a barbaric sequence of feasting, dance and prayer.

The coronation ceremonies were estimated to have cost the government about \$5,000,000 and months of preparation.

After the Emperor and Empress emerged from their night of prayer and meditation in St. George's church they entered a specially built pavilion adjoining the church, where they took their places on the red and blue canopied throne.

The Emperor looked tired and the portly Queen, worn out from the hours on her knees, had to be supported as she walked to the throne.

Colonel Telfer, Vet of Spanish War, Passes On

BREMERTON, Wash., Nov. 3. (A. P.)—Colonel George Filmore Telfer, 74, veteran of the Spanish and Philippine wars as a lieutenant and lieutenant colonel of the second Oregon Infantry, died at the Washington Veterans' home today.

He had served as inspector general and in other capacities with the Oregon National Guard, coming to the Veterans' home in 1927. He was a native of New York. Interment will be at Seattle today.

Two daughters, Mrs. Grace Forbus, Medford, Ore., Mrs. Hazel Chalmers and a son, Willie Telfer, Seattle survive.

BATTERY "D" WORKING FOR NEW ARMORY

"All busy on the Klamath County Front" is the by-word at the headquarters of Battery "D" today, where the officers and men of Klamath's own are finishing up their campaign to bring an Armory to Klamath Falls. Both city and county voters are lending their whole-hearted support to the movement and all indications point to an overwhelming majority in favor of the proposition, according to Captain Walter W. Abbey, who has the campaign in charge.

Captain Abbey pointed out that voters have been educated to the fact that a passage of the Armory measure appearing on both the city and county special ballots will not only mean proper quarters for the local national guard unit, which is really a small part of the Army program, but will bring a huge assembly hall to this county for the use of the public and local organizations at any time they desire. Such a building, he said, is vitally needed in this county for the use of veterans' organizations, the Grange and as an inducement in bringing conventions to the city which at present is impossible owing to the lack of suitable quarters. Such uses will return the slight cost of the buildings in a few years and add greatly to Klamath's growth and development.

JAPANESE SHIP CALLS FOR AID

SAN FRANCISCO, Nov. 3. (A. P.)—Word was anxiously awaited in shipping circles here today concerning the fate of the Japanese freighter Selyo Maru, reported helpless and in a sinking condition in the North Pacific early yesterday.

Although the steamer California had the stricken ship's position, and at last reports was battling rough weather in an attempt to reach the scene and rescue the 40 men aboard the disabled freighter, no word had been received here early today.

The California radioed last night she expected to be alongside the Selyo Maru at 11 o'clock p. m., PST.

First distress signals were sent out at 5 a. m. yesterday, when the Japanese vessel was at latitude 50.15 north and longitude 178.25 east, a position southwest of the Aleutians. At that time, her messages indicated she was helpless and listing.

Subsequent messages throughout the day said the list had increased and further damage, including cracking of the life boats, had been done by the heavy gale. The freighter's cargo had shifted, giving her a list of 16 degrees.

Plight of the freighter, bound from Portland, Ore. to Yokohama, was first learned here through radio messages from the Mutual Radio station from the Dollar Steamship President Grant, which picked up the distress calls.

The Selyo Maru had no passengers booked when she left Portland. The ship is a steel vessel, of 5,550 tons, built in 1913 at Glasgow, she is owned by the Mansel Kien Kaisha and operated by the Yamashita Shipping company.

"Weather Man" Predicts Blue Skies Tuesday

WASHINGTON, Nov. 3. (A. P.)—The electorate in two-thirds of the country will have unusually good weather when they cast their ballots in tomorrow's election.

In the other third, the South Atlantic states, occasional rains probably will fall.

The weather bureau here said today from the middle west to the Pacific the skies mostly will be clear and the temperature not unduly low.

In the South Atlantic states, however, possibly as far north as southern New Jersey, cloudy skies and intermittent rains may be expected.

She suffered several cuts on the face and deep bruises. Miss Geddes said she was driving south on the Pacific highway when another car made a left hand turn in front of her.
