

1930 Was a Busy Year for County Sheriff's Office

A Total of 928 Prisoners Held in Custody During Year on Many Charges. Taxes Collected Amount to Over \$800,000

The sheriff's office experienced a busy year in 1930 in the law enforcement division as well as in the tax collection department, as a report for the year reveals. The sum of \$824,664.95 was collected by the tax department from June, 1930, until December 31, 1930. Auto fees collected by the department amounted to a total of \$906.00, for the same period. These sums were turned over to the county treasurer.

During the year there were 525 prisoners held in the county jail on 60 different types of charges. Liquor law violations led the list with 260 charges of possession of liquor. Five murderers were held in the county jail during the year. Four of this number are now serving life terms in the state penitentiary, and the fifth is serving 15 years after pleading guilty to a manslaughter charge and paying \$1,000 fine.

COMMISSION ON STATE'S LOANS MAKES REPORT

SALEM, Jan. 8. (AP)—Since the War Veterans State Aid commission began operating in 1922 loans aggregating \$28,818,125 have been made to 12,073 ex-soldiers, says the biennial report of the commission, made public today. During the last biennium there were 1343 loans aggregating \$2,857,300.

At the end of the biennium September 30, a total of 675 loans amounting to \$1,625,000 had been paid in full with interest. Forty-one loans, \$38,100 were cancelled by the applicants before completion, and the money was refunded and deposited in a special state treasury fund.

A total of 1499 loans originally granted to veterans in the sum of \$3,430,790 have been transferred to persons not entitled to the benefit of the act by sale of property by the veteran. Unpaid balances actually transferred total \$3,151,101.48, which now draws 6 per cent interest.

Receipts of principal and interest on loans amounted to \$3,748,837.25 during the biennium. Since the act became effective 25,884 veterans have received the cash bonus to a total of \$5,068,350. During the biennium 244 bonuses, \$36,930 were paid. Since 1922 recipients of the bonus to the number of 2173 have returned the cash and instead taken loans amounting to \$455,790.

Communists Are Charged By Policeman

NEW YORK, Jan. 8. (AP)—A series of what their communist sponsors called "Hunger Marches" culminated today in disorders near Salvation Army headquarters in Brooklyn in which seven or eight alleged communists were injured and two detectives scratched and kicked.

After searching to Borough Hall, where spokesmen denounced city and national governments and demanded free food, clothing, rent and heat, the paraders moved toward Salvation Army headquarters, which police said they intended to enter.

Forbidden to approach the doors of the building, they hissed and shouted and foot police who had been rushed to the scene to preserve order. A melee soon started in which police charged the crowd dispersing it after a fifteen minute fight in which men and women struck and scratched policemen. The latter used their clubs, injuring several persons.

FISH GAME COMMITTEE WILL REPORT

During the past three months, meetings of the Interim Fish and Game Commission have been held every week, according to Arthur W. Schupp of this city, a member of the commission, in an endeavor to put all approved codes in shape ready for presentation at the coming session of the legislature. The last meeting of the Interim Commission was held on Saturday, January 3.

For years, Mr. Schupp stated in relating the history of the Commission, controversies between commercial fishermen and Oregon sportsmen relative to opening or closing of various streams in the state, have consumed a great deal of time in the legislature. Hearing of complaints of factions, formulating new codes and presenting them for enactment became regular occurrences at state sessions. Consequently the fish and game commission in Oregon has been disputed and unsettled for more than 20 years.

During the last session of the legislature, it was decided to obtain first hand information from both sportsmen and commercial fishermen, and to this end the Interim Fish and Game Commission was appointed to take testimony from both factions, and report findings on the controversial subjects back to the 1931 session of the legislature.

Two members from the House of Representatives, two from the Senate, two representatives of sportsmen's interests, and two representatives from commercial fishermen were appointed to serve on the committee. During the past two years the committee has held three meetings in Portland, one in Astoria, one in Marshfield and one in Gold Beach.

During the period of the Interim Committee's activities, invitations have been extended to various factions to come before the organization and present testimony. Approximately 2,000 pieces of testimony have been taken from sportsmen organizations and commercial fishermen throughout the state. Mr. Schupp said.

As a result of the meetings of the Interim Committee, acting with the game committee and the fish committee, a new code has been formulated and approved, and will soon be presented to the legislature.

It is the belief of the committee, according to Mr. Schupp, that the activities of this group will eliminate the controversies and quibbling that have heretofore taken more than one third of the time of legislative sessions.

"Believing that the conservation of fish and game will mean much to the state, and that these sports will benefit many people, drawing tourists to the state, etc., while commercial fishing is beneficial only to comparatively few fishermen and packers, the Interim committee has formulated the new code with great thought for the future," Mr. Schupp concluded.

Fortune Lost, Former Star Returns To Stage

CHICAGO, Jan. 8. (AP)—The outlying Keddzie theatre on the West Side is far out of the route of the night theatre crowd, but Francis X. Bushman, matinee idol of 15 years ago, had a star on his dressing room door, and he is "doing the work he loves."

The Tribune quoted him today as saying he was "broke, not a penny left of the \$6,000,000 to \$9,000,000 he earned since he became the first star of the old Keddzie studio on Argyle street here in 1914, in the pre-hollywood era of motion pictures."

Following the filming of "Ben Hur" in Rome in 1924, he was blacklisted by the major picture firms, he said. Beverly Bayne divorced him in 1925. Lawyer fees and alimony left something of his fortune, he said, but he lost "every cent" in the stock market crash of 1929. Now he is at work again, in a stock company. He will be 47 years old Saturday.

At the height of his career in 1916 Bushman bought a lavender monogrammed automobile, manned by lackeys to live to match, and smoked nothing but lavender monogrammed cigarettes.

"I've seen everything there is to see and done everything at an age when I could enjoy it most," he said. "I don't need any money now, and I can manage to travel less grandly."

Age-old Catholic Doctrine Stressed In New Encyclical

(Continued from Page One) marital obligation and to traditional church teachings. While not mentioning sexual education, the Pope discounts "exaggerated physiological education". He stresses at length the need for preparation for married life.

Pleas For Mothers The Encyclical asks adequate state laws touching upon the state and family, saying that the religious and civil powers should cooperate therein.

The Pope's advice to the young is "choose a partner well." He advocates state aid for mothers, commenting however, "We are sorry to note that not infrequently nowadays it happens that through a certain inversion of true order of things a ready and bountiful assistance is provided for the unmarried mother and illegitimate offspring, (who, indeed, must be helped in order that greater evil may be avoided) which is denied to legitimate mothers or given sparingly, almost grudgingly."

Scores Amorous Productions "Today, alas," he says, "not secretly but under cover but openly with all sense of shame put aside now by word, again by writing, by theatrical productions of every kind, by romantic fiction, by amorous, frivolous, novels, by cinematographs portraying in vivid scenes in addresses broadcast by radio telephoning, in short by all inventions of modern science the sanctity of marriage is trampled upon and derided."

"Divorce, adultery, all the basest vices either are extolled or at least depicted in such colors as to be or appear to be free of all reproach and infamy."

Dignifies Marriage The Encyclical condemns what it terms "human tampering with a sacred institution," calling companionate and experimental marriages mere travesty. It stresses the high dignity of marriage as affecting questions of conjugal fidelity and the sacramental nature of the marriage contract and the marriage state.

Among the blessings of marriage the child holds first place, the Pontiff said, adding that the parents' duty is not concerned solely with begetting and bringing up with education of the child.

The Pontiff also touches upon emancipation of modern woman. The wife should be subject to the husband, he says, but adds that this "does not deny or take away the liberty which fully belongs to the woman both in view of her dignity as a human person and in view of her most noble office as wife, mother and companion; nor does it bid her obey her husband every request when for example such a request is not in harmony with the right or reason or with the respect due to a wife."

Submission of the wife to a husband, says the Pontiff, does not, however, "forbid that exaggerated license which cares not for the good of the family." It requires "honorable, noble obedience."

The Pope stresses "the inviolable stability" of the marriage bond in explaining the Catholic doctrine of the sacramental character of marriage. Man and wife, he says, are "not fettered, but adorned by this noble bond."

SOLUTION OF SLAYING IS YET UNSOLVED

PORTLAND, Ore., Jan. 8. (AP)—The mystery of the death of Lloyd B. Stryker whose body was found in the Willamette river here Sept. 26, was no nearer solution today after police had questioned Ed Sherer, 30, who was arrested in Vancouver, Wash., two days ago with Stryker's automobile.

Police said they were convinced Sherer, an escaped prisoner from Florida penitentiary, knew nothing of Stryker's death. Sherer had been charged with assault and robbery while armed. George Johnson identified him yesterday, police said, as the man who robbed him of more than \$200 in a holdup.

Detectives announced Sherer had admitted firing two shots at Dr. C. P. Lynn Monday night. Sherer said he was intoxicated, tried to turn his car around in the middle of a block, and the front wheels became stuck in Dr. Lynn's freshly planted lawn. Dr. Lynn ran out to protest and Sherer fired two shots which struck the porch of the house.

Heroic Ice Pilot Dies At Brooklyn

NEW YORK, Jan. 8. (AP)—Acton P. Jochimsen, rescuer of the Karlik survivors in the Arctic in 1914, died today in the Naval hospital at Brooklyn.

He was a native of Denmark. As captain of the King and Wings, a fur-bearing ship of the Graf Swenson company of Seattle, he came to be known as the most skillful ice pilot in the Arctic. During the war he was a lieutenant commander in the United States merchant marine.

The rescue of the Karlik survivors, which tested his ice-piloting skill to the limit, brought him world renown.
