

MANY VIOLENT DEATHS OCCUR OVER EASTER

(By the Associated Press.)
Nineteen persons, all victims of forms of violent death, comprised the Pacific coast's weekly-end, an Associated Press tabulation indicated today, with automobile traffic accidents claiming the majority.

Eight persons were killed in automobile wrecks, one of them in Seattle, Wash., constituting this city's fifty-third traffic fatality this year. The remainder of the list was divided into five, one; drownings, three; murder, two; suicides, four; asphyxiation, one, and dynamite blast, one. The list of injured amounted to nearly one hundred.

In San Francisco Carl Gohin, 35, janitor service head, shot and killed his former fiancée, Mrs. Selma Brown, 43, and then turned the weapon upon himself. He died in a hospital a few hours later. Police said jealousy prompted the murder and suicide.

Near Couer d'Alene, Idaho, authorities sought the murderer of A. J. Brannard, 44, service station owner, shot down by an unidentified assassin.

Three children, Minnie, William and Howard Nutt, eleven, nine and six years old respectively, were drowned before the eyes of a fourth child in a shallow pond near Marysville, Cal. They slipped from a rock shelf. The bodies were recovered.

Mary Jacobs, 4, was burned to death in her Easter dress. She played with matches and neighbors saw her rush from her home, her father, John Jacobs, in flames. She lived in Stockton, Cal.

Among the automobile deaths were Mr. and Mrs. H. M. Goss, El Centro, Cal., who died in an accident near Banning, Cal., involving three motorists. The driver of one of the automobiles, held to have been the blame of the crash, fled.

One man was killed in a Tacoma, Wash., auto upset, a train and an automobile collided near Los Angeles and one hitch hiker, D. K. Timmer, York, Pa., was killed near Holtville, Cal., when the automobile in which he was riding skidded in desert sand and overturned.

Harold Harris, 26, real estate dealer, was found, asphyxiated in a tightly closed San Francisco hotel room. A gas valve was full blast and authorities said it was accidental death. A woman companion of Harris was taken to a hospital in a serious condition.

The dynamite blast victim was Sam Inkster, Edmonds, Canada. Besides the suicide of Gohin, James P. Robertson, prominent Seattle resident, ended his life by inhaling carbon monoxide gas in a garage. Another man committed suicide in Snoqualmie, Wash., and a lawyer, John J. Kinnane, shot himself to death in Seattle.
