Klamath Gets a Rebuke

WHAT Marshall Dana had in mind when he rebuked Klamath Falls for its "back yard fusses" caused plenty of head-scratching after Wednesday's forum meeting.

Chances are Mr. Dana referred to nothing specific. It is true, as was pointed out in this column a fortnight ago, that this community has a reputation among men connected with federal agencies like CWA, as a center of factionalism and small politics. It appears likely this was what prompted Mr. Dana's remarks, which, it should be said, were accepted in good humor by his audience.

Now Mr. Dana is in an authoritative capacity over this area only as a public works official, and he was talking on public works when he spoke of local dissension. Yet it is noteworthy that so far as public works go, the entire community and countryside have been in unusual harmony.

There has been no dissension, no argumentation, no pushing and pulling on the various public works proposed here. It is true that none of them thus far has won much favor with the public works administration, but neither Mr. Dana nor anyone else can blame that justifiably on local dissension, because there has been none in this connection. In fact, if a little more success were met by this effort, it might encourage similar harmony on other projects, which is something we offer Mr. Dana as a good idea.

But Mr. Dana's remarks do emphasize a fact that should be faced—that Klamath has an outside reputation for contention and factionalism. It seems to hark back through the years to certain ancient squabbles, and some of the recent happenings in local politics haven't helped correct the impression.

So it is well to accept the regional advisor's warning at face value, without regard to its application to the specific subject on which he was here to speak. Subordination of factionalism and selfish interest to the general good and presentation of a united front whenever we go to outside agencies for consideration, deserve an important place in community policy and will go far in correcting unfavorable outside impressions. That can be done without denying anyone the right to honest disagreement on any issue.

Taking Their Time

THE courts have a way of taking their time about doing anything, and there is little hope for an immediate decision on the constitutionality of the Knox liquor control bill.

Since Klamath Falls raised the question, there have been hopeful predictions from various sources of a court decision "by the end of the coming week." Another week-end is at hand, and the matter hasn't yet gotten through the lower tribunal. A call for written briefs has been made, which makes a decision even more remote.

Once it is decided by the circuit court, the matter will be taken into the supreme court, where more waiting can be expected.

It is realized that weighty legal matters call for cautious, careful deliberation. Even so, the tendency of the courts toward delays, postponements, and seeming unconcern toward the occasional need for speed, try the patience of the layman.

More rapid action on applications for home loans in this territory appears in the offing. Changes in the Portland headquarters office, and a general policy of speeding up on worthy loans, are factors in the favorable prospects for applicants.

New Violence Hits Austria With Campaign

VIENNA, Austria, Jan. 11. (AP)—Violence sweeping Austria during the government's harsh anti-Nazi campaign broke out afresh today. One person was killed and scores wounded.

The death was reported from Klagenfurt where newly armed guards and emergency police fired into a mob of discharged Nazi printers. Little hope was held for two who were wounded.

Police had ordered the printers to disperse. The mob grew unruly instead, and the guards were called out to aid the regular policemen in the ensuing battle. Several were slightly injured on both sides.

In Vienna, eight bombs exploded at various locations during a hectic day. One policeman was injured in a subway station, where a bomb exploded, endangering the lives of crowds at the rush hour. Traffic on the line was suspended for half an hour.

Letters Used In Divorce Complaint

CHICAGO, Jan. 11. (AP)—The passionate love letters of a woman former collector of internal revenue were admitted as evidence in an alienation of af-

fections suit against her today. Mrs. Myrtle Tanner Blackledge identified the letters as the ones she allegedly wrote Norman E. Nottingham, a patrol wagon driver, and which are the basis of a \$100,000 suit filed by Mrs. E. Nottingham, who has the quaint habit of saving her husband's mail.

Monroe Reformatory Again Under Fire

OLYMPIA, Wash., Jan. 11. (AP)—The Monroe reformatory, which drew the fire of the famed Wickliffe crime report in 1930, was again under siege today with drastic changes being recommended by a house investigating committee.

The Wickliffe report called the Monroe reformatory one of the worst in the country. The house committee of seven, headed by Rep. James Cavanaugh of Spokane, substantiated charges of three years ago following a personal investigation of the institution and called it a "breeding place of crime rather than a reformatory."

The Inside Story From The Capital

WASHINGTON, Jan. 11.—This new milk policy has a clever hidden curve in it, aimed at certain farm cooperative outfits.

The Wallace-Tugwell crowd has been going through the books of some of these associations and discovered a lot of lost cream.

One such co-op in the east has accumulated a surplus of \$800,000. Imagine a farmer cooperative association accumulating that much profit in those times, with the farmer complaining about low prices and the consumer howling about the high cost to him.

Another co-op in the mid-west cached a creamy \$150,000 in surplus. It decided to go into the cheese business and built a factory. That may seem to be a good place to put such money, but the new dealers are trying to figure out whether it is a proper function for a co-op to try to run a cheese factory. They suspect the best place to have put the money right now is in the farmer's pocket.

Considerable farm purchasing power could be created if these surpluses were distributed or at least if the co-ops were stopped from piling up more.

Incidentally, the general manager of that mid-west co-op gets a salary of \$18,000 a year.

OVERALLS

Agriculture Secretary Wallace has said nothing openly on the matter, but he will, if the co-ops do not play ball with him.

Obviously he had the surplus and salary situation in mind, when he decided a few days ago to rewrite all the milk codes. His decision came a few days after he had referred to certain co-ops as nothing more than "distributors in overalls."

He directed that hereafter a fair price be guaranteed to the farmer, but said there will be no further fixing of prices to the consumer. He is experimenting with the idea that competition will keep consumer prices down.

If it does not, a maximum consumer price will be fixed. That is only the beginning of the new policy. There are indications that the whole system will undergo a thorough re-naturing before Wallace gets through.

HOUSE CLEANING

The government has started a little renovating of its own in the home owners loan corporation.

Officials down there deny it, but there are good reasons for believing that a corps of inspectors are out checking over the books in branch offices.

One branch manager has already been dropped for making unauthorized loans. Another is being called on the carpet. It seems he loaned money to a loan association, which in turn used the money to pay off its notes to a bank of which the treasurer of the branch office was president.

It may have been all right but the topmost quarters here want to know more about it.

INSPIRATION

The way Chief Justice Charles Evans Hughes came to the rescue of the new deal in the Minnesota mortgage case is the most inspiring thing which has happened in Washington in a long time.

Liberals bitterly contested the appointment of Hughes in the senate. They marked him as a man who defended property rights to the detriment of human rights. They called him a corporation lawyer and demanded the appointment of men like Brandeis, Roberts, Cardozo and Stone. That was three years ago this coming February.

Now Justice Hughes has cast the deciding vote for the liberals, allied with the four men named. He led them, writing new law for human rights and
